


So then I heard about the you could go into the signal core.

Calling down artillery shells, you. 00:03:34 Speaker 1 Know no, I don't know what that means. 00:03:36 Speaker 3 Well, we would see where the artillery shells were spotting. 00:03:39 Speaker 2 Tell him how far I've come. 00:03:40 Speaker 3 Anyway, dumb hop right off with 300 yards short, 300 yards long. 00:03:44 Speaker 1 But is this in training or this was really out there? 00:03:45 Speaker 3 No, an actual Congress. 00:03:47 Speaker 1 So you're you're. 00:03:47 00:03:48 Speaker 3 Learned. 00:03:48 Speaker 3 I learned to do that. 00:03:50 Speaker 1 So you saw a German target and you see where the bomb lands and you say move 20° to the right. 00:03:56 Speaker 3 That was one of the jobs I did. 00:03:58 Speaker 3 I was also an infantry scout. 00:04:00 Speaker 1 Which is what?

00:04:01 Speaker 3

Scott was a guy who went in front of everybody else and looked at checked out to see where the enemy was and said come, I would follow me.

Oh my God, that's bad.

00:04:11 Speaker 3

I was pretty far much in the front, but the time I got wounded was I was in infantry. I was an observer.

Yeah.

What?

The artillery.

00:04:22 Speaker 2

Oh.

00:04:24 Speaker 3

And we're in France near Panama.

00:04:27 Speaker 3

We climbed up this hill and the artillery was firing down upon us and we were trying to get our killer to stop the enemy.

Wait, you were being fired upon by your own?

00:04:39 Speaker 3

We got we were being shelled.

00:04:41 Speaker 1

By your own artillery.

00:04:43 Speaker 3

By the Germans and we were in a in a dugout trying, you know, in a foxhole, trying to shell the Germans.

00:04:44 Speaker 1 OK. 00:04:51 Speaker 1 Yeah. 00:04:52 Speaker 3 And the Lieutenant got killed. 00:04:56 Speaker 3 And my radio. 00:04:57 Speaker 3 The my radio got partially split the day before and a sniper had hit the antenna on my radio, so I was holding the antenna together with my fingers. 00:05:09 Speaker 1 Yeah. 00:05:10 Speaker 3 And and calling off the artillery observations at the same time. And a grenade came over the top of the hill and hit me in the face. 00:05:19 Speaker 1 A fragment. 00:05:20 Speaker 3 No, the grenade flank came up and I saw the grenade. 00:05:23 Speaker 3 I turned my head and exploded and I got hit in the face and the thigh and in the foot. 00:05:24 Speaker 1 Yeah. 00:05:30 Speaker 1 And where's that scar on your face? 00:05:32 Speaker 3 The scars, the small little scar right over here. The one over here is.

Yep. 00:05:37 Speaker 1 Oh no, I'm not even going to film that one. Because you lie about that one. 00:05:41 Speaker 1 No, I'm not even looking at. OK, that ones are. 00:05:44 Speaker 1 Let's see, that's gargant. 00:05:45 Speaker 3 This is not from the OSS. 00:05:47 Speaker 1 UAN. 00:05:48 Speaker 1 Face it. Yep. 00:05:49 Speaker 3 You can't. 00:05:49 Speaker 1 Oh, I see. 00:05:50 Speaker 1 I remember seeing it all growing up. 00:05:53 Speaker 3 Down the bottom of your ship. 00:05:54 Speaker 1 Yep. And So what happened then? You had a bloody face. 00:05:57 Speaker 3 Yeah, and I. 00:05:58 Speaker 3 Α. 00:05:58 Speaker 3 There was a old dugout from World War from 19.

French dugouts were on this hill and I ran into this dugout and there were several other guys who were in there that were wounded.

Hand grenade.

00:06:12 Speaker 3

Combat there, that was there, you know, firing everything and about 1/2 hour, maybe 20 minutes later. Half hour later, the Germans were on top of the hill and they took prisoners.

Yeah.

00:06:22 Speaker 1

So you saw them coming over.

00:06:24 Speaker 3

Yeah, we. Well, we just, we just stayed in there and we had a first date man there and we were all screaming.

What does that mean? Don't you?

Don't shoot, Alice. Camera friends, we surrender.

Right.

Alex wounded.

Will you guys waive in a white flag at?

Or anything.

00:06:44 Speaker 1

And did any of these Germans have, like, s s things on them or anything? This was regular German army guys. 00:06:47 Speaker 3 No, not at that time. 00:06:51 Speaker 3 They were dressed up in the uniform of the Air Force, German LUFTBUFFER soldiers. 00:06:54 Speaker 1 Uh. 00:06:57 Speaker 1 Huh. 00:06:58 Speaker 3 And they were both young men and old men. 00:07:00 Speaker 1 Were they mean to you or they were not? 00:07:03 Speaker 2 Really part of the Home Guard or something. Oh, you're. 00:07:05 Speaker 3 We don't know. 00:07:06 Speaker 3 We we don't. 00:07:07 Speaker 3 We don't what they were, but they were, you know, at that time they were using everybody they could possibly use, you know, is infantry and. 00:07:14 Speaker 1 Let me pause for one second. 00:07:16 Speaker 1

On a second.

It's very.

I'm getting a real nice picture.

Hello.

OK.

So you just these guys just came over the hill?

You're in this hill and there was a red crushed man there and he was whatever he could give. He was giving to us and he gave me a couple of shots of morphine.

Would do you remember being in a lot of pain?

00:07:36 Speaker 3

Yeah, I remember being in pain, but the pain 1.

00:07:39 Speaker 3

And I started talking when I was under the morphine and we had a code as far as these hills were concerned, you know, New York Hill, New Jersey, so forth and so on.

Yeah.

00:07:51 Speaker 3

Things and I started giving out this code.

00:07:54 Speaker 1

Whoa.

00:07:55 Speaker 3

And this is what I was asleep.

So when the Germans woke me up, one of the guys grabbed me and woke me up and slapped my face a couple times.

Asked me what that meant and he asked me if I was the radio operator and I said yes. You know, before I even knew it. 00:08:11 Speaker 3 He. 00:08:11 Speaker 3 What does this mean? 00:08:12 Speaker 3 Says it doesn't. 00:08:13 Speaker 3 Anything. And he says he looked at my dog tags and says, ah, do Mr. Newton. 00:08:19 Speaker 3 He saw the H on my dog, his business H to Mr. Newton. 00:08:23 Speaker 3 I says no, he didn't. 00:08:24 Speaker 3 *** ** * **** 00:08:26 Speaker 3 And he slapped my face and I kicked him in the balls. 00:08:30 Speaker 3 I. 00:08:30 Speaker 3 Greg and I, are you sitting at your right hand next to me? 00:08:33 Speaker 3 So I'd slap my face.

00:08:35 Speaker 1

00:08:37 Speaker 1

The same thing with the hand.

This is the.

This is the same instant I thought, OK.

The same instance, same day. And so when you slapped my face, I kicked him in the groin and he sat on my chest and he took a knife and put the knife to my throat.

Was about to cut my throat and the German officer came in and stopped him.

Just at that point and.

They kicked me around, hit me a couple of times.

Didn't tell them anything and they left me alone.

00:09:04 Speaker 3

And we were in that same.

00:09:07 Speaker 3

Dugout all day.

00:09:09 Speaker 3

And through the whole day that our troops were shelling the the dugout, you know, fairly well protected.

00:09:13 Speaker 2

Were the Germans with you all?

00:09:15 Speaker 2

Time or they look.

00:09:15 Speaker 3

No, the German word.

00:09:17 Speaker 3

Were.

00:09:17 Speaker 3

They were outside the.

00:09:18 Speaker 3

They didn't stay inside with us.

00:09:20 Speaker 2

Oh, but they.

00:09:21 Speaker 2

Just left you there. Do they kill anybody up?

00:09:22 Speaker 3

They left us there and they had a they had a card.

00:09:25 Speaker 2

Do they kill anybody in the?

00:09:27 Speaker 3

No, no. They took a couple of guys that were not wounded. They took out of the dugout, but the wounded and the wreck and the first aid man, they left there.

So they were sort of almost like doing Geneva Conventions, sort of like.

Five of us.

00:09:39 Speaker 1

Like you were wounded so.

00:09:40 Speaker 3

They yeah, they left us alone.

00:09:43 Speaker 3

And towards night, about eight 10:00 at night.

00:09:47 Speaker 3

Don't know if it's dark or anything.

00:09:51 Speaker 3

The Germans had.

00:09:52 Speaker 3

The diving was the shelling was very strong.

00:09:56 Speaker 3

Two Germans came into the dugout, an old man and a young man.

00:10:01 Speaker 3

And the young man put his rifle to my chest.

00:10:07 Speaker 1

This is still the same day, Dan, right?

00:10:08 Speaker 3

Same day and they were asking us if we had any weapons and I had a 45 caliber pistol automatic underneath me.

He didn't know it's been laying on all this time. There was no way I could reach it because these Germans were right outside.

Nothing I could do about it.

00:10:28 Speaker 1

Just a second.

00:10:29 Speaker 3

And he had this, and he started to he kept asking us if we had weapons.

I'm sorry.

00:10:51 Speaker 3

Started to cook like this on the trigger.

00:10:54 Speaker 3

And I started to pass out.

00:10:58 Speaker 3

And I crapped in my pants.

00:10:59 Speaker 3

I defecated in my pants. I was so scared. 00:11:02 Speaker 1 Was there anybody else in there with you? 00:11:04 Speaker 1 The time. 00:11:04 Speaker 3 Yeah. The other guys were in there with us. 00:11:05 Speaker 1 Did they have the the gun to anybody? 00:11:08 Speaker 1 Chest or just your. 00:11:09 Speaker 3 The other German had somebody else to had. It had his gun on the other guys. They have it to the. 00:11:14 Speaker 3 Just covering the other two guys. 00:11:16 Speaker 1 So they weren't yelling at the other guys. They're just yelling at you. 00:11:18 Speaker 3 No, this was just yelling at me about we had new weapons. 00:11:21 Speaker 1 Alright. 00:11:21 Speaker 3 We only had both of us at all of us. You know, we had new weapons, you know, and he started doing this.

Yeah.

00:11:26 Speaker 3

I went.

00:11:27 Speaker 3

Back there, you know, all of a sudden the gun was taken off my chest.

00:11:29 Speaker 1

Mm hmm.

00:11:32 Speaker 3

And he took their two guns and they threw him out of the dugout.

00:11:36 Speaker 3

And they held up their hands and they said Tamura. They surrendered.

00:11:41 Speaker 3

They surrendered to us.

00:11:42 Speaker 3

They had orders to kill us.

00:11:45 Speaker 3

But they had decided to get out to surrender, and they didn't want them us to shoot them.

00:11:51 Speaker 3

You know, if they surrendered to us.

00:11:54 Speaker 1

But but I thought the other Germans were all around your.

00:11:54

It's.

00:11:57 Speaker 3

All the other Germans that they were all they were all.

00:12:00 Speaker 3

These two guys were among the last couple of men on this top of the hill there.

00:12:05 Speaker 3

The Germans you know? And but it was being shelled and their orders were to kill.

00:12:08 Speaker 1

They were retreating.

00:12:10 Speaker 3

Orders were to kill the prisoners and to.

00:12:11 Speaker 1

And get the hell out.

00:12:12 Speaker 3

Out.

00:12:13 Speaker 3

And so they decided they had decided to.

00:12:15 Speaker 3

This is the only way they could surrender to us to make sure that we wouldn't shoot down.

00:12:21 Speaker 3

In about 10-15 minutes later, our troops were on the top of the hill again and one of the majors. There was no captain, Captain Smith.

00:12:31 Speaker 3

Stuck his head in the air and he says, are you alright in there?

00:12:33 Speaker 3

Said yes, Sir. We've got 2 German prisoners, he says.

00:12:36 Speaker 3

Them.

00:12:37 Speaker 3

I'll take care of them. And I said no Sir, they surrendered to us.

00:12:41 Speaker 3

Had orders to shoot us and they surrendered to us.

00:12:44 Speaker 3

We will not send them out.

00:12:46

Mm.

00:12:46 Speaker 3

And they said, OK, we'll get somebody to take him back later on.

00:12:50 Speaker 3

And so we kept them with those two guys with us all night long.

00:12:53 Speaker 1

So he would they would have killed them.

00:12:55 Speaker 3

And the next morning, they were taken back to the prisoners.

00:12:58 Speaker 3

Were taken this prisoners of war.

00:13:00 Speaker 1

And did you ever get their names or?

00:13:01

They.

00:13:02 Speaker 3

Never got their name, so know who they are? Nothing about them.

00:13:05 Speaker 3

And that morning they took me off the hill and I was able to walk a little bit.

00:13:11 Speaker 3

Was.

00:13:11 Speaker 3

I was in between two guys, you know, walking downhill and this hill again was being shelled and bombed, and the hill was taken again by the Germans and it was taken 3 times.

Mm.

00:13:22 Speaker 3

Three times they got the top of the hill in three times we lost.

00:13:27 Speaker 3

Question.

00:13:28 Speaker 3

Get them going back and forth like that.

00:13:30 Speaker 2

The men killed each time.

00:13:33 Speaker 3

Were men killed each time?

00:13:37 Speaker 3

You know, it was one of those very it was a very, very tough place to be. And so I I don't know what happened to the rest of the people after that.

What about the guys that were in?

00:13:48 Speaker 1

Foxhole with.

00:13:49 Speaker 1

Do you remember their names?

00:13:50

A couple of guys.

00:13:50 Speaker 3

The guys were no, I don't.

00:13:52 Speaker 3

Their names don't have their names or anything.

00:13:54 Speaker 3

Only one I know is Wick.

00:13:58 Speaker 3

And one was the first egg man's name was Frost.

00:14:02 Speaker 3

The other guys name was Wick and Wick I ran into in a in the hospital afterwards and he was like anti Semite.

00:14:13 Speaker 3

He hated Jews and he started making some kind of remark and I took him.

00:14:18 Speaker 3

And I said, you make one armor remark and I'm going to put you on the stove.

00:14:23 Speaker 3

Was a hot stove in the in the barracks, in the Kentucky, he says.

00:14:26 Speaker 1

The hospital.

00:14:28 Speaker 3

Couldn't do in a month or Sundays and I picked him up.

00:14:31 Speaker 3

I put him on the stove.

00:14:32 Speaker 1

This was the guy that was in the foxhole with you that almost got killed with you, and he's still being anti-Semitic to you.

00:14:42 Speaker 1

That's right. You burned the cedar on the heater.

00:14:46 Speaker 3

They separated us and nobody ever said anything about it.

00:14:50 Speaker 1

Yeah. Was he above you in rank at all?

00:14:56 Speaker 1

Was there a lot of anti-Semitism in the troops?

00:14:59 Speaker 1

Did you get?

00:15:00 Speaker 1

Uh.

00:15:02 Speaker 3

And.

00:15:04 Speaker 3

The other 10.

00:15:04 Speaker 2

I think when they were overseas studied, they didn't.

00:15:07 Speaker 3

Have time to be anti-Semitic and the other time it was really a bad time that we had was just before I went off before I had my trench foot.

Mm.

00:15:17 Speaker 3

A few days before.

00:15:20 Speaker 3

We were advancing and we came to 1 area that was.

00:15:25 Speaker 2

What word?

00:15:26 Speaker 3

In France, again, this was we've already crossed the Moselle river and we're in northern France and we.

00:15:34 Speaker 3

We came to 1 area where there was a large large field, farmland and everything you know ditches wide ditches in there, you know, looking for drainage ditches. And we got into this drainage ditch and there was a farmhouse.

Mm.

00:15:50 Speaker 3

Maybe 500 yards away or so and the Germans started coming out with this white flag.

00:15:56 Speaker 3

And somebody started shooting at them and they ran back into the farmhouse.

00:16:02 Speaker 3

Immediately after they run back into the farmhouse, mortar shells started dropping in the farm down the ditch.

00:16:10 Speaker 3

The same pitch that we were laying in mortar shells were dropping blood. No, the Germans.

00:16:14 Speaker 1

Your own.

00:16:15 Speaker 1

Your own guys.

00:16:18 Speaker 3

They have had they've had the.

00:16:22 Speaker 3

The mortar had already been zeroed in on this ditch you.

00:16:26 Speaker 1

Yeah.

00:16:27 Speaker 3

So if any troops were in there, they could shoot it. You know, they could kill. And these shells were dropping one after the other. Every 2030 feet, they were coming down and we had just dug in.

Yeah.

00:16:39 Speaker 3

Like my foxhole buddy, Calvin Brighton, I had just dug it in slightly into the side of the hill.

Of the things troops, Evelyn did the minute they stopped advancing, he started digging a hole.

Yeah.

00:16:52 Speaker 3

You know, to get under, get undercover, get below the the.

00:16:54 Speaker 1

Yeah.

00:16:58 Speaker 1

Fire line.

00:16:58 Speaker 3

Round line below the ground level and we started digging the first minute we got in there, you know, before anybody even said to, we're going to continue going.

00:17:08 Speaker 3

So we had digging into, we had dug into the side of the ditch and the mortar shells were dropping.

00:17:15 Speaker 3

And I could hear them dropping and I'm sitting laying on top of.

00:17:19 Speaker 3

And he's against the against the dirt, and I'm practically smothering.

00:17:23 Speaker 3

It you know, we're figuring we're gonna be gone. We're praying like crazy.

Right.

00:17:27 Speaker 3

And I hear a shell drop about 20.

00:17:29 Speaker 3

Feet away. Warm and I hear another show.

00:17:34 Speaker 1

Does it make an explosion after you hear?

00:17:36 Speaker 3

The next one, the next one.

00:17:38 Speaker 3

Boom, boom and then there is more.

00:17:41 Speaker 3

Will be further down about 20 minutes later, a tank came and destroyed this farmhouse, and the shelling stopped, and when we got out of this foxhole, this did this hole that we had.

At the top of the, you know like at the top of the ditch there was a mortar shell.

00:18:01 Speaker 3

And it was a Dutch.

00:18:01 Speaker 1

Duh, duh, duh.

00:18:02 Speaker 3

And was stuck in the.

00:18:03 Speaker 3

It was about that much of a God of the.

00:18:06 Speaker 3

It was a big 120mm mortar and it would, if it had hit me it would have hit me right in the right in the small of the back.

That's where it was.

00:18:16 Speaker 3

So we sat.

00:18:17 Speaker 3

We didn't know what to do with this thing, and nobody wanted to touch it.

00:18:20 Speaker 1

Right.

00:18:20 Speaker 3

You know, and we didn't want to do it. So they said somebody brought an ammunition box.

00:18:26 Speaker 3

And they put an ammunition box on top of it and they said you 2 guys keep anybody from kicking the ammunition box.

And so so we were awake all night long.

00:18:37 Speaker 2

You're garrity.

00:18:38 Speaker 3

Garden this ammunition box guarding this shell. This shell that was laying there could have gone off at any time, but we couldn't leave it.

We couldn't.

00:18:48 Speaker 3

And we couldn't.

00:18:49 Speaker 3

And we had to stay with this damn thing.

00:18:50 Speaker 1

Why did they do that?

00:18:52 Speaker 3

Well, if you would touch it, you know it's life.

00:18:55 Speaker 3

Fusions level the.

00:18:56 Speaker 1

Yet why did they put an ammunition box?

00:18:58 Speaker 1

Top of it.

00:18:58 Speaker 3

Because to protect it, you know, so anybody who would be walking would see that there's something there.

I got it.

So they they left this thing on top of there and they said you guys watch it.

Uh, guns were still.

The first one they were. 00:22:27 Speaker 1 Right, the grunts, grunts. 00:22:28 Speaker 3 They had no unit cohesion with the Russian. 00:22:32 Speaker 1 And it was their first experience.

So this was your so all this stuff with the German guy in the hand grenade and all the stuff came after you landed D-Day +3.



Oh my God. 00:29:36 Speaker 1 And then were you still in that? 00:29:39 Speaker 1 With that dead guy. 00:29:40 Speaker 3 For a little while. 00:29:42 Speaker 1 Yeah. 00:29:42 Speaker 3 But as soon as the show went. 00:29:44 Speaker 3 I got out of there and I was moving. 00:29:45 Speaker 1 Uh, huh. And then when I came off the line, I had trench foot. Trench foot is a. 00:31:57 Speaker 1 And what is that? 00:32:00 Speaker 3 Is a lack of circulation in the feet because your feet are constantly wet. 00:32:05 Speaker 3 You don't change your socks. 00:32:06 Speaker 3 Don't have circulation. 00:32:08 Speaker 3 You lose the circulation. You get the trench foot and your feet become like cloves. 00:32:14 Speaker 3 You feel like you're walking on wooden stumps. 00:32:17 Huh. 00:32:17 Speaker 3 You have no feeling in the feet. Nothing. There's no way that this can't walk. 00:32:19 Mm. 00:32:22 Speaker 3 And I got this trench. 00:32:24 Speaker 1 Is that? 00:32:24 Speaker 1 Did a lot of guys get that? 00:32:27 Speaker 3 I got this and. 00:32:30 Speaker 3

And I requested.

00:32:32 Speaker 3

I asked my unit in my Lieutenant I.

00:32:35 Speaker 3

I got to get some change of socks and shoes, he said.

00:32:38 Speaker 3

You and Kel and I both had this, he says.

00:32:42 Speaker 3

Back to the aid station. Get some socks.

00:32:45 Speaker 3

I didn't have any socks and I didn't have any other shoes.

00:32:49 Speaker 3

Because when I had been wounded.

In in September, they cut off my shoe.

When I when they found the piece of shell I have piece of shell shell fragment sticking out of my shoe and when they when they saw this sticking out of my foot when they saw this.

Cut the shoe off.

00:33:07 Speaker 3

And now I had 12 triple E feet and they didn't have any.

For me.

00:33:12 Speaker 3

So they tried to sew the shoe back up together as best they could.

And I use those same shoes that I was in combatant in September, in July, August, September, October, November, I was wearing the same pair of shoes.

When I got the trench foot and he started coming off the line, we were walking back and we suddenly started getting sheltered by the Germans. And there was Sherman tanks that were coming.

Alongside of us and all of a sudden the Sherman tank started turning and they started coming towards me and I'm trying to walk in the mud and the mud was up to my.

My calf figure and I couldn't get my feet out of the mud.

Did they see you the tanks?

00:34:18 Speaker 3

The Sherman tank did not see me.

00:34:20 Speaker 1

But you thought they did it first.

Well, we didn't know.

00:34:23 Speaker 1

Uh.

00:34:24 Speaker 3

And and they were coming towards me. And I'm waving my hands and everything. And I thought he was going to run over me.

And Calvin jumped up on the tank, and he's banging on the tank and everything, and the guy opened it up and he says there's a man out there and that that's when one of the tankers came out and then he and Calvin pulled me out of the mud.

The Sherman tanks are our tanks, the US.

Why did he go get to the United States?

Preparatory to operating on my feet, they were going.

00:35:30 Speaker 3

They had making a decision. I had small spots of black and all on egg toes that was gangrene.

And they had decided either to cut off my toes.

00:35:45 Speaker 3

They had me on an operating.

00:35:47 Speaker 3

They had me preparatory for being operated on.

Several doctors came along in this hospital.

In the field hospital, they said, OK, we're going to cut off the toes and then one of them said, well, why don't we try the penicillin if we give him massive dosage of penicillin, it may stop. The gangrene may even help the help his feet.

And if it doesn't stop it, we can cut off his toes, feet at the angles.

They're saying this in front of you.

Through the month of February. 00:37:07 Speaker 1 Yeah. 00:37:10 Speaker 3 I was getting penicillin. 00:37:12 Speaker 3 Every four hours.

So you were in the hospital from then until February that whole time, yeah.
