Why don't you start off by telling us a little bit about yourself and what you were doing before the war and how you how you progressed into the army?

Of course.

00:00:34 Speaker 1

Grew up, was born in Ithaca and grew up.

00:00:36 Speaker 1

My father was in the school system.

00:00:38 Speaker 1

He was director, director of physical education, recreation here in Ithaca.

And I was fortunate. Had good parents and everything, and was active in the Boy Scouts and.

Used to.

Airplanes in the area prior when they had us, some of US scouts and others.

They wanted to do something collective metal, you know.

Things and.

We, but then in the other there they the CCCS moved in and did a lot of the work around the area. Very few people know about the CC CS and of course I think it's a little unique with the area we have here with all the park trail.

The lakes.

And the stonework, which was done by these folks, woodwork, some of those benches they built 60 years ago, are still in use.

And so, you know they the CC Cs.

Participated in the community and everything.

And I also when I was still in high school and my mother didn't like it, I she made me cut down in my hours of school, and I was going to Cascadilla prep school in the morning at 8:00, and I take three classes in the morning and then.

The afternoon I go to the Lehigh Valley and I was a traveling baggage and mail clerk.

And my job was to work at the stations only so as to not to delay the passenger train.

Well, this doesn't seem like anything important, but every 3 or 4 minutes a freight train loaded with raw material came through. And of course it was important they had priority.

And so our job like in Geneva, they had 45,000.

Navy guys up there and there was an awful lot more mail went in than came out, so they had what they called bombs and these were large male sacks and they crammed them full of empty mails.

About 90 lbs each.

And I had five minutes and the train stopped there, and I had two or three of these platform cars with 2025 sacks on it, and I got to the point. I just pick those things up and just heaved them right in, you know, and I got.

I was in good shape and I was determined that I was going to come home.

And it was going to be not because I wasn't in shape now then I was.

Was finally drafted. I had.

Have gotten.

Deferment from the military on that, but everybody in my high school class went in.

You know, that's something.

Did you go?

00:03:07 Speaker 2

Did y'all go in together?

No, I was.

00:03:09 Speaker 1

A little later because of.

Because Mother says you are not going to, you're not going to take a full load and work nights.

Nights I was working until two or three in the morning and I had an 8:00.

I had many.

00:03:22 Speaker 1

It's snowing in the Lehigh Valley station. Was downtown.

And it was a three mile hike from their home and I had to hike there.

Buses. No taxis, nothing.

I was in good shape.

When I went in the service.

And I trained and.

Wheeler, Georgia in Macon, GA.

And I guess I had a good test score or something 'cause they put me in combat intelligence at six weeks, infantry training and six and 12 weeks of combat intelligence training.

You know map reading, doing overlays, patrolling radio communications and so forth like that.

So after that was over, I had a chance to come home for a week.

Then back and then next thing you know, I was alerted for shipping overseas.

But we went over in a converted liberty ship that had been torpedoed twice, called the s s Beanville out of New Orleans. And I can remember in one section there were prisoners, and these guys were lifers from Leavenworth, which they were going to take over.

And put them into combat with.

Idea that if they survived.

Relation.

They would.

00:04:37 Speaker 1

They were free, say.

Well this.

Around and of course the officers didn't like.

None of us liked it, so I don't think they ever used him to that.

What they did with him, I don't know, but they were in the same hole we were, but they were locked up.

In in, in in wire enclosures and stuff.

Are down in camp.

00:05:19 Speaker 1

Where there is, I said in combat intelligence.

And we were like any minute patrol and stuff and we would circle around. And these lot of these guys didn't train, you know, they goofed off and went to a bar or something some of these night problems and and.

We were amazed me to think that they didn't spend a little more time.

00:05:40 Speaker 1

I never. Only one of my ever knew was a high school fellow from.

And he was in regular infantry, and he had a story that he, he he ended up in a in a unit and he was captured the first night.

They were asleep in a house and the Germans patrol came in with burp guns and that was it.

Was during the Battle of the Bulge their first combat.

00:06:02 Speaker 1

Which amazed me that they didn't know about door guards and because regardless, you always had door guys, day or night, wherever they were.

But anyway, so we're training down there and it was hot in Midsummer in Georgia 9000 humid.

Terrible. Really.

And the only one thing saved me like these 25 mile hikes that did it at night and I used to get 2 lemons and squeeze them in my canteen of water. And I ended up with water left. And most of these guys were just parched.

You know, and stuff.

00:06:35 Speaker 1

Was how you help?

00:06:37 Speaker 1

We help other guys around and so forth because as I said, I was determined.

Sure.

00:06:41 Speaker 1

Was going to come home.

00:06:43 Speaker 1

So then I was alerted for shipment overseas and I told you I went.

In the beanville.

00:06:49 Speaker 1

And I got to England.

00:06:51 Speaker 1

And I was there for hours.

00:06:54 Speaker 1

And we put on a channel steamer. Teak wood. Beautiful British ship with hammocks in it. The way they slept, and we were overnight in the channel.

Was the South HAMP?

00:07:06 Speaker 1

And the guy were the most braids on the ship. Was the guy that made the teeth.

00:07:12 Speaker 1

They've had three or four big vats of hot water, and of course they lived on hot tea. As you know, the British do.

Now we got over to Normandy, to Omaha, and even though these other ports were open, they had us climb down the side.

Of the ship.

00:07:28 Speaker 1

You know, into these landing crafts and then we went and landed without any trouble.

Three of the guys, though, missed the.

00:07:37 Speaker 1

The sway of the boat.

00:07:39 Speaker 1

And went down to the bottom and never came.

00:07:41 Speaker 1

Of course, they had some Navy divers, but they never found them because there's a lot of silt in the bottom of the channel there and stuff.

How long? How long after D-Day did were you going into Omaha Beach?

00:07:52 Speaker 1

I was going in in late September.

00:07:54 Speaker 2

So probably 3-3 months or so.

00:07:58 Speaker 1

Our division actually went in in August, one with the 3rd Army and spent all their time with the 3rd Army. One of there were five divisions, what was called patents, workhorse divisions, and so forth.

And we were one of them and so forth because I didn't know it at the time.

00:08:13 Speaker 1

So now we climbed up this nice steep hill and get it to the top. And what do we see?

Think there were 11,000 crosses?

00:08:21 Speaker 1

And I thought, boy, what a place to bring it a.

00:08:23 Speaker 1

Of.

00:08:24 Speaker 1

Rookie recruits, you know, and so forth.

00:08:27 Speaker 1

So we spent some time I can remember there on a hillside.

00:08:31 Speaker 1

I think 10 miles. I had something like four extra helmets, 3 or 4 extra pairs of shoes.

Really, a supply train taking over exercise besides our own.

00:08:41 Speaker 1

So I probably had a good 6070 extra pounds in here tychin 10 miles and stuff.

00:08:47 Speaker 2

You had been in really great shape.

00:08:48 Speaker 1

Yeah, some of the guys didn't make it and so forth, but I made it and we pitched prop tents and spent a.

00:08:55 Speaker 1

Close to a week there. And remember, we had three mils of spam.

00:09:00 Speaker 1

Put your hand out.

00:09:02 Speaker 1

Piece of steel white bread, piece of span, steel white bread and a cup of.

00:09:06 Speaker 1

See and we couldn't figure it out. 'cause. They talked about the great rations, but we found out also that what was happening.

The cooks had girlfriends and their families and all the Class A rations were going to them and we were getting.

00:09:19 Speaker 1

Spam.

00:09:20 Speaker 1

We won't go into that.

00:09:22 Speaker 1

So anyway, then I was.

00:09:23 Speaker 1

By rail to near to near Nazi in France. And then I joined Company B, 318th Infantry Regiment.

00:09:31 Speaker 1

Of the 80th Infantry Division.

00:09:34 Speaker 1

And got into combat and the first thing they did was.

00:09:38 Speaker 1

In me the bazooka.

00:09:40 Speaker 1

Well, I never seen a bazooka before.

00:09:42 Speaker 1

Trained on it.

00:09:44 Speaker 1

I had a good Sergeant Sergeant who, as I remember, and he explained everything to me and everything. And then some wise guy says, you know, you're the 9th bazooka man we've had in 10 days. See.

00:09:55 Speaker 1

And I said, well, and I says, well, why didn't you take?

00:09:59 Speaker 1

You've been here and so forth, but this is what they did. Get some. Like the BAR, the mounting automatic. Get some big young guy that could handle it. He got it.

Of course they were losing a lot of men or the BAR in bazooka.

00:10:14 Speaker 1

Were the vulnerable.

00:10:16 Speaker 1

Those are the vulnerable weapons and so forth. When the bazooka was fired, they shot everything at you like we did with them.

00:10:17 Speaker 2

Sure.

00:10:27 Speaker 1

They went.

00:10:27 Speaker 1

And I had to use it the next morning.

00:10:30 Speaker 1

And it bounced off a tread of a tank and and what the guy said is you, when you fire that move, I said.

00:10:38 Speaker 1

Do you?

00:10:40 Speaker 1

He.

00:10:40 Speaker 1

Well, you ought to be able to figure that.

00:10:41 Speaker 1

They're going to shoot at you. So I fired from behind a tree and I dove and crawled behind some rocks.

With that tree just disintegrated. I've stayed there, so I looking for my assistant.

He wasn't anywhere around here.

00:10:54 Speaker 1

Out.

00:10:54 Speaker 1

And of course The thing is.

00:10:55 Speaker 1

Got to get.

00:10:56 Speaker 1

So bazooka's A2 man deal, you know, to put the electronic charge and wire it and catch on ahead and get out of there.

Take your head off. If there was no, there was no force to it when you fired it.

00:11:05 Speaker 2

Right, right.

00:11:10 Speaker 1

But no one's gonna know the number of times I fired the M1, and that my hearing is still fairly good.

Know which which I'm fortunate.

00:11:19 Speaker 1

So I I was mad I went to.

00:11:23 Speaker 1

I got a new rookie with me and I kept that for a while.

00:11:30 Speaker 1

So I kept that for a while and.

00:11:36 Speaker 1

I use different time to time. I use a lot of phosphorus, white phosphorus on enemy.

00:11:41 Speaker 1

They'd be in certain areas and you throw a rocket in with phosphorus. You got them out of there and so forth.

00:11:46 Speaker 1

Know that was it because the phosphorus was?

00:11:51 Speaker 1

Like napalm, it was a wonderful weapon.

00:11:55 Speaker 1

So we went along and fought our way across France and the division when they came across France, they captured Argentine and Argentine philos was one of the what they call the gap there, where they surrounded the German 7th Army and other units.

00:12:13 Speaker 1

And unfortunately they didn't get at it the way they should have.

00:12:16 Speaker 1

They were afraid that the British and American troops would shoot at each.

00:12:20 Speaker 1

The British and Canadians were coming from the north and we were coming from the South and I wasn't there at the time and so forth. But I'm the historian of the vision, so I pretty well know what happened.

And the guy that I've talked to, I've always been interested in talk with.

00:12:33 Speaker 1

Guys so.

00:12:36 Speaker 1

Anyway, we got to the Moselle river and the division did and we sat there for 10 days.

00:12:43 Speaker 1

Now our reconnaissance in the 4th Armored reconnaissance went to the German border and there was hardly a German soldier there, if you recall.

With, when the patent there had pushed, pushed hard.

00:12:55 Speaker 1

There was not much in front of them.

00:12:56 Speaker 2

Right.

00:12:58 Speaker 1

The gas, the supplies.

00:12:59 Speaker 1

Going to Montgomery in that airborne drop.

00:13:02 Speaker 1

You have your pros and cons of this.

00:13:06 Speaker 1

We got to the division, got there and waited and the guys told me they could see the Germans. They evidently brought troops from the Balkans, Norway and all around and showed in the area.

00:13:20 Speaker 1

The 317th Regiment, one of our sister regiments and one of my best buddies there.

00:13:25 Speaker 1

They got across the river, they didn't have the support.

00:13:28 Speaker 1

Usually you have your tank destroyers and extra tanks and your quad 50s and so forth support.

00:13:36 Speaker 1

They weren't there.

00:13:37 Speaker 1

Some of these guys.

00:13:38 Speaker 1

Over on logs and stuff and wooden boats and things. And it was in the town and the Germans were right in the village and fire them and the medics went downstream and pulled the bodies out.

00:13:52 Speaker 1

And they lost.

00:13:54 Speaker 1

Almost two companies going across.

00:13:56 Speaker 1

Wow, some did get across and fought, but they ran out of everything. It had to surrender.

00:14:01 Speaker 1

Wounded.

00:14:03 Speaker 1

And you know, that's another story. Their story.

00:14:06 Speaker 1

But you know, actually it was in March, by the time they got to the German border and broke through there into Germany and the 3rd Army had over 100,000 casualties in that thing.

When you were when you were moving across France and and obviously in in combat.

00:14:27 Speaker 2

All along the way.

00:14:29 Speaker 2

Did you?

00:14:30 Speaker 2

Did you did you make friends with the folks that you were with, did you?

00:14:34 Speaker 1

Very rarely saw a civilian.

00:14:34 Speaker 2

Ever.

00:14:36 Speaker 2

Yeah. How about the? How about the guys you were?

00:14:38 Speaker 2

With did you?

00:14:39 Speaker 2

Did you? Did you make friends with those guys or some of the veterans have told me that they tried not.

00:14:45 Speaker 2

Make friends true.

00:14:46 Speaker 1

You really didn't have an opportunity. 00:14:48 Speaker 1 Know your squad. 00:14:50 Speaker 1 I mean, I go to these, aren't reunions, and guys that were in my company. 00:14:53 Speaker 1 Never knew. 00:14:54 Speaker 1 And so forth over there. When I was sure and and, you know, you had your 4 platoons and so forth. 00:15:00 Speaker 2 Do you remember any of the guys that were in your in your squad and your platoons? 00:15:02 Speaker 1 Oh, yeah, yeah, there's there. 00:15:04 Speaker 2 Me about some of that. 00:15:05 Speaker 1 There's if. 00:15:06 Speaker 1 Recall, right now, when we went into edelbrook. 00:15:09 Speaker 1 Don't. 00:15:09 Speaker 1 If you want to go that far ahead.

00:15:11 Speaker 1

We went into edelbrook and fought there for three days and so forth, and I think right now.

00:15:17 Speaker 1

After I tell my story here, there two of us alive of that group.

00:15:23 Speaker 1

Now we went in with 220.

00:15:25 Speaker 1

We were over strength because we had come across France and the weather was horrible in.

00:15:31 Speaker 1

Mud, mud. Mud tanks couldn't get off the roads and stuff, and the Germans were fighting a battle.

00:15:38 Speaker 1

Always seem.

00:15:39 Speaker 1

Be fighting uphill in the Germans and so forth.

00:15:41 Speaker 1

That's the way it.

00:15:42 Speaker 1

The Moslem was up on the hill there and stuff had.

00:15:46 Speaker 1

360 observations.

00:15:50 Speaker 1

And of course, for their mortars in October the 88th, they could put it right in your.

00:15:55 Speaker 1

And so forth.

00:15:56 Speaker 2

So where you're obviously taking heavy casualties going across.

00:15:59 Speaker 1

We terrible casualties really in the mud and everything and of course all of us.

00:16:03 Speaker 1

Foot. Now the interesting thing is trench.

00:16:06 Speaker 1

Isn't considered.

00:16:11 Speaker 1

A combat casualty, you might say. Or a frozen fee.

00:16:15 Speaker 1

Of course I had trench foot and then I had frozen feet and legs.

00:16:20 Speaker 1

So this was a double jepudy when I got up in the balls, and if I hadn't gotten out when I did, I'm sure I would have lost some feet or something like that, but anyway.

00:16:31 Speaker 1

We fought across and you knew your.

00:16:33 Speaker 1

Of course, it was a tremendous turnover and so forth.

00:16:36 Speaker 1

And you knew?

00:16:37 Speaker 1

Fox old buddy more than ever.

00:16:38 Speaker 1

Anything you lost them or you were out for a bit. And as I said, I got hit 13 times, so I was in, out, in and out.

00:16:46 Speaker 1

Really only spent one long time in the hospital, which I'll get into further, but we got over there. Then we got into.

00:16:55 Speaker 1

Reached finally reached the border.

00:16:59 Speaker 1

In late November, Santo Vol.

00:17:03 Speaker 1

And we're right now, one of the largest American cemeteries is over there.

00:17:07 Speaker 1

We still have 800 men buried there from our outfit.

00:17:11 Speaker 1

So we were there and we had six days core reserve, we had 129 days in combat.

00:17:20 Speaker 1

No time off. Constant battle. Every day you attack with patience.

00:17:24 Speaker 1

You kept the enemy off balance and so forth, and you worked with Tank 4th and 6th Armored Division and so forth. Some of the best going. Of course the 12th and 20th core were some of Patton's favorites.

00:17:37 Speaker 1

They were with him all the way across the Europe.

00:17:41 Speaker 1

And as we excuse me, and as we moved that we would core resolve December 4, I remember.

00:17:49 Speaker 1

I told you about my friend that that they had attacked this village Farber's villa.

00:17:55 Speaker 1

A few days before and had gotten forced out.

00:17:58 Speaker 1

So we hiked all.

00:17:59 Speaker 1

I don't know about 35 miles. We hiked to support him and we got up there and I remember they put me in a foxhole and as I was running and not running, but as I was, we were moving up.

00:18:11 Speaker 1

This guy came running down there hollering.

00:18:14 Speaker 1

Element you know, no helmet, no gun, nothing. Just like this.

00:18:18 Speaker 1

But what had happened is there was a telephone pole and an 88 shell that hit that pole and was a dud.

00:18:26 Speaker 1

And he just, you know, he just went to pull it.

00:18:30 Speaker 1

Now I was a bazooka.

00:18:31 Speaker 1

So that was my spot, I says.

00:18:33 Speaker 1

You get rid of that.

00:18:34 Speaker 1

The engineers took it out and I said OK, so we supported them.

00:18:39 Speaker 1

On December 3rd, the night we went back to this village.

00:18:43 Speaker 1

And they gave us some hot food, warmed us up, and we had a meeting and I'll never forget.

00:18:48 Speaker 1

We had this meeting there and that early in the morning we were going to attack the whole car, 12 car, 5 divisions and we got there like 10 as we came out, the civilian says.

00:18:59 Speaker 1

Us what we were going to do.

00:19:02 Speaker 1

So I thought, well, we'll do Germany.

00:19:04 Speaker 1

So we formed in the streets about 4:00 in the morning. And just as we were forming in the streets.

00:19:11 Speaker 1

The Germans know it, obviously.

00:19:12 Speaker 1

All of a sudden these 88 started coming in. No, that's their big.

00:19:17 Speaker 2

They're big enough.

00:19:18 Speaker 1

Anti aircraft and use it. The only thing that saved us is the street was like this and these are direct fire went over.

00:19:25 Speaker 1

8 or 10 guys showed up later.

00:19:27 Speaker 1

They knew what was going to happen, so we went out and we moved up and we relieved the unit that was there.

00:19:33 Speaker 1

Went out and we stretched out across the top of a of a hillside and here were.

00:19:39 Speaker 1

Were tanks.

00:19:40 Speaker 1

This.

00:19:42 Speaker 1

Tank destroyers, Quad 50s you know mounted together and that 50 caliber is a wonderful weapon. Let me tell you, it keeps their head down.

00:19:51 Speaker 1

We were there and we knew.

00:19:53 Speaker 1

And just at dawn, we were going.

00:19:55 Speaker 1

Attack well.

00:19:57 Speaker 1

But an hour before that, all of a sudden the Germans put up \* shelves and we're sitting there on this hillside.

00:20:04 Speaker 1

Write and directly. When nobody said a thing, we just got up and charged because you know the tax started the artillery.

00:20:11 Speaker 1

Boomed in and we went through that village. Unbelievable and so forth.

00:20:15 Speaker 1

And I got on the other.

00:20:16 Speaker 1

And we reached our goal.

00:20:18 Speaker 1

It took 10 O clock in the morning on this hillside and I was over there and I was firing this bazooka down at some s s were in a house down below and this was a big high hill like and all of a sudden bingo. I got hit in.

\*\*\*\* with a sniper with a wooden bullet.

00:20:35 Speaker 1

And.

00:20:35 Speaker 1

Wooden bullets. You know, some say they didn't use them for, but they used them a lot in Normandy.

00:20:40 Speaker 1

Talked to paratroopers and many times if the poison owner say.

00:20:45 Speaker 1

Well, the the medic checked me over and he says, well, I'm going to ship you back when we leave there myself, a Sergeant who was 69 had lumbago.

00:20:55 Speaker 1

Couldn't move.

00:20:56 Speaker 1

And another fellow had been hitting the leg 3 or 4 times with wooden bullets.

00:20:59 Speaker 1

We were all sort of huddled together in the sleep for six hours then.

00:21:03 Speaker 2

What?

00:21:04 Speaker 2

What's the purpose of using a wooden bullet as opposed to a regular lead bullet?

00:21:09 Speaker 1

Well it it it?

00:21:11 Speaker 1

Creates core.

00:21:13 Speaker 2

Sure.

00:21:13 Speaker 1

As I said, that's one way it's silent and there's no smoke and it's great for a sniper at short range.

00:21:20 Speaker 2

I see.

00:21:22 Speaker 1

And it takes four men to carry a.

00:21:23 Speaker 1

Out right.

00:21:25 Speaker 1

And that was some of their feeling, you know that the Germans had learned this from the Japanese.

00:21:30 Speaker 1

Japanese did this a lot too and.

00:21:32 Speaker 1

And but anyway, so I got hit there and finally I walked out and I went back to the aid station and.

If you know what I mean. 00:22:29 Speaker 1 Diarrhea. 00:22:30 Speaker 1 So I had a nice time with that and so forth. 00:22:33 Speaker 2

Did every eternal was? 00:22:34 Speaker 2 Was there poison in this? No. 00:22:35 Speaker 1 There was no poison in it, luckily, and so forth. 00:22:38 Speaker 1 I wouldn't be here. 00:22:39 Speaker 1 Again, I don't know how sensitive that area is. 00:22:44 Speaker 1 ln. 00:22:44 Speaker 1 That hurt more when I got hit later in the thigh. 00:22:48 Speaker 1 And in fact, that did not heal. 00:22:50 Speaker 1 This was December 4th that did not heal up until January 11th in the. 00:22:55 Speaker 1 It was bleeding all that time and you get on trucks fighting or digging or doing, you know, you don't realize and stuff like that. 00:23:02 Speaker 1 So anyway, I got back there and we were loading into the trucks and we were starting to go towards sidebrook and across some. 00:23:09 Speaker 1 Defenses in the West Wall, Siegfried Line or whatever you want to. 00:23:13 Speaker 1 lt. 00:23:14 Speaker 1

So we got we.

And just as we arrived, all of. 00:23:18 Speaker 1 Sudden we were alerted. 00:23:19 Speaker 1 The Battle of the Bulge started. 00:23:22 Speaker 1 We didn't know anything about it. 00:23:23 Speaker 1 Were on trucks. 00:23:26 Speaker 1 For two days and two nights. 00:23:29 Speaker 1 175 miles. 00:23:31 Speaker 1 No blankets, no overcoats, no covering freezing temperatures. 00:23:36 Speaker 1 Huddle together, packed in their 19. 00:23:39 Speaker 1 We moved out in the company and we had brought in replacements and casuals and so forth. 00:23:44 Speaker 1 We had 200 and. 00:23:45 Speaker 1 Men. 00:23:46 Speaker 1

Who never got off those trucks.

00:23:49 Speaker 1

We went through depots.

00:23:52 Speaker 1

And they threw gasoline, water and rations in.

00:23:55 Speaker 1

You used your helmet or whatever.

00:23:58 Speaker 1

Whatever they had.

00:24:01 Speaker 1

I suppose it was something to see a truckload of guys going by, well relieving themselves in a way, but I'm sure didn't bother the French.

So we got there and we went through depots and they did this stuff and we took the driver would open the gas tank, the assistant driver would take the wheel and he put the thing in.

So we got up and went through Luxembourg and city, you know, which is a very modern. I remember seeing glass houses there in 1944. Very modern, very, of course, very friendly and very autumn spoke English and so forth.

Never. 00:26:32 Speaker 1 I've been back 20 times. 00:26:34 Speaker 1 Never could find that. 00:26:35 Speaker 1 It's. 00:26:35 Speaker 1 So anyway, we're. 00:26:38 Speaker 1 And a little while later, a radio Jeep came in with some armored unit and so forth. 00:26:45 Speaker 1 And he was. 00:26:46 Speaker 1 Away. And I told him to turn the thing off. 00:26:48 Speaker 1 Couldn't hear. 00:26:49 Speaker 1 It's snowing out, wind blowing and everything, and all of a sudden about 1:00 in the morning we heard tanks.

Usually you can tell the difference between the treads of a German or American debt, but without whether you couldn't do it.

So I go out with my rifle and Harlem, see, and luckily there were 12 a tunne of American tanks that were lost.

Some of the units we were in support I think at that time and we went way up on this hill and got fired at by our second battalion.

Was the first battalion and came down and we came down and back and we rushed down this hill into the village and got into a few houses.

And had some terrible fights in there.

They said, well, there's just a few Germans.

See whether it was a regimental headquarters there, say so. There were a lot of troops and equipment, tanks and everything in there and stuff, but I can remember just as we were running on this hill here were German bodies all over the landscape, really.

And what it was they had just started using what they call the proximity FU.

Mm.

00:29:37 Speaker 1

And this was aircraft.

00:29:38 Speaker 1

This was where, you know, a certain distance from the ground. It explodes.

00:29:44 Speaker 1

Well, these guys were caught with open foxholes and.

00:29:48 Speaker 1

And you know, it snowed. And you see the word shapes with the snow on these guys, like scarecrows or whatever it is, you know and stuff trying to get away and things. And I don't know, there were a lot of them. There must have been 100 or.

And we went right through them and so forth and then down into the village.

00:30:06 Speaker 1

But it's an interesting thing.

00:30:08 Speaker 1

None of the Germans had a covering over their foxholes.

00:30:11 Speaker 1

I mean, they had to.

So we got down in the village and fought there and we spent the night there.

00:30:19 Speaker 1

First day we lost every automatic weapon and every officer.

00:30:25 Speaker 1

And I think all but one Sergeant fighting in there. Luckily, that night they brought up more equipment and ammo and so forth.

Next morning the battalion came in up the street, shooting away with tanks and everything.

00:30:38 Speaker 1

They got stopped cold. The Germans attack.

00:30:40 Speaker 1

Attacked back.

00:30:42 Speaker 1

Major Tulsi was injured severely, though he was our battalion commander. See you there.

00:30:49 Speaker 1

Then on the 24th.

00:30:53 Speaker 1

We withdrew and as we were withdrawing.

00:30:58 Speaker 1

Bob Wade, another fellow friend of mine from Rochester, originally Syracuse.

00:31:02 Speaker 1

And we were to be the rear guard and we were there as a rear guard and.

They said don't wait too.

00:31:11 Speaker 1

5 minutes because they're going to our Turkey's going to open up at such and such a time.

Sorry for.

00:31:19 Speaker 1

All of a sudden we heard a muscle cry and we went down.

00:31:22 Speaker 1

Here's a tanker on a stretcher.

00:31:26 Speaker 1

It up now why he was wounded on the 22nd. Why? This guy was still there. The 24th. We could not figure out.

So we picked him up and started out just as we started out the activity coming in and so forth.

Terrible snowy, terrible night and so forth.

00:31:43 Speaker 1

And we carry him for a while and I have.

Shift you know.

00:31:46 Speaker 1

Big guy, two guys carrying it usually had straps or four guys on a stretcher.

We we finally got back down there and I can well remember we got near where we thought our lines were down below there.

And British British gear was a place, and there was a little Chapel there and a big farm in the state like. And that was a Medical Center. And we heard Safety's click off and rifles.

And we had a tough.

00:32:17 Speaker 1

We didn't know the news, counter sign or counter sign, but we got in there and so forth and they said we're going to dig out where we went in the barn and went to sleep.

Heck, with that, you know.

And then all of a sudden we were loaded in the trucks.

00:32:33 Speaker 1

I remember we went into this House and we were going to stay overnight and he said we're going to you're going to have your Christmas here.

Get your Christmas stuff, say.

Well, I thought.

00:32:43 Speaker 1

With all this going on, we're off the line and Christmas stuff.

Actually I got mine in March so.

But you know, it wasn't 10 minutes later.

Load up and here's the open trucks again.

We went around and we went down.

In the near Luxembourg City and cut across and joined nearby, the Forest Farmer Division, which was attacking up that way and if you know, you know the forest was the one that liberated.

Bastone, you know, broke in SO2 battalions of us the 1st and 2nd Battalion were attached to the flanks deep in the woods.

And we were in there.

00:33:24 Speaker 1

I got hit.

00:33:25 Speaker 1

This was Christmas morning. Some of those guys were in there three and four days and they had no blankets, no overcoats, no camouflage.

There were no buildings and there were no fires.

00:33:38 Speaker 1

Occasionally they had German artillery horse.

00:33:42 Speaker 1

You know, eat it raw.

00:33:45 Speaker 1

Try to cook it do.

00:33:47 Speaker 1

So you couldn't keep warm those guys and we didn't have the equipment you see?

00:33:52 Speaker 1

So we were attacking and I got hit well when when we.

00:33:57 Speaker 1

Off trucks.

00:33:59 Speaker 1

We were there.

00:34:00 Speaker 1

And we were milling.

00:34:02 Speaker 1

The guys are smoking and we were around the trucks and everything and and they brought up some.

00:34:08 Speaker 1

I like to say some cold hot chow.

00:34:12 Speaker 1

Pancakes are fire. 00:34:13 Speaker 1 Was. 00:34:14 Speaker 1 Couple pancakes with. 00:34:19 Speaker 1 When they have on a marmalade on it, it's rather than the syrup and oatmeal, the oatmeal, and so forth, and that they would give us that we'd be very happy every morning, hot or. 00:34:23 Speaker 2 And. 00:34:31 Speaker 1 Which we didn't get too often, of course. 00:34:34 Speaker 1 Now at least died at all. 00:34:36 I. 00:34:39 Speaker 1 Let me know when you're set. 00:34:40 Speaker 2 OK. 00:34:40 Go ahead. 00:34:41 Speaker 1 And so we went, went into got light just. 00:34:46 Speaker 1 We going on? 00:34:47 Speaker 1 We didn't go 50 feet. 00:34:49 Speaker 1

Were opened up on. 00:34:51 Speaker 1 Germans had dugouts there. 00:34:53 Speaker 1 Now why they never shot at us while we were in these trucks, I'll never know. 00:34:58 Speaker 1 But I had a little depression, so I got down and fired my hand. 00:35:03 Speaker 1 I got rid of my carbine. 00:35:04 Speaker 1 Wanted an M1. 00:35:06 Speaker 1 I wanted a little heavier so I started firing and all of a sudden bingo, I got hit right across the neck. 00:35:14 Speaker 1 Bert gun caught. 00:35:15 Speaker 1 You know, if they've been over that much, right? 00:35:18 Speaker 1 Shredded my. I had a towel around my neck for a scarf. 00:35:22 Speaker 1 That knocked my helmet. 00:35:23 Speaker 1 The sparks were flying and everything like that. 00:35:27 Speaker 1 Medic. 00:35:28 Speaker 1

00:35:29 Speaker 1

Looked at.

You're OK. So right back going, you said.

00:35:32 Speaker 1

A little later I had some shrapnel on the back and we were attacking in these woods and stuff, and then all of a sudden, you know?

00:35:41 Speaker 1

What the guys were doing is they were fixing bayonets because if they got hit.

00:35:46 Speaker 1

They hopefully.

00:35:47 Speaker 1

Put it in the ground so the medics could find them in the deep snow.

00:35:52 Speaker 1

And so forth.

00:35:52 Speaker 1

Well, I we were sort of gathered there and this one guy lit a fire.

Crazy guy and all of a sudden boom and I.

00:36:02 Speaker 1

It right through here.

00:36:03 Speaker 1

Ripped me.

00:36:04 Speaker 1

They said 88. I get Archer something.

00:36:09 Speaker 1

And it took one guy's heel off, took another guy in.

00:36:12 Speaker 1

Back and so forth.

00:36:14 Speaker 1

And the medics told us that the no.

00:36:18 Speaker 1

Bears are getting.

00:36:19 Speaker 1

You've got to hike out or you're freezing.

00:36:23 Speaker 1

Was any option?

00:36:26 Speaker 1

Some of the guys started to crawl.

00:36:27 Speaker 1

You know, we tried to help each other out as much as we could.

00:36:31 Speaker 1

We hiked 5 miles to the aid station.

00:36:35 Speaker 1

We had three firefights with some of the Germans on the way out. We might have said take your bandoliers of ammo.

00:36:38 Speaker 2

On the way out.

00:36:44 Speaker 1

Your rifles and.

00:36:46 Speaker 1

So forth. So we helped each other.

00:36:48 Speaker 1

And we finally did get to the aid station.

00:36:50 Speaker 2

So the three of you that were hurt right there were roads are more than three.

00:36:53 Speaker 1

Well, there were a lot more injured and some of them were killed, of course. But this is happening all the way. I was on the far right and I was getting sniped up from the front side and rear, the Germans closing behind us as well as the weather.

And so forth. 00:37:06 Speaker 1 Waiting the tanks were on the road. 00:37:08 Speaker 1 Never heard the tanks. 00:37:10 Speaker 1 The weather was so bad and it was distance where we were in there. 00:37:14 Speaker 1 Well, just to relate, I'll tell you what happened to me and then the division. 00:37:21 Speaker 1 So we hiked. 00:37:21 Speaker 1 Up back to the aid station. 00:37:25 Speaker 1 And. 00:37:27 Speaker 1 We got back there and they patched me up and says well. 00:37:33 Speaker 1 We've got so many casualties coming out of here. 00:37:35 Speaker 1 Going to put an air. 00:37:36 Speaker 1 You're going to hang on and possibly the states. 00:37:41 Speaker 1 Sorry, boy, that's. 00:37:42 Speaker 1

That \$1,000,000 wound you know.

00:37:44 Speaker 1

Well, we got up 500.

00:37:46 Speaker 1 German fighters brought us down. 00:37:49 Speaker 2 You were here in. 00:37:50 Speaker 2 Aircraft and you were shot down. 00:37:51 Speaker 1 Inner interaction. 00:37:53 Speaker 1 The M1 engine on fire 2 nurses killed some of the guys. 00:37:58 Speaker 1 Luckily, the pilots, one of them was wounded. 00:38:01 Speaker 1 They brought the plane around and landed it. 00:38:04 Speaker 1 And of course we we. 00:38:06 Speaker 1 Were all mobile, most of us, you know, we helped each other out. Pull the bodies about 10 minutes later. 00:38:13 Speaker 1 lt. 00:38:14 Speaker 1 And so. 00:38:14 Speaker 1 So back to the aid station there.

00:38:17 Speaker 1

What?

00:38:17 Speaker 2

Are you doing back here?

00:38:20 Speaker 1

Got back to the 8 station. They put me in the chair.

00:38:23 Speaker 1

Then they gave me 7 shots of Novocaine and they just reopened that right up to the whole thing to clean it.

00:38:29 Speaker 1

They didn't stitch it up because they wanted to be sure you know wasn't infected, so they banished it, shipped me down to down to the 50th General Hospital in Commerce, France.

And I.

00:38:41 Speaker 1

All 60-70 days there. I guess in there and so forth.

00:38:45 Speaker 1

General Patton came by and shook my.

00:38:47 Speaker 1

And so forth. You know, that's a story in itself and so forth, so.

They, you know, as soon as they could, they got you going.

00:38:59 Speaker 1

Well, they got me out too soon. Really.

00:39:01 Speaker 1

I had an awful lot of trouble.

00:39:03 Speaker 2

Did you have infections and so?

I didn't have infection, but a month later they stitched it up.

00:39:08 Speaker 1

But I had over 100 shots of penicillin.

00:39:13 Speaker 1

All of them in my shoulders. 00:39:14 Speaker 1

What used to get me so mad is they give you every three hours a shot and every four hours pills.

00:39:21 Speaker 1

Now, why are they combined?

00:39:22 Speaker 2

Yeah, really, because they kept waiting.

00:39:22 Speaker 1

If you're trying to get.

00:39:25 Speaker 1

Well, everyone of the guys had their feet out of the covers, couldn't take their feet, were frozen or, you know, frostbitten, whatever it was. And you're lying there and you're sort of praying and hope, you know, that that they don't turn black.

00:39:39 Speaker 2

They did come off well, did the.

00:39:40 Speaker 2

There.

00:39:41 Speaker 1

Go. Yeah.

00:39:43 Speaker 2

So so when you got when you were hit?

00:39:47 Speaker 2

Aside from the the injury that you had in your thigh, you were also starting to get frostbite on.

00:39:52 Speaker 2

Feet as well.

00:39:53 Speaker 1

Waist deep in the snow.

00:39:55

Yeah.

00:39:55 Speaker 1

You say you had already gotten it fighting prior in the cold on those trucks and everything. You know you did everything you could.

So it's just like kind of combined everything all came together at once.

Sure.

00:40:08 Speaker 1

Yeah, and.

00:40:10 Speaker 1

lt.

00:40:12 Speaker 1

Remember, with just a gross a bit, Patton came in. Captain came in, there were all split and polished.

Patton's going to visit you.

Want you all to come to attention.

And I said, Captain, I said, these men are all bedridden.

101st Airborne and 80th Division.

Was in.

00:40:29 Speaker 1

They brought the guys down from Bastone and they said these men are all bedridden, he says.

00:40:35 Speaker 1

Then lie at attention.

00:40:39 Speaker 1

I felt like.

00:40:40 Speaker 1

He's probably a good West Point man.

00:40:41 Speaker 2

Of course, yeah.

00:40:43 Speaker 1

So anyway, he came in and Patton came in and he looked at me. And of course he was always suspicious about combat fatigue and so forth.

He had sort of uttered something outside.

High pitched.

You know, I don't want to see, you know those.
