We met them, they met us and there was the first hand to hand combat that I had ever been in.

I do have one asset. We were a battalion and we were cut off from the our main forces and the only contact we had with them was we had one tank destroyer with us and we couldn't manage to get through on their radio on occasion.

But then, after I was wounded, the artillery fire got pretty bad in the area, so they moved me down.

Can't afford to stay there now, but at that time with about 10 officers per room or 10 and personnel per room, it was a army hospital for paraplegics. The reason I sat there, I had a my gunshot wound came out over my spine.

And they were worried whether there's going to be a paraplegic or not. Well, fortunately, I wasn't.
