OK. And that was in 19. 00:06:44 Speaker 2 Yes. 00:06:48 Speaker 2 For the last part of 41. 00:06:51 Yeah. 00:06:52 Speaker 1 And so you were. 00:06:53 Speaker 1 Why did you decide to go in the military? 00:06:55 Speaker 1 Didn't you wait to be inducted?

Well, there was a fun I worked with. It had a little military. 00:07:03 Speaker 2

Not in a war, but in the states. And I I think he kind of talked me into it with the idea that if we went in together.

There they it was a processing place, I think for draftees because we were there for.

All two weeks while I showed, I don't know hundreds of draftees through and then finally, when they came to us.

We they fitted us out all out with nice heavy winter overcoats and trousers on uniforms and a shifts to Louisiana Camp, Claiborne and Alexandria, LA.

Where you did your boot.

Yes, I that was the 82nd.

00:08:34 Speaker 2

Our inventory division at that time was there and we were went into the 82nd instantly.

So that was before it became a paratrooping paratrooper.

Yes, we.

00:08:46 Speaker 2

Had a little time after we finished our boot training and then they converted the 82nd Infantry to a airborne and gave one of the regiments to start the 101st Airborne.

OK.

And I found out that I was in the glider troops.

Well, I had seen pictures of the army gliders.

00:09:09 Speaker 2

Flying and landing.

00:09:12 Speaker 2

And the landing was not nice, the.

00:09:16 Speaker 2

The gliders were made out of wood and they they all was pieces. I don't think our army knew at that time that all the lots and plots of ground in France.

Had hedges around them and there was really no place they could land and and they had a hard time.

Almost all our troops are. The gliders were broken up on landing.

So you were in basic training in Louisiana, your boot camp, and then you joined the 82nd Division and then they broke it up and you were still part of the 82nd Division before.

They came through and asked for candidates for Officer school, correct?

So they came through.

Well, they they want they wanted.

And I wanted to get out of the 82nd Airborne, so sure that could.

And so I applied for, it was accepted, was sentenced to Camp Benning.

I believe I was in Georgia.

00:10:27 Speaker 2 Not quite sure. 00:10:27 Speaker 1 Right. 00:10:30 Speaker 2 And have three months training there and then there was. 00:10:36 Speaker 2 Transferred to the 88th Infantry Division at Tullahoma. 00:10:44 Speaker 1 So can you compare the officer candidate school training to boot camp? 00:10:51 Yeah. 00:10:51 Speaker 1 How difficult was the officer training? 00:10:53 Speaker 2 Well it. 00:10:54 Speaker 2 It was quite difficult because you were trained in everything. 00:10:58 Speaker 2 I mean, you did. 00:10:59 Speaker 2 training and.

You you were trained in in weapons and so forth that you weren't trained with in in your regular boot

You had to either master them or you you were shipped out and.

How physically difficult was it?

It was quite difficult because we had all all these.

Training things to go over, they had the.

Hikes, you went?

That was the worst thing I.

They gradually build it up to where we hiked 60 miles, 30 miles out, 30 miles back, and we lost a lot of men. In fact, is I I thought that might be gone because I broke both of my Archers and both feet.

And they wouldn't let me hike back, but I I stayed in the.

The in the division.

00:11:58 Speaker 1

Now how about the other officers?

They have other.

00:12:01 Speaker 1

Do they have problems too in OCS officer candidate school?

00:12:06 Speaker 2

Does it?

00:12:06 Speaker 1

They have the same type of problems you did.

00:12:09 Speaker 2

Yes, they they had the officers who who couldn't make it, Raiden and they would be shipped out and more modern men came.

Washed out.

So you joined the 80th Division, 300 and 18th.

Regimen and you went to school there for you did some schooling, didn't you?

Legitimate, yes.

Mechanic work.

No, no. They I went to the 80th, was assigned to heavy ward heavy mortar.

Uh.

Company and I was called to Division Headquarters One day and I didn't know my. I wonder, well, what did I do now, you know.

On but they were looking for someone with a mechanical background and they needed a motor officer and for some reason they picked me as the judgmental motor officer. And I went through the rest of the war as that position.

And you were commissioned by that time as second Lieutenant.

One way we left Fort Benning.

Commission.

00:13:13 Speaker 1

Where did you join the 80th? At the 80th Infantry?

Tell a Homa, Tennessee.

00:13:20 Speaker 1

OK, youth. So you we went to Camp Forest and then at that time you were allowed to bring your wife down.

Can't can't forest.

00:13:29 Speaker 2

Well, I could at anytime. After you had a Commission, you, your wife could travel with you and live with you.

So before that you what happened to your wife when you went into basic training or boot camp?

She was secretary to one of the men in now, Owens, Illinois.

Could stay, I forget.

Specified time and they gave the the.

Quayling quarters and every photo.

So she came down there once and.

11 time and while it's still in in the basic training she came.

She had.

00:14:31 Speaker 2

Got permission to come down to camp?

At Claiborne and.

She packed.

00:14:42 Speaker 2

It got already and I had to call her.

Got pneumonia down there, pneumonia.

00:14:47 Speaker 2

And I stayed. Had stay in the hospital for a month. They kept it.

They had a hospital they built.

00:14:55 Speaker 2

They called it the Seven Mile hospital. It was.

00:15:00 Speaker 2

Just all rooms on two sides and they said it was 7 miles long if they went around they had, I don't know how many cases of pneumonia.

Louisiana is very damp, you know.

00:15:16 Speaker 1

So you went to Tennessee and your wife was living with her parents at that time, and you brought her down. 00:15:18 Yes. 00:15:24 Speaker 2 She she didn't join me. 00:15:27 Speaker 2 Permanently. 00:15:32 Speaker 2 I so I was in in Tennessee and she after that. 00:15:39 Speaker 2 She stayed with me and. 00:15:40 Speaker 2 Bill, just before we shift out. 00:15:44 Speaker 1 So you went to. 00:15:46 Speaker 1 Would you go to school in Tennessee then? 00:15:49 Speaker 1 Maintenance tool. 00:15:50 Speaker 2 I when I was in in the Tennessee, I was shipped to Fort Benning. 00:15:57 Speaker 2 That was for another school and I don't remember the word. 00:16:01 Speaker 2 Was for we we took the. 00:16:04 Speaker 2

The training for mechanics are for officer training. When we were down in in Louisiana.

00:16:15 Speaker 1

So now you're in Tennessee and it's 1940 late 42. And you're probably wondering where you're going next, right?

00:16:22 Speaker 2

Everybody wondered that.

00:16:23 Speaker 1

Yeah. And there's all kinds of rumors, right?

00:16:25 Speaker 2

Oh yes.

00:16:27 Speaker 1

So what happened next?

00:16:29 Speaker 2

Well, from there on, we just travel the United States different places.

00:16:36 Speaker 2

Were in Kansas once we were in in Arizona.

00:16:43 Speaker 2

And from Arizona, where we were shipped back to.

00:16:50 Speaker 2

For **** to leave to go to Europe.

00:16:53

You know.

00:16:55 Speaker 2

But all this time now my wife could travel with me and.

00:16:58 Speaker 1

I was.

00:17:00 Speaker 2

My father-in-law.

00:17:03 Speaker 2

Had a car, of course, and gasoline and everything was rationed back home. He couldn't get enough gas to go to work, so he gave me his car and I had his car to drive all during the war, up during the efforts there in the United States.

And.

00:17:21 Speaker 2

But he one thing he didn't tell me and we run away from.

00:17:26 Speaker 2

Arizona.

00:17:28 Speaker 2

For *****, he didn't tell me that he had ludlks on his wheels.

00:17:33 Speaker 2

Know you.

00:17:34 Speaker 2

You couldn't buy tires, so they were stealing them, so they had ways of locking him down. And I blew a tire in in Arizona.

00:17:44 Speaker 2

At night, about midnight and went out to change it.

00:17:49 Speaker 2

We didn't have the love lock.

00:17:52 Speaker 2

And I hammered, drove and hammered the hammer, and I finally got it off.

00:17:57 Speaker 2

And someone told us where you go to Dallas, TX and you get 2 new tires to a serviceman.

00:18:04 Speaker 2

We drove over there and we were at work finally able to get one tire.

00:18:11 Speaker 2

And drove back then to to New York. My aunt lived in New York, and my wife stayed with my aunt. And I went down to scrambix.

So how long did you stay in at Camp *****?

00:18:26 Speaker 2

Only a couple of.

00:18:27 Speaker 2

We didn't stay there very long and then my wife, my wifes father, had to take a train into New York to bring the car back.

00:18:37 Speaker 1

So did you know when you went to cap *****, you were going to Europe?

00:18:41 Speaker 2

One way off.

00:18:42 Speaker 1

When you first went to Camp *****, did you know you where you were going?

00:18:45 Speaker 2

And we didn't know anything.

00:18:47 Speaker 2

All we knew that we were there.

00:18:50 Speaker 2

We didn't even.

00:18:51 Speaker 2

Wow, how we were able to get there.

00:18:53 Speaker 2

We are just there and they're all packed up and.

00:18:57 Speaker 2

Pack everybody in and one day they said. All right, boys, let's get going.

00:19:02 Speaker 1

Now, did you have your weapons then?

00:19:04 Speaker 1

Had you finished?

00:19:06 Speaker 2

I don't think I.

00:19:07 Speaker 2

I don't know where where we probably were. If we were, you know, it wasn't. 00:19:14 Speaker 2 Army rap Weapon Rat at first mm HMM it was. 00:19:20 Speaker 2 A Springer Enfield. 00:19:23 Speaker 1 Yeah. 00:19:23 Speaker 2 A British rifle. 00:19:24 Speaker 2 Believe it. 00:19:25 Speaker 1 So you went from Fort Dix to where to get on the boat to embark. 00:19:31 Speaker 2 We I'm barred from New York. 00:19:32 Speaker 1 So you wrote a train up to New York. 00:19:35 Speaker 1 She wrote a train to New York, do you think? 00:19:37 Speaker 2 No, II get confused. 00:19:41 Speaker 2 Where where the camp was before ***** was, we were there and went right from there to the. 00:19:48 Speaker 1 Part of embarkation. 00:19:49 Speaker 2 Yeah. 00:19:49 Speaker 1 What ship did you go on to England you remember?

00:19:51 Speaker 2

Well.

00:19:53 Speaker 2

We marched out.

00:19:56 Speaker 2

I'm in port and there.

00:19:57 Speaker 2

Over front of a great big boat, you know, and you got to walk all the way up that gangplank. And I didn't know what it was. They finally got on to it.

00:20:08 Speaker 2

Going around, somebody said, oh, this is the Queen Mary.

00:20:14 Speaker 2

So we we stayed, stayed on the Queen Mary had had a nice stateroom with six officers in it.

And then we had duty every so often to go down into the hole.

00:20:28 Speaker 2

Where they had less than man and that was terrible down there.

00:20:32 Speaker 1

The food now, did you eat with the enlisted man or did you eat with other object?

00:20:36 Speaker 2

Wait, was the officers?

00:20:39 Speaker 2

It was British food and they liked a lot of.

00:20:44 Speaker 2

Catering. Think of what it was.

00:20:47 Speaker 2

Kidneys. Was it kidneys? They like it.

00:20:49 Speaker 2

I that was terrible stuff, but I didn't care for further.

00:20:53 Speaker 1

Did you have any Brussels sprouts?

00:20:55 Speaker 1

Did you have any brussel sprouts?

00:20:58 Speaker 2

I don't remember that though.

00:20:59 Speaker 1

And Lamb, did you have mutton?

00:21:01 Speaker 2

If they whatever they serve, we have either, you know, either lay.

00:21:06 Speaker 1

Now you just you said that it was terrible down in the hole where the enlisted people were.

00:21:11 Speaker 1

Can you describe it?

00:21:13 Speaker 2

Well, it was just one large open spot with with sports going everywhere and they had to find a place to put their beddings away, you know, to sleep and and every time you hit a wave, you could hear it.

Sounded like somewhere with a hammer out there, you know?

00:21:32 Speaker 2

And it was. It was hard then we didn't know all about what was going on, where it started.

00:21:38 Speaker 2

I was going over there and we probably would have been scared to death if we did.

00:21:43 Speaker 1

Yeah. Did they allow you to go out on deck?

00:21:47 Speaker 2

You only got just the officers could go on deck.

00:21:50 Speaker 2

I had a lifeboat.

00:21:53 Speaker 2

Every officer had a lifeboat station with other officers in it, and at that time the officer.

00:22:02 Speaker 2

Who had the Lifel station was in charge? And you did what he said and I was just lucky to have the commanding officer in my life of station had scared me too, because I.

That's not.

00:22:16 Speaker 2

What to do?

00:22:19 Speaker 1

So you we took how many days do you remember how many days it took to get this?

00:22:24 Speaker 2

It took us six days to get across and we wonder why so long took so long. We found out later that they zigzagged all the way across the ocean from New York to to Scotland.

00:22:40 Speaker 2

And they told me that the zigzag because.

00:22:45 Speaker 2

The sub boats could not.

00:22:49 Speaker 2

Line up their torpedoes in that length of time and they would zig back the other way before they could wind up as far. So we went across without escorts.

00:23:03 Speaker 2

We didn't know about.

00:23:04 Speaker 1

All on your own.

00:23:05 Speaker 2

You see all the pictures and all the destroyers and so forth.

00:23:08 Speaker 2

You feel kind of safe.

00:23:10 Speaker 2

But we didn't have.

00:23:11 Speaker 2

And you look out and all you saw was water.

00:23:15 Speaker 2

And we landed in.

00:23:17 Speaker 2

I believe it was enough 1st to 4th they call it and I was the only the only port large enough.

00:23:25 Speaker 2

That the Queen Mary could safely go to.

00:23:28 Speaker 2

And we ship right immediately right from the boat to train and went down to to England then and we bivouacked and in and around one of the old great big Moore homes that they had there.

And we stayed there for for a few days and then they came and told us to pack up.

00:23:50

We.

00:23:51 Speaker 2

Went down to South Hampton and we were supposed to get out, get on board right away and go across the channel and we had to sit there for hours and everybody was shaking because.

I be a good place to be bombed.

00:24:07 Speaker 2

You know, we finally got on on the Liberty ship to go across the channel.

00:24:15 Speaker 2

I swear I was introduced to sea rations.

00:24:19 Speaker 2

And I hated them.

00:24:21 Speaker 2

I never did like.

00:24:22 Speaker 1

Did you have your equipment with you when you landed in Scotland?

00:24:26 Speaker 1

Know your jeeps and.

00:24:27 Speaker 2

We had our yes, I had Jeep and personally I want your personal equipment.

00:24:33 Speaker 1

So they they shipped all that stuff down to where you were bivouacked for a while and then they you sent them on to Southampton, OK.

00:24:40 Speaker 2

Yes.

00:24:42 Speaker 2

Well, we had him with us.

00:24:44 Speaker 2

Sipping where we were then.

00:24:46 Speaker 1

Yeah. So did you drive him down to Southampton?

00:24:50 Speaker 1

Or did they ship them down by rail?

00:24:52 Speaker 2

They had them all down there. Everything. Everything was shipped across and we picked it up over and now.

Was gasoline and.

George Patton's didn't like the Russians and the Russians were opposed to get into Berlin and George Patton didn't like it.
