I stopped at at my brother's office in Frankfurt on the way down, and he was he was gone for the day and I said, well, I said we can't wait. I said to you, I left word there, I said now we'll be coming back through at a certain time.

And and so we went down to the disparity barracks. And you wouldn't believe it when we got down there, we found out this, this AWOL soldier was already back in the states.

Out in Carlisle Barracks, PA, in a prison office. So this was more or less luck too, because we didn't have to worry about bringing the prisoner back.

And I got a statement from from the people there at at the disciplinary barracks that that he he was already back in the states, that it was our. It wasn't our responsibility anymore.

And so then I stopped and seen my brother on on the way back at Frankfort.

So that just shows you what kind of man Emerson Jones was. He was, he was all right.

I had 69 points with that one point held me up about two months of getting home.

So it was. I don't know, it wasn't too long till Sergeant Godek.

He went home on points and so I was acting regimental Sergeant major for, I don't know just how long probably.

Maybe two months or so, but I I couldn't get my rating because I was only up there on special duties, see? So, but they tried to talk me into staying, but I had a wife and a 2 year old daughter back home and a job with the post Office department and I couldn't. I couldn't afford to do it.

But they also talk up. Maybe OCS you.

Going on to officer.

No, no, they didn't mention that, but.

I'm not too sure I would have done that. I I would have. I would have got a master Sergeant rating and that that have been good.

But I I love that up there. I learned the army, I learned. I learned how to operate. But that was a mystery. I don't know how I was picked out of 3000 men.

But it never got out because I tried to find out, you know, and I've never been able to find out what? How I ever, you know, was promoted. It really wasn't a promotion. But chances are, if we went to Pacific, I might have got out of action because I think if I had went to Pacific, I wouldn't come home.

I wanted to talk just a second that kind of job, my memory of mentioning Captain Woodside, man, that you admire greatly. And I know Mr. Ray Clark did as well. What did you know about his? His background? And could you describe something about it? The personality of the man, his physical appearance.

Well, his physical appearance.

Like.

Mr. Clark said that redhead.

With the mustache now, he had one of these. He was a big old Swede. I round face.

Bushy red hair. And he had one of these hair.

Curly cue mustaches. One of the kind of what? What do you? What do they call them? What? What? They call them handlebar mustaches. And the man was just.

Well, he was a strong individual, very strong individual and had a strong feeling.

Freese, men. Very strong. Like I say, on that Christmas Day.

He said. I'm sorry I said forever forever. I mean captain Woodside. I said you you couldn't help this.

You know you don't. And like I say when when you're up there on the line, you can be, sometimes you're better off if you're not an officer. I've seen the couple of times, the second lieutenants.

Platoon leaders and and I seen one get up one day and he says well, let's go get them stood right up. And boy he he didn't have any more stand up till he was down for good see this is.

I mean, it's it's every man for himself.

When you're in the infantry, you.

You're just a plain GI Joe. Dog faces, Mr. Clark puts it.

Were you a a Rifleman or?

00:06:13 Speaker 1

Did you? I was an expert Rifleman. I took it. That's a funny thing. I I took my training at Camp Wheeler, Georgia, and heavy weapons. In other words, heavy machine gun. 30 caliber, heavy machine gun. 00:06:26 Speaker 1

And the only time I ever used a machine gun.

Is when I.

00:06:29 Speaker 1

Got my silver star outside Erfurt there and it was with a light machine gun. Well, they both operate the same way. The only thing one and one is air. Cool and the.

00:06:39 Speaker 1 Other is water cooled. 00:06:41 Speaker 2 And the machine gun you fired that day? 00:06:43 Speaker 2 At Erfurt was what kind of? 00:06:44 Speaker 1 Was it was a 30 caliber light light which is air cool. 00:06:45 Speaker 2 30. 00:06:48 Speaker 2 Error. 00:06:49 Speaker 2 Your icing gun. 00:06:50 Speaker 2 And you often see them on Jeeps and tanks with the holes in the sides. 00:06:53 Speaker 1 Right. 00:06:55 Speaker 1 Yeah. 00:06:56 Speaker 2 Probably the easiest way to describe it is somebody.

Well, a lot of them on your jeeps and weapon. Your light weapons were 50 caliber.

Four 50s.

And then on on your on your tanks was 50 caliber.

Yeah, so, but ordinarily, you were a Rifleman.

Definitely just just. Yeah, I just carried right. I just carried a rifle over my shoulder and.

Called dog face.

Sling and and you slept with.

00:07:20 Speaker 1

lt too, I mean you.

00:07:22 Speaker 1

That's one thing you never you never got away.

00:07:25 Speaker 2

From did you keep it always?

00:07:26 Speaker 1

Loaded. Oh, absolutely. And I carried. I carried.

00:07:33 Speaker 1

A A hand grenade.

00:07:37 Speaker 1

In my lapel slot here.

00:07:40 Speaker 1

But of course you you squeeze the pin so it the pin didn't come out because you don't want to be sleeping. Sleeping with a live hand hand grenade with the possibility of PIN pulling out, or that you know.

Yeah, we, we all carried A and and then I carried. I don't how many vandal layers.

00:07:57 Speaker 1

Of ammunition besides my belt. When I carried my belt.

And usually all I carried, I carried this. Here is a folding trench shovel. It's it's like a gravel shovel, pointed shovel and they're they're smaller. Naturally only about. Oh, I don't know. 6/6 inch blade.

And it the blade would fold under up next to the to the handle, and you carry that on your on your belt.

And besides the vandwellers of around your.

00:08:30 Speaker 1

Shoulder and then I carry some I had. I carried a raincoat.

And fold up behind my belt. Didn't kill it, didn't carry a pack. Now you see a lot of them carrying packs now. My outfit, we didn't carry packs we, you know.

But they did issue 4 buckles for us when we were up in the in the bulge air at 4. Buckle boots. See when we first got out, all we had was just our combat shoes, combat boots, you know, they come up partway up your leg.

A what?

Also.

And find and some of them didn't even get get the we had problem with frozen feet up there.

Hey, we. We'd be out there weather down to almost zero. And you lived in a hole like an animal.

And I I still got my little stove here that I used with my wife, sent, sent that to me that you have these little chemical tablets, and that's how I'd heat the water for my nescafe coffee in the bottom of of a of a foxhole.

So we so we'd have warm coffee. Yeah, that that's how. That's how we live, just like animals.

Don't believe I the reason I say it it it's hard to believe that that we made it through the environment. We had to be in. That was the best shape I've ever been in my life. Like I said, I was an athlete in high school. If I was never in that kind of shape, I was 20.

Four years old at that time.

00:09:57 Speaker 1

But I was never in that good of shape and thank God that I I took that that training seriously or I wouldn't be here talking to.

There's a controversy and I always ask infantrymen about this. Men had served in the infantry SLA. Marshall was talking about that in some outfits. Or maybe he was making a general observation that there's always some fellows would never fire their weapon. And in a combat situation, some who always would. And then there are some fellows.

Were sort of in a Gray area, but you were there. Was it there ever a problem in your company or the best of your knowledge of somebody freezing up and not firing their weapon when the Germans?

Were.

00:10:36 Speaker 2

Firing at them, they had a.

00:10:38 Speaker 1

No, I.

00:10:39 Speaker 1

Not not in my experience. Now I.

00:10:43 Speaker 1

Of course, a lot of times you went in a position where you couldn't fire.

00:10:47 Speaker 1

You didn't want to stick your head out of the hole, you know, but basically I I didn't have.

00:10:54 Speaker 1

The only problem I had I had a a young kid with from he was from Pittsburgh, I remember.

There's always 2 fellows.

00:11:04 Speaker 1

In a foxhole.

00:11:05 Speaker 1

You always had two you buddy.

00:11:07 Speaker 1

Up and your buddy.

00:11:08 Speaker 1

Up.

00:11:09 Speaker 1

Now, like I say, maybe once every three or four days or a week you our kitchen would be in some wooded area somewhere and you'd undercover of darkness.

One would go up to get.

00:11:23 Speaker 1

Food.

00:11:24 Speaker 1

The other one stayed in the hole.

00:11:26 Speaker 1

And then when that one came back, the other one?

Would go.

But this kid kid by the name of Fritz, I believe his name was from from Pittsburgh. He followed me like a dog every, every, every time I go, I turn around and Fritz was behind me.

I said God, man, I said you're.

Get away from me, I said. The first thing you know, I said, we're both going to get killed.

Well, he just kept this up and and.

00:11:54 Speaker 1

Even the old man told me I'm talking about Woodside.

00:11:58 Speaker 1

He said, hey, you, you got to get that kid off your back and I.

00:12:00 Speaker 1

Said you telling me I know it.

00:12:03 Speaker 1

And all of a sudden, one day you just come up missing.

00:12:06 Speaker 1

He's one of these guys. I'm unable.

00:12:10 Speaker 1

And then after I got up to regiment, I found out.

That the reason he went AWOL and the reason he was probably following me like a dog, he had syphilis.

And the guy was he? He was well, he was sick. But this Seth was not evidently affecting his mind in some way.

And yeah, that's that. That's that was the reason he was he was like he was. And here here all the time he had syphilis.

No, I never. Well, you should have went back to to, you know, went back to sick call and find out what, you know, what was wrong with him. But he just didn't do it.

But he did. He I know Captain Woodside. He.

He said you got to get him off your back, he said. You're both going to get killed. And I said you telling me I know what I've told him.

But you know, I'd. I'd be up up there eating and maybe turn around. There was fits behind me.

Nobody back.

In our hole.

Not being covered then to that particular site.

That's right, but I I.

You know that there are some funny things that happen, you know.

All getting back to the frozen feet and things, and I don't even how this happened.

But we changed our socks every day up there.

00:13:22 Speaker 1

You carried 1 dry pair in the top.

00:13:24 Speaker 1

Of your helmet liner.

00:13:26 Speaker 1

And then you had actually the ones you had on your feet. But every day there was a runner came around with a pair of dry socks, and he's trying to avoid this here frozen foot thing. And there was a, there was a lot of them. They a lot of.

Them lost toes, some of them lost their whole feet.

00:13:44 Speaker 1

It it it it it was rough.

00:13:46 Speaker 1

Luckily, I'd I'd mine got cold, but I. But every day I was religiously with this, I chained my socks every day up there so.

That's that's about the story.

00:14:01 Speaker 2

Captain Woodside, given the strength of his personality, I would assume now I don't want to put words in your mouth that you had a real strong a spree decorating company. It would that be a fair assessment.

Oh, yes, yes, what it did.

00:14:14 Speaker 1

Those guys who went through hell for Captain Woodside.

00:14:19 Speaker 1

And he had done the same thing for.

00:14:20 Speaker 1

Us.

00:14:21 Speaker 1

See, that's that's.

00:14:24 Speaker 1

Of course, now, Captain Woodside wasn't the only one we had. I mean, I we we had other company commanders before him, but but he was tops in my book.

Of course it in actual combat.

00:14:37 Speaker 1

When things are rough, he he was our main man. Prior to that, you know, we we weren't actually in under fire, you know, that makes a difference too.

I assume he is. He survived the war. Is that correct?

Well, well, I'm almost sure he did, but I have no contact. I've tried to even even Captain Jones from regimental headquarters. I've never been able to find out what it. Now I know that Sergeant Goldak the one that, that, that.

You had no contact.

00:15:07 Speaker 1

Replaced the Sergeant palettes. He passed away. I got it in my new Ridge, 80 Division Association magazine. And here about a year or two ago, he.

Correct.

00:15:20 Speaker 1

Passed away.

00:15:22 Speaker 1

So, but but Sergeant Palazzos belongs to the 80th Division. He lives in New Jersey.

00:15:28 Speaker 1

Think I've got his name and address here. I'll give.

00:15:30 Speaker 1

It to you, OK.

00:15:31 Speaker 1

I got it here somewhere. I don't know just where it is, but I'll try to find it.

00:15:36 Speaker 2

You mentioned off tape too. The importance of the combat Infantry badge, which is the blue background with the cross rifles. What what does this the Combat Infantry badge mean to you in in relationship to the other?

Right, right.

00:15:50 Speaker 2

Metals that you received.

00:15:53 Speaker 1

I the The thing is.

00:15:57 Speaker 1

There's a great possibility that I would have never been awarded the other medals without first being awarded or first being a combat infantryman.

And to me, they they, you know, they talk about the Marines.

00:16:13 Speaker 1

But I can classify myself with any marine.

00:16:18 Speaker 1

We we had it just just as tough as they did so.

00:16:22 Speaker 1

When it comes to combat, we we were the we were the top people and that goes along with the Marines. I don't mean to take anything in the Marines. That's a great offset.

But to tell them that they were better than we were, that I'd have to see.

00:16:34 Speaker 1

That.

00:16:36 Speaker 1

Because we, we we served under the same conditions as they did and this is actual combat. You know you can.

The other branches of service you know, you even in the artillery and stuff like that, you're not right on the line. You know, you this this is that means something to me.

To know that I was at first hand.

00:17:00 Speaker 1

Uh.

00:17:01 Speaker 1

Duties, you know, in a combat way, rather than being making some death someplace or or, you know, or maybe way back away from the front, maybe firing our till recent, you know, and stuff like that.

Oh, we we needed all the service. Don't get me wrong. We needed them all. I remember laying on my back up there that Christmas Day.

In one of those holes and seeing those B seventeens going over, I mean just hundreds of them going over the top and go get them go get.

Them you know.

00:17:33 Speaker 1

And I'll tell you something else.

00:17:36 Speaker 1

When you're in a condition like I was up there on Christmas Day, don't think that you can't pray.

00:17:43 Speaker 1

And don't take a long prayer.

00:17:47 Speaker 1

God be with me.

00:17:49 Speaker 1

God be with me and he was or I wouldn't be here.

00:17:58 Speaker 1
That's true.
00:18:00 Speaker 2
When that you were wounded in that tree burst on, I think it was.
00:18:04 Speaker 1
March 17th, March the 14th, 1945.
00:18:09 Speaker 2
Were you incapacitated?
00:18:11 Speaker 1
No, I I didn't go on with that. I I felt this. It felt just like a sting back here.

00:18:19 Speaker 1

And held my hand a little bit of blood there and there's some medics. 1 Medic not too far from there, taking care of another guy. And finally he came over to me and he said sorry. Do you need any help? And I said, well, I said I got a piece of it back here in my arm and got something back here and he took a look at it. He said, well, he said if you want to go back to medics, he said I'll send you.

Back and God, they were small arms fire all around us said, hey, I've got to be wounded worse than this before I go back, you know?

00:18:47 Speaker 1

But I said I may need a statement from, you know, from from you. And so I guess that's where they got the information. Or maybe he turned it.

In I don't know.

00:18:55 Speaker 2

But they just basically patched your arm up.

00:18:57 Speaker 1

He didn't. He didn't. They didn't do nothing, right?

00:18:59 Speaker 1

Then.

00:19:00 Speaker 1

No, II just just covered it up and.

00:19:04 Speaker 1

It finally stopped bleeding and I just let it go. And then incidentally in.

00:19:09 Speaker 1

I think it's about July.

00:19:12 Speaker 1

We still had our woolens on yet, and I remember reaching back here and I cut my finger.

00:19:18 Speaker 1

I felt something and here that piece of shrapnel has started to come out and went through my shirt sleeve bag here. Then I went down to medics.

00:19:27 Speaker 1

And and one of the captain down there, he got a hold of a pair of trees and pulled it out.

00:19:33 Speaker 1

It was about that long and oh, it wasn't any bigger and hard to pencil lid.

00:19:38 Speaker 1

But that thing went right in there and just.

00:19:41 Speaker 1

You know, a lot of them still carrying their their shrapnel. I mean it goes in.

00:19:44 Speaker 2

And stays right in there. A lot of fellas were wounded by tree bursts. I've interviewed several that was lethal, like those 88 hit those trees and just spray.

Well, well, you know, they they come out with it with well, we had it too.

00:19:58 Speaker 1

We had it with our 90s, you know it, it it right at treetop, they would, they would explode and come down like this.

00:20:07 Speaker 1

Now that was towards the end of the war too. And when they come up with that, that type of ammunition. Yeah. Well, the Germans had it too.

00:20:15 Speaker 1

But I don't know these these ones that these tiger tanks fired up through that woods that day. They come direct up through there. They they didn't explode above the trees. They come right up through the trees.

And I got just about just about at the Crest of this hill.

00:20:32 Speaker 1

And I did. I actually just seen about the time this one guy hard tanks.

00:20:37 Speaker 1

I could see just just the top of this one tank. Well, that I didn't want to see you all are tanks that are different. And I mean, you're going to scatter and pretty quick.

00:20:49 Speaker 1

Now they never come on. Well, they couldn't come down through the woods because it was just tanks could have come to that, which is too thick.

00:20:56 Speaker 1

But boy, they sure fired down through there.

00:21:00 Speaker 1

Yeah.

00:21:01 Speaker 2

Question I always ask the veterans is, did the war experience change them in any way? And I'd ask you that question. Did you change this a person from the time you went in until the time you got out of service?

I didn't think me didn't change me much more than.

00:21:20 Speaker 1

Then probably making a much, much, much stronger man.

00:21:25 Speaker 1

Mentally and not so much physically, but especially mentally I.

00:21:30 Speaker 1

I I I just become so much more military, I guess. I don't know. I guess that's how I'd have to explain it now, physically. You know, you you you're not going through that training all the time when you get out but.

But mentally, it made me a much stronger person. I know it did. I know it did.

Yeah.

00:21:52 Speaker 1

And I think another thing that that helped me probably was was my.

The athletic aspect that I had in high school where.

This this helped me build character discipline.

00:22:07 Speaker 1

You need discipline. Ohh, but you you need discipline more than anything else and that's the reason it gets to be so rough on on on some young people going into service today that or any time as far as that's concerned.

Not having any discipline before they enter the service and then you get this discipline. I mean you get discipline.

00:22:29 Speaker 1

And that's well, that's that's that's the core of your success in America in making a soldier or a sailor out of out of anybody or an airman is you got to have the proper discipline.

That kind of carries over them to the.

00:22:47 Speaker 1

Rest of your life, it does definitely. I mean, in whatever. Whatever your.

00:22:51 Speaker 1

Endeavor is in your life. What? Whatever you do that carries over and not. And that's like I say, you asked me what? That's the strength that I got or that's really what I got out of the military.

And it says here that you started back to the United States on December 17th, 1945 and arrived on December 29th, 1945 and.

How did you?

00:23:13 Speaker 2

Get maybe talk a little bit about how you left Europe and got back to the states.

Well, if we have to talk about that.

00:23:23 Speaker 1

There was about 1300 of us on the Sheepshead Bay. Now that's a liberty ship.

00:23:30 Speaker 1

And we left.

00:23:35 Speaker 1

Where did we leave in France, I guess, left out of Lahar.

00:23:39 Speaker 1

I believe it left out of the hard.

00:23:41 Speaker 1

And the name of this liberty ship was the Sheepshead Bay of all names.

00:23:47 Speaker 1
