And we we, you know, we were signed up bumper to bumper and then we'll be ready to take off. The Frenchman came punch me young kid about 18 years old. He had all these markers on this. You know that marking what do they call it anyway I got on the arm.

He was part in that book we had in English, French and Don and Jay up, saying Don Jay and he pointed.
