The boat put us on train there and took us across England. 00:09:02 Speaker 2 Push on the boat on the other side of England there and took us over to the hog. 00:09:10 Speaker 2 And then they spread us out. 00:09:14 Speaker 2 And. 00:09:16 Speaker 2 I sent part of us up to. 00:09:18 Speaker 2 I don't know where the other boys. Yeah. Mitts. France. 00:09:27 Speaker 2 From Mets by they they. 00:09:33 Speaker 2 They sent us up there to. 00:09:37 Speaker 2 Uh. 00:09:44 Speaker 1 What we all doing up there? 00:09:47 Speaker 2 Trying to get to the front. 00:09:51 Speaker 2

We were going up as replacements. 00:09:54 Speaker 2 And. 00:10:01 Speaker 2 We got up into. 00:10:04 Speaker 2 Georgia's uh. 00:10:08 Speaker 2 The regimental headquarters company where they're going to separate all of us. 00:10:13 Speaker 2 Tell us what outfit we'd be in. 00:10:16 Speaker 2 And it was about 30 of us, I guess on that vehicle. 00:10:23 Speaker 2 And they called my name told me to get off and. 00:10:28 Speaker 2 I got all of them as well. What's this for? 00:10:31 Speaker 2 Well. 00:10:33 Speaker 2 You've got a. 00:10:36 Speaker 2 We, we, our our mailman was. 00:10:41 Speaker 2 A wireman yesterday or day before and said he got so scared. 00:10:48 Speaker 2 That he can't talk. 00:10:50 Speaker 2

And a bombing daily. You know, that was the bullsh were the start of it and all that. And so anyhow, he said that we need a wireman because he was and you've got a spec number.

What does a wireman do?

Telephone lines where the boys are coming.

And I mean that I put and we had a man. There's a little bit.

You know, we be trying to find out where those wires are shot into and all that kind of stuff and put them back together so.

That needed a wirement, and that where I'd been training.

Well, the first job that gave me.

Was down on sour river.

And that was the widest spot in the Siegfried Line. I'm sure you know that part of it.

And we stayed there two or three days.

And couldn't get out much.

After finally they decided we're going to jump.

So they they call my crew.

Along the line across the river. So.

You know that we are on this side now on that side and there seek freedom right behind them.

Far from here, the other side street.

We we found a snowboat, put it together and use some of that little bitty wire instead of the big.

When when you said jump, what do you mean by jump?

They said y'all gonna jump, jump off, take off.

00:14:23 Speaker 2

You know, we call it jump.

We're jumping this morning. You know, that means we're we're getting out of here, boy.

Coming on, we're going.

So.

Well, we got the we got the line about halfway across the river and that time of year it was up a little bit and both we had to go back and start over.

With the two of us and hold the wire up so it wouldn't get down. We'll get outside to tree on the other side and.

Now later here the whole boys come.

Come across the river.

Got up there pretty dark that night.

Why would moving around a little bit and the major wanted to line up the top, the hill? And I said, well, major the most.

Boxes up there, sailor. What they call.

The Germans.

00:15:52 Speaker 2

Juries, the the concrete boxes, pill boxes, appeal boxes, and I said, can't you got to have a phone?

Got when I started up here and we took a little bitty wire had a mile.

On the real about that riding about that big around.

Somebody hollered at me and said get off my foot, you *** ** * *****.

Rather, read not well. You'd remember it too, but.

Went on about my business when I got discharged.

John, going back to John Barker going down the street and a guy named Ross Presley.

And about a week later, first met her I got from home. 00:17:33 Speaker 2 While I know the boy. 00:17:35 Speaker 2 That I graduated. 00:17:37 Speaker 2 He had a twin brother and Mama wrote me a letter. 00:17:41 Speaker 2 First one I got and he had been killed. 00:17:45 Speaker 2 In that same. 00:17:47 Speaker 2 Deal that we were in there, but we finally got up the hill. 00:17:53 Speaker 2 Cut on the cross. 00:17:57 Speaker 2 And. 00:18:01 Speaker 2 They came all the way across. 00:18:05 Speaker 2 Through the widest part of the Siegfried. 00:18:10 Speaker 2 Went down into. 00:18:13 Speaker 2 Kaiser Slaughter and went into. 00:18:18 Speaker 2 I had the first telephone line in Nuremberg, Germany. I put the first one in there. 00:18:24 Replay.

00:18:26 Speaker 2 And. 00:18:28 Speaker 2 We had. 00:18:33 Speaker 2 We went to Munich. 00:18:37 Speaker 2 Went up to Campton. 00:18:42 Speaker 2 Then we cross the Elb River. 00:18:45 Speaker 2 And major wounder line across there, that's when I got up there in the middle of the town. 00:18:52 Speaker 2 lt. 00:18:53 Speaker 2 That guy, says Bogan. 00:18:56 Speaker 2 And I knew it wasn't supposed to be. 00:18:58 Speaker 2 Of that going on that time. 00:19:01 Speaker 2 So we jumped in an old barn there and the barn was full of hay. 00:19:06 Speaker 2 They didn't bail it over there, you know, they just piled it up. 00:19:11 Speaker 2 And so main that old ball we. 00:19:14 Speaker 2 We scooted his follow up in that Bale of haze. We could drop the line out. 00:19:21 Speaker 2

It was rolling off out in the middle of the street and they look for us all night, but they they they came in that barn.

But they didn't bar it 20 feet in it to see where it's in that we buried 10 feet.

The Germans came in the barn looking for.

00:19:38 Speaker 2

Oh yeah, and you all were up and up and, well, the the barn. The barn was probably.

00:19:46 Speaker 2

30 by 40 big you know, and that's all it did because I did bail it over there. And those days they just piled hay in there.

You know, you could go as far as as long as you can still breathe while you.

How many of you were in there?

Two way it take one man and carry the real.

So I got another story about that.

We stayed there that night. The next day while our boys come across the river and the rest of them got out.

So we found his house and Natasha, Major, when they signed our, Mr. Sarah signed a thing. The major wanted to be.

French put me a line in there.

You know well, it's raining a little bit that day.

And we went back. We didn't. Didn't have the little wire at that time, so had to use the.

Regular size. I just had 222 lines inside.

Anyhow, I was pulling it.

Back in the Jeep and the guy was running out the window.

You had to squeeze it so it break between you and the Jeep instead of half mile back there.

Know. So when I jumped down on it.

A woman had just hollered at us about 10 minutes before.

And asked me if.

If I wanted valency and flashes snobs.

Layer and I'm sure y'all know what Snoop says. And boy, that was just like, did we wanna? 00:22:45 Speaker 2 Heaven is open the gates and she couldn't get her front door open to give it to me. 00:22:53 Speaker 2 She took a string, tied it around the neck of that Bob, and let it down. 00:23:00 Speaker 2 Me looking up into the rain, you know, let it down that to me, I get it. 00:23:08 Speaker 2 And put in the raincoat pocket. 00:23:13 Speaker 2 Then the Jeep gets on over there. They had. 00:23:17 Speaker 2 Buildings. 00:23:18 Speaker 2 Across. 00:23:20 Speaker 2 The street with you know. 00:23:24 Speaker 2 That you could walk in and they were really. 00:23:28 Speaker 2 Nice things. 00:23:30 Speaker 2 The streets weren't very wide in here, and they didn't have to go far, so, but there's lots of streets, but you had to drive through them. 00:23:42 Speaker 2 Anyhow, to get down that street? 00:23:44 Speaker 2 So when the Jeep ran out of wire, guess where he was.

Why we always had 10 or 12 or 15 five gallon cans of gasoline. We wash them out real good, you know.

Boy and that wine was good, man. He had been there for five years. You know, the more wood barrels.
