And where were you in the mix?

World War One was. 00:05:39 Speaker 1 My dad was in the first World World War. 00:05:42 Speaker 1 Still had his uniform and. 00:05:45 Speaker 1 And it hadn't been that many years since the Titanic let down. In 1912. It was. 00:05:53 Speaker 1

They were still talking about it, so I had a deathly fear about a sinking ship. I can remember that.

Help us. 00:09:30 Speaker 2 Did your brothers go to war at that time? 00:09:34 Speaker 1 My oldest brother. 00:09:36 Speaker 1 Let's see. He'd be 10 years older than I am, so. 00:09:42 Speaker 1

l was.

He'd be 20.

He would. He was married, so he got a.

He didn't go in, but then my other two brothers went in the.

How frightening it is to think that nothing's going to.

J3 Cubs and I sold in AJ4 coupe. I don't know if a little side by side, but it had a stick instead of a wheel.

See, I turned 18 in February. 00:14:50 Speaker 2 That's why. 00:14:53 Speaker 1 And immediately, they'd already had us all pegged. 00:14:57 Speaker 1 We went down to Pocatello and took her physicals and I passed the physical. 00:15:02 Speaker 1 Well, I decided, hey, I'm going to get in their cadets. 00:15:04 Speaker 1 I went over to Pocatello and I took their. 00:15:08 Speaker 1 I passed their test and they gave me a little green, card says. 00:15:10 Speaker 1 You take this green card. 00:15:12 Speaker 1 When you go in the. 00:15:15 Speaker 1

But here drive you have to go back and finish high.

West of France, turn N up along the West side of Ireland.

And one house on the MP duty. And I looked out one morning and there's a couple little.

We got our signal to clear all the decks and clear all the passageways guys had.

And it went out of quiet ways.

The subject pulls some kind of a threat to us.

Then we went up around the north part of Northern Ireland and down to Glasgow. That's where we disembarked.

To Southampton.

So some signs of war, some burned out buildings.

But there was no attacks at that time.
