My name is Frank Aaron and was in the 319th Patagon.

And that was around Mooresville, France, that, to the best of my knowledge, George D Patton made it to, you know, George Patton come up and inspected the arms. And he didn't like the way the gun.

They went up and the machine and the Lieutenant to the best of my knowledge, the Lieutenant Friskies as Lieutenant Sergeant Italy, to talk to the Germans.
