That's where I worked.

My first job was an estimate plant.

The steel industry, I wouldn't struggle Ohio for Youngstown sheet and tube.

And then I got drafted.

I was about 20 years old when I went in and I spent my 21st birthday down in Tennessee and Camp camp for Tennessee.

You just said.

Yeah, I retired. And at 80, at 85 and I'm just about that now myself.

During the war, well during the war, what I did the first time I got, I'll tell you I didn't get no accident until I got into Queen Maryland at the Queen Mary.

Into Scotland and there was George Patton, General Patton and the first thing he said to us and he was looking right at me because I was one of the first ones off the plank, you know, and he said.

We have to, but the German is attacking us anymore, I guess because it wasn't long after that they had to started that their invasion in France, the beachhead.

Did you make the invasion?

00:07:20 Speaker 1

Of Didi got there when they were started at the June the 6th I think was D-Day and I got there in August about.

Six weeks later.

First thing we did, we assembled. They already had six beaches, 6 miles of beach.

Capture already. So when we got off the boat we just had, we got done into those what they call bread ball, express them trucks you know.

Oh yes, yeah.

And they took us up to the front lines and we dug in.

OK.

00:07:53 Speaker 1

Dug in up there.

00:07:56 Speaker 1

And I had one friend.

We will dig any and I was lucky. I got a fox all done soon, you know.

But one fella couldn't find her, couldn't dig a false every place you dug your hit rock.

So he was scared.

So I told him we'll make mine wider.

He sat in with me.

Uh.

00:08:14 Speaker 1

Then and German thanks for coming.

At that time, we had a fighting with bazookas.

Uh.

00:08:24 Speaker 1

And and we were told, keep your heads down. Keep your heads down because you know the Germans be running over you or something. And one kid from Indiana, PA.

He had to put his head up and got shot right there.

First casualty.

00:08:41 Speaker 1

That's when I got frightened. Yeah. Then then then. After that, I don't know what happened, but I guess.

After he'd been locked a few tanks off, the Germans retreated.

00:08:53 Speaker 1

A while.

00:08:54 Speaker 1

And they.

00:08:54 Speaker 1

Then we went into silly league alarm and as we moved up, you want can I answer?

Meaning.

00:09:01 Speaker 1

Ask you tell you have the questions there.

00:09:05 Speaker 2

Well, you went.

00:09:06 Speaker 2

We were in Argentine for a gap.

00:09:09 Speaker 1

Oh, that was a bad one.

00:09:12 Speaker 1

Was a bad.

00:09:13 Speaker 1

Where the Germans came through, Germany was cornered. They were.

00:09:18 Speaker 1

Were already cornered at the fillet. Gap was about.

00:09:20 Speaker 1

Mile wide.

00:09:22 Speaker 1

And the British and the Canadians were north and we were from the South trying to close the gap to capture the German 7th Army, you know? But then they they put all their forces into that one mile stretch of the escape.

Of them got away, but most of the 7th Army was captured.

00:09:41 Speaker 1

Because we we closed the gap for a gap, but that was a little town of Argentine was around there.

Took that town.

00:09:47 Speaker 2

That was one of Patton's main.

00:09:51 Speaker 2

Thrusts when it yes.

00:09:53 Speaker 2

Again.

00:09:54 Speaker 1

Whoa. That he was after.

00:09:56 Speaker 2

Yeah.

00:09:56 Speaker 1

See and then he always stole us. Now that you got the Germans on the run, keep him on the run.

We've always.

00:10:02 Speaker 2

Uh.

00:10:03 Speaker 1

We take a.

Old boy. We'll get a break.

But he always had a secondary object.

Second day you call it.

Objective objective, yeah.

00:10:14 Speaker 1

They objected and a third objective in its fourth. We always took one town, didn't thought for a rest.

You want to take another town while the Germans are running? They says. Keep them running.

You need.

00:10:24 Speaker 2

It was patented idea. Patton was doing that.

00:10:27 Speaker 1

Yes, that's what we were doing.

00:10:29 Speaker 2

And you saw him.

00:10:30 Speaker 1

I believe you had said. Yeah. And I caught him.

00:10:34 Speaker 2

We were.

00:10:34 Speaker 1

We took the little town.

00:10:37 Speaker 1

Bechet. But you know how soldiers are.

00:10:39 Speaker 1

Call it ***** that town.

00:10:41 Speaker 1

And we were surrounded by.

00:10:44 Speaker 1

Then they were up in the mountain in the.

00:10:47 Speaker 1

We were in a little valley. We had a retreat that night, but then during the day I had my machine gun set up behind.

The wall.

00:10:57 Speaker 1

But there was a big hole opening and had a good view of the hillside.

In fact, I moved on a few Germans before he even came there with the 50 caliber machine gun, and he came in with the Jeep.

00:11:11 Speaker 1

And yet his shoes were, and he commanded to me at the my machine gun, and I had my machine gun in the back behind the wall.

And he told me soon as he saw me, he said, how do you do an air?

I told him when I just got done doing, you know, and I said if I say any more Germans, I can mow them down again.

They were backing off and he says.

He.

00:11:34 Speaker 1

You you know what you do better if you put your machine gun in the front of that wall.

So I had to move it, then he left.

And I don't how he took a gamble.

Going to the front lines and it sound like that we were surrounded by Germans, you know, and then that night we had a repeat because Germans really come in strong.

Well, we were.

00:12:03 Speaker 1

We had a 25 basis. You know how that is.

00:12:05 Speaker 1

Got to go 25 basis.

The guy walks 25 basis and you walk.

00:12:11 Speaker 1

Out.

00:12:12 Speaker 1

Side and a big shell came between me and the guy in front of Maine.

Will be way when Swoosh and where I could feel the heat that sounded a gun and then down below it exploded.

Just think of us.

00:12:31 Speaker 2

Was that an 80?

00:12:32

8.

00:12:32 Speaker 1

88 for streaming Mimi, this was a larger one.

00:12:36 Speaker 1

Didn't scream.

00:12:37 Speaker 1

88 was they told us when the 88 stopped screaming.

00:12:42 Speaker 1

Do you know it's going to?

00:12:43 Speaker 1

You have to be careful as long as they're screaming in order to run over your head.

Uh.

00:12:48 Speaker 1

But that one, I don't know what kind it was, but it must have big shell because I didn't scream, but it went swoosh between us like that.

In between and the guy in front of me got so scared and worried about it, he committed suicide the next day.

So yeah, because I guess it's frightening him so bad, it must have been closer to him.

Could have even maybe bumped him a little bit. For all I know, you know.

Did you run into much of that since you saw so much action your your unit?

Yeah.

00:13:18 Speaker 2

So much of that shell.

What they call shell shock in World War One and.

Yeah, that he had. Yeah, yeah.

00:13:25 Speaker 1

Yes.

00:13:26 Speaker 1

And then after that.

00:13:29 Speaker 1

Well, we took out a few.

00:13:31 Speaker 1

A whole bunch of.

00:13:33 Speaker 1

And we took probably did mostly mopping up.

00:13:33 Speaker 2 Well, we got. 00:13:36 Speaker 2 Shalom. 00:13:37 Speaker 2 Mourn you're on the morn, cross the Meuse that the gamer see and St. 00:13:39 Speaker 1 Yeah. 00:13:44 Speaker 2 That was. 00:13:45 Speaker 2 Your story is the story of the war. Yeah, bridge, head across the Moselle with two. What happened there? 00:13:50 Speaker 1 That's the one. 00:13:51 Speaker 1 Did you see that on that bottom? That's where our company was. Was that in September? 00:13:56 Speaker 1 Yes, that's what we were captured. 00:13:59 Speaker 2 Uh.

00:14:00 Speaker 1

That's where the pond.

00:14:02 Speaker 1

Bridges were knocked out that one and two, and the Germans were so smart they they treated pretty far away. And so we moved in, you know, close enough in the Oconnor attacked it and.

Well, Roger, come out again.

00:14:15 Speaker 1

I get out of.

00:14:16 Speaker 1

OK. But the company get captured had no company left.

00:14:21 Speaker 1

Except you, me and my squad.

00:14:25 Speaker 1

About 10 of us, that's all.

00:14:26 Speaker 2

That you were able to get.

00:14:27 Speaker 1

Away. And did we run?

00:14:29 Speaker 1

I'm telling you, we run.

00:14:31 Speaker 2

So then you were able to.

00:14:33 Speaker 2

Storm Mountain in Mount Saint John.

00:14:37

No.

00:14:38 Speaker 2

And captured Alba according the enemy the West Bank of the Sail River, which I hadn't heard of.

00:14:47 Speaker 2

But this year?

00:14:47 Speaker 1

Well, we waited quite a few rivers.

00:14:50 Speaker 1

Some rivers that were too swift to the engineers would put a rope across.

00:14:55 Speaker 1

Yes, from the other end to.

00:14:58 Speaker 1

Then we hang on to the rope and cross the rivers.

00:15:02 Speaker 2

That way, not too deep.

00:15:03 Speaker 1

Yeah, yeah. Only up to waist high, but the the current was so strong. In fact, if you left looser the rope, the current would take you away.

This was like the force crossing of the weeds.

00:15:14 Speaker 1

Can hang on to the rope.

00:15:18 Speaker 2

Yeah, you got all this memorized too. Bridgehead and the end.

00:15:23 Speaker 2

Iman. Iman, German.

00:15:23 Speaker 2

Yeah, yeah. Reached or what was the experience?

00:15:29 Speaker 2

Was it?

00:15:29 Speaker 2

Kind of an.

00:15:30 Speaker 2

Was it to reach the marginal line?

00:15:33 Speaker 1

Oh yeah, that's where I German that. Imagine the line was facing Germany. That was the French.

Fortifications, you know, they had there and but the German did use the.

00:15:51 Speaker 1

Those pill boxes, in fact, I went up to one pill box.

00:15:56 Speaker 1

Won't even prepare to see any Germans. They could have shot me, but you know.

00:16:01 Speaker 1

I think they're prepared to give up because soon as I got there, they came out smiling with their hands up in the air and I took them to the PWA camp.

Must have been about 8 of them.

00:16:11 Speaker 1

Yeah.

00:16:13 Speaker 2

Let's see that was.

00:16:16 Speaker 1

November of 44. Yeah. Just before Christmas, yeah.

00:16:22 Speaker 2

And then what happened to the marginal line after that?

00:16:26 Speaker 2

Was supposed.

00:16:26 Speaker 1

To while we knocked it out, we got like you know, we had some tanks coming with the 4th Armored Division.

00:16:34 Speaker 1

Usually we had to go in front of the 4th Armored Division to clear.

00:16:38 Speaker 1

Some areas, because they didn't want to lose the tanks either, you know. And then after everything a little bit of cleared up tanks would come in and they would destroy the pill boxes and stuff that tell you once we got there, the Germans would go. The war was.

Almost.

00:16:54 Speaker 1

Not as furious as it was in France.

00:16:56 Speaker 1 The Germans usually gave up easier. 00:17:00 Speaker 1 You know, you didn't have to fight him. 00:17:02 Speaker 1 Hard. 00:17:03 Speaker 1 In France they fought hard, but the Nigerian to imagine a line that then. 00:17:10 Speaker 1 He was coming into Nancy, France. I think you'll see. 00:17:12 Speaker 2 November of 44 mentioned the arrest period that Nancy was in December. 00:17:20 Speaker 1 That's. 00:17:20 Speaker 1 We were doing. 00:17:21 Speaker 2 And this was after you liberated for Beresville A and fired the first rounds of artillery into Germany. 00:17:25 Speaker 1 Yeah. 00:17:29 Speaker 2 You were the first. 00:17:29 Speaker 1 They. 00:17:30 Speaker 1 You were the first ones there, yes. 00:17:32 Speaker 2 My cousin didn't do that. I'll tell you. 00:17:34 Speaker 1

Yeah.

00:17:35 Speaker 1

Then we.

00:17:36 Speaker 1

We.

00:17:36 Speaker 1

They said we were fought on their front lines for 102 days.

00:17:40 Speaker 2

Uh.

00:17:41 Speaker 1

That's what I mean anyway.

00:17:43 Speaker 1

And they said.

00:17:46 Speaker 1

We're going to stay in that, Nancy.

00:17:48 Speaker 1

For two or three weeks till we get ourselves, you know our equipment get more replacements and get get full strength again. And that's when I battle the ball started.

We were.

00:17:59 Speaker 1

For about a week, a little over a week.

00:18:00 Speaker 2

Ah.

00:18:02 Speaker 1

And four O clock in the morning, Patton says load up.

00:18:06 Speaker 1

Even for Luxembourg, we went to Luxembourg and that's where we were knocked some trees down, because German tanks were coming down the road and they couldn't cross the the trees.

Uh huh. Uh.

00:18:17 Speaker 1

Have some kind of explosive we put on side of the.

00:18:21 Speaker 1

Tree and blew it up.

00:18:22 Speaker 1

And the tree would land.

00:18:23 Speaker 1

On.

00:18:23 Speaker 1

Road. That's what I was doing, yeah.

00:18:25 Speaker 2

Were you fighting German?

00:18:28 Speaker 2

Tiger Facts, or did you even know what takes you were fighting.

00:18:30 Speaker 1

What's that?

00:18:32 Speaker 1

No, I know that.

00:18:33 Speaker 2

Except they were German.

00:18:34 Speaker 1

I know they were just Germans because they thought they gave us a warning. They said be careful. Even if the Germans have some of our Jeeps, they're driving in and and they could be spies. And some of us speak fluent English.

Huh.

00:18:47 Speaker 1

Make sure you know who you talk to. 00:18:50 Speaker 1 We had to be real careful then. 00:18:51 Speaker 2 Did you run into any of? 00:18:52 Speaker 2 You know the movie battle of the Bulge where they talked about changing the road signs. 00:18:55 Speaker 1 Yeah, yeah, they did that too. 00:18:59 Speaker 1 And they took the road that they and they took the signs of the cities off to. 00:19:04 Speaker 1 Know what town you were in. 00:19:05 Speaker 2 Uh. 00:19:06 Speaker 1 And they took the sign Rd. signs off too.
