I could have got out of it because I worked in a defense plant.

They said we can get you out of and I said no better than anybody else. I'm going.

In Cincinnati.

Had lived in Claremont County until got married, and then we moved to Cincinnati and lived there about a year and a half.

Camping and your training is.

Yeah, that was in uh, Tullahoma, TN.

We had 13 weeks basic training there and then I was there a year and we had maneuvers there. And then from there we transferred out to.

Camp Phillips. It's a line of Kansas and we was there for training for about 3 months.

From there, we went to the desert Humira outside of Yuma, AZ and we done some Desi desert training there and from there we went for \*\*\*\*\*, New Jersey, Camp Gilmer, New Jersey and then.

OK. Do you remember anything about your instructors?

Sergeant Davis George.

M Davis was our platoon Sergeant and our we had our first Lieutenant.

Thought of his name just a little while ago, but I can't think of her right now.

Have an awful time thinking a name.

00:04:13 Speaker 2

I had a firstly attended Clark. His name was and they done most of the basic training. Then after I was promoted to the Sergeant, then I got.

OK, after you got out of boot camp, you.

You went to Scotland?

00:04:34 Speaker 2

Yeah.

00:04:35 Speaker 1

Is that where?

Went into first to Clyde in Scotland, then we went on into England.

In England, about 3 weeks and then into France.

Landed at Utah Beach in France.

Could you just is there anything in those?

Is there any experiences you want to talk about?

In each of those places.

In in France you mean?

00:05:03 Speaker 2

Well, the first thing, the first thing we seen was really good for your morale was a big cemetery was crosses as far as you could look.

But our first combat we got into was a place called Argentan.

00:05:23 Speaker 2

And I can remember being out in the middle of an open field and German tanks coming at you.

00:05:31 Speaker 2

I'm telling you, there's no more scary feeling than that to be out.

But that was our first.

00:05:37 Speaker 2

Then we pretty well drove pretty fast across.

00:05:42 Speaker 2

You know, we got into some pretty tough battles, but that was the first one we got into and then we got into another one called Oregon.

For a gap where they had a bunch of Germans surrounded and they captured about 75,000, but about that many got away too.

That was one of our first battles we got into.

00:06:09 Speaker 2

And then we would move from one town to another. I mean, you take 1 town and then maybe there be troops, Germans that have been bypassed maybe 1520 miles over here in another direction. We'd head over that way.

And you know, take take them on and we captured a lot of towns and that.

Like I said, we fought all the.

00:06:33 Speaker 2

We was 102 days consecutive contact with the enemy before we ever got a break.

And I can only remember.

00:06:47 Speaker 2

From the time we started in combat in August until I was moved, we had a a rest period in the first part of December. I think about the 6th December, something like that. I can only remember having 3-1 warm meals.

Everything else was OK and you got the same clothes on.

00:07:09 Speaker 2

I mean, had the same clothes on when I was wounded.

00:07:11 Speaker 2

I had one that landed over.

What was your job?

00:07:18 Speaker 2

Rifle platoon Sergeant.

00:07:21 Speaker 1

OK. And what did this involve exactly?

00:07:25 Speaker 2

Bleeding Platoon, a platoon when it's up to full strength to be 41 men.

00:07:32 Speaker 2

And I would we had a platoon leader part of that time about half the time at one if they got wounded or something, and I had to take over.

Leading, they've had their three squads in a platoon.

00:07:47 Speaker 2

Again, I was platoon Sergeant, of course, and let them in combat.

00:07:55 Speaker 2

And I was one that said.

00:07:58 Speaker 2

I said what we're going to.

00:07:59 Speaker 2

I'm not what you guys are going to do.

00:08:01 Speaker 2

Is what we're going to do.

00:08:02 Speaker 2

Was always up front.

00:08:04 Speaker 2

Not to be bragging, but I was always right up front.

00:08:08 Speaker 1

Were there very many casualties in your unit?

00:08:12 Speaker 2

Yeah, we this one particular place, we took a big. I can show you a picture of it.

00:08:20 Speaker 2

Big Hill, like more like a small.

00:08:25 Speaker 2

I guess it had a castle up on top of it at Panamous on France.

00:08:31 Speaker 2

We took that and.

00:08:33 Speaker 2

Our second platoon, it had a big high wall.

00:08:37 Speaker 2

Well, about three times high this ceiling maybe four times our second platoon.

00:08:42 Speaker 2

Thought they would be safe getting to that wall.

00:08:47 Speaker 2

The Germans was up on the top where this old castle was.

00:08:51 Speaker 2

They dropped hand grenades down, killed 17 at one time.

00:08:57 Speaker 2

That was about the middle of September by like I say, we went in combat in August 1st part of August and by the middle of September.

I was a top Sergeant in the company.

00:09:07 Speaker 2

There was 3.

00:09:09 Speaker 2

It was over higher than me when we went into combat, but by that time I was a top Sergeant in the company from then on.

You tell us about.

00:09:20 Speaker 1

A couple of your more memorable experiences.

Well, like I say on this.

00:09:29 Speaker 2

Hill, where these Germans dropped that.

00:09:32 Speaker 2

Crump. Well, I'll tell you something.

00:09:35 Speaker 2

Thing we was making waiting to cross the Moselle river.

00:09:40 Speaker 2

Was pouring down.

00:09:41 Speaker 2

We're waiting for engineers to get a bridge built.

00:09:44 Speaker 2

We stood in this woods all day long, waiting for them to get a bridge built.

00:09:51 Speaker 2

The Germans had an artillery training school at a place called Mets France, and they knew all that.

00:09:59 Speaker 2

Area around her as soon as the engineers get a bridge built, they blow it up.

00:10:06 Speaker 2

We stood there in this woods all day waiting for get a bridge up, but.

00:10:12 Speaker 2

The river wasn't any bigger than 12 Mile Creek out here, but it was at speed banks and of course tanks and trucks, and that couldn't get across.

So we waited all day.

00:10:26 Speaker 2

And while I'm standing there in this woods, there's a.

00:10:28 Speaker 2

Big Tree right here by me.

00:10:31 Speaker 2

And carved in this tree with a man's name.

00:10:35 Speaker 2

Cleveland, OH, 1918.

00:10:39 Speaker 2

Some guy from Ohio had been in that same spot in World War 1 and I was stand right for that same tree.

00:10:48 Speaker 2

First thought was to cut that feature, see if I could cut that piece of bark out, but didn't have anything but bayonet bit.

00:10:55 Speaker 2

Cut it with and see if I can locate him and mail it to him.

00:10:59 Speaker 2

That would have been real neat, you know.

00:11:02

But.

00:11:03 Speaker 2

I just didn't do.

00:11:04 Speaker 2

Of course, maybe he wasn't around either. Till you know you don't know.

00:11:09 Speaker 2

But this same him, when we finally crossed the Moselle river.

00:11:18 Speaker 2

They didn't get the bridge built till after dark, but when it's dark, getting dark, they gave us orders.

00:11:23 Speaker 2

Get across the river. Best way you can.

00:11:27 Speaker 2

So we just went down to speak bank and walk.

00:11:30 Speaker 2

Walked across it.

00:11:31 Speaker 2

Just.

00:11:33 Speaker 2

Wrong.

00:11:35 Speaker 2

Took the ground on the other side of it.

00:11:40 Speaker 2

And company commander, there was a big hill up to the right and the company commander said.

00:11:47 Speaker 2

Sergeant Gulfman, take your platoon up on the hill and set up a an outpost. And I told him a man. I said. Boy is sure stuck us out here on the limb that while we was up there, they started yelling.

And shelling down in in the valley and all around us too. You know, our children shells coming in and the next morning there was the awfulest battle down there in the valley where the rest of.

Company was.

00:12:13 Speaker 2

Germans let tanks just roll down the hill.

00:12:16 Speaker 2

And they got a bridge up during the night.

00:12:20

And.

00:12:20 Speaker 2

They pushed.

00:12:21 Speaker 2

They could cross that trucks, tanks, not tanks, but artillery and everything, you know.

00:12:29 Speaker 2

And these Germans come right down in there.

00:12:33 Speaker 2

Right on on on them, you know.

00:12:36 Speaker 2

Well, artillery supposed to be behind you on fire over your head, but they push the artillery in there and they said that artillery was far in point. Blanket tanks right about 30 feet in front of them.

00:12:48 Speaker 2

And we was up there.

00:12:49 Speaker 2

We had a ringside seat. I mean, we.

00:12:52 Speaker 2

Was safe. We thought we was in the spot, but we were safer than anybody.

00:12:57 Speaker 2

So we then the next day we attack.

00:13:01 Speaker 2

If they're punished somewhere, I.

00:13:03 Speaker 2

But they dropped those hand grenades and that's where I got my first wound.

00:13:10 Speaker 2

Used to, I had a foxhole outside of a big wall that had a hole blown in the bottom of it and up a little bit higher.

00:13:17 Speaker 2

Had like a courtyard that had these little buildings, you know, like you've seen guards stand in these little building.

00:13:27 Speaker 2

When there wasn't shellness, I would crawl through that foxhole and you could see all over the whole valley, you know?

00:13:35 Speaker 2

And when they would throw some shells in, I'd crawl through that thing and get them a foxhole outside the wall.

00:13:43 Speaker 2

Well, this one time I.

00:13:44 Speaker 2

Well, there I'm going to throw half a dozen shells in here.

00:13:47 Speaker 2

I'm not going to purl through that little holes.

00:13:49 Speaker 2

Just step in this little building.

00:13:53 Speaker 2

And then much more step in until Pam, the whole roof came off.

00:13:58 Speaker 2

She'll hit the rooftop. The whole rope of oven dust. Ryan and I felt something burning in my knee, and that's why I got my first wound. I got a piece of shrapnel in my left knee right there.

00:14:11 Speaker 2

But before we took that hill, the company commander told me, he says, take your platoon out and set up a road block.

00:14:18 Speaker 2

Have to keep keep from coming in and I didn't much more get out there to accommodate your comments at the captain. Want you to come.

00:14:27 Speaker 2

Help take the hill.

00:14:29 Speaker 2

I said if they pull us out of here, I said the Germans gonna move right back in.

00:14:34 Speaker 2

So we had to go, you know, and then they did.

00:14:37 Speaker 2

Moved back in next.

00:14:39 Speaker 2

We were surrounded for four days.

00:14:42 Speaker 2

That's one of the many things I can remember, but I mean.

00:14:48 Speaker 1

Now you is with General Patton.

00:14:51 Speaker 1

You.

00:14:52 Speaker 1

To us a little bit about that.

00:14:52 Speaker 2

3rd Army general.

00:14:54 Speaker 2

3rd Army, our division was.

00:14:57 Speaker 1

Can you tell us some experiences with the patent or?

00:15:02 Speaker 2

Well, like I said, I was never real close to doing, but he believed in once you had him on the run. Don't give him a chance to stop and dig in.

00:15:11 Speaker 2

On going as a matter of fact, we did make one drive so.

00:15:15 Speaker 2

Fast that we ran our land line of supplies and had to stop and wait till they we we got replaced with supplies. We was in foxholes for about 13 days.

00:15:30 Speaker 1

Could you tell us about your supplies?

00:15:32 Speaker 1

You have.

00:15:33 Speaker 1

All the time that you needed or.

00:15:35 Speaker 2

Most of the time, yeah, yeah. Most of the time, yeah.

00:15:39 Speaker 2

Had two different kinds.

00:15:40 Speaker 2

We had plenty of ammunition. I mean, I had a cartridge belt that held 10 clips of eight each, and I looked like one of these Mexican banditos. I used to have two bandoliers of bullets on me.

00:15:55 Speaker 2

Two or three hand grenades hanging on a lot of guys you know lazy didn't want to carry ammunition. But I always cared plenty in case we needed, you know.

00:16:07 Speaker 2

Bandoliers had 10 clips, about 80.

00:16:12 Speaker 2

Will teach.

00:16:16 Speaker 1

Did you tell us enough?

00:16:16 Speaker 2

And then the rations, you know, we had two different kind of rations, K rations and sea rations.

00:16:23 Speaker 2

We usually had plenty.

00:16:27 Speaker 2

Oh, there's been times when you get wouldn't have a tight chance, you know, but get so hungry and disgusted and you don't care if you get killed in the next second. You know, you just get tired and disgusted.

00:16:43 Speaker 1

Could you talk about some of your metals and citations that you were awarded?

00:16:49 Speaker 2

Well, I was worried.

00:16:51 Speaker 2

I was worried.

00:16:53 Speaker 2

Purple Heart 3. Purple hearts.

00:16:55 Speaker 2

I got a wounded in the in my right arm. Just a nick.

00:16:59 Speaker 2

Not bad.

00:17:01 Speaker 2

The worst one? I got a big hole blood through my upper thigh.

00:17:05 Speaker 2

But the doctors, described as a 2 inch hole where it went in the four inch hole. It went out, it blows a bigger hole where it's shrapnel, you know, it's a piece of metal.

00:17:13 Speaker 2

Been not like a bullet. A bullet goes through, makes it pretty clean hole. But that piece of metal just flopped and you know.

00:17:23 Speaker 2

It's instant surgery without an anesthetic.

00:17:29 Speaker 2

And that and.

00:17:32 Speaker 2

Got the Bronze star and when they pinned that on me they told me it.

00:17:35 Speaker 2

Have been a silver star.

00:17:38 Speaker 2

I said well, they should have been a silver star, wouldn't they?

00:17:40 Speaker 2

It a silver.

00:17:41 Speaker 2

But the company commander wrote it up as a bronze \* silver, you know higher.

00:17:52 Speaker 2

And then.

00:17:54 Speaker 2

The Good Conduct medal, they said. I could get the ribbon, but then I got the medal later.

00:18:00 Speaker 2

But when they got the Bronze star, they pinned that on me right out in a field open field.

00:18:08 Speaker 2

Excellent it is.

00:18:09 Speaker 2

Come on, hand it to you.

00:18:14 Speaker 1

OK. You mentioned you got one of the medals from helping to rescue somebody.

00:18:20 Speaker 1

That.

00:18:20 Speaker 2

Oh, you read that there.

00:18:22 Speaker 2

That what you read?

00:18:23 Speaker 1

Could you tell us about that situation?

00:18:26 Speaker 2

I was always a platoon's archent on the 1st platoon when we went overseas.

00:18:32 Speaker 2

I became platoon Sergeant when we was out in Arizona desert.

00:18:38 Speaker 2

I was a pretender Sergeant when we went oversea.

00:18:41 Speaker 2

First platoon, I've been in it for over 2 about two years.

00:18:47 Speaker 2

We took this town in France.

00:18:51 Speaker 2

In five Certs, Sergeant from the third platoon caught a chicken.

00:18:59 Speaker 2

And they was cooking it upstairs in the house, and the Germans put a shell right through the window and killed all five of them.

00:19:08 Speaker 2

So I had a first Lieutenant with me.

00:19:12 Speaker 2

And he.

00:19:14 Speaker 2

Had to go to a company meeting.

00:19:17 Speaker 2

But for the cabin in when he came back, he had a buck Sergeant with him and he told us what happened. And he says this buck sergeant's the only one in the third platoon that's left.

00:19:30 Speaker 2

And he's ready. Can't handle the job. And the captain wants you to take over the third platoon.

00:19:37 Speaker 2

So with that, the Lieutenant had to go back to another meeting within my mansard Grumman.

00:19:43 Speaker 2

Don't see why I can't sound a Lieutenant. Let you stay with us.

00:19:48 Speaker 2

But I had to.

00:19:50 Speaker 2

Do it you know. So I took it over about midnight and we made an attack about daylight the next morning.

00:19:59 Speaker 2

Well, I had to go to a meeting too. Later on about 3:00 in the morning and company commander.

00:20:07 Speaker 2

Sergeant golf. And you take the third platoon and reserve.

00:20:12 Speaker 2

Well, the reserve is about as short from here to the ball field about behind the rest of them. You're still down far.

00:20:20 Speaker 2

You're still under fire, you know.

00:20:23 Speaker 2

So we made an attack, we.

00:20:27 Speaker 2

Took a hill upon out of this town.

00:20:31 Speaker 2

And of course, my platoon was out in front of.

00:20:35 Speaker 2

The first platoon was out in front and I took the settlement and they they brought an 18 year old boy.

00:20:41 Speaker 2

Remember when I went to that?

00:20:43 Speaker 2

They had an 18 year old boy as a replacement.

00:20:46 Speaker 2

And a company commander says Sergeant Gautman.

00:20:49 Speaker 2

Take him with you.

00:20:51 Speaker 2

Next morning, that boy, we got him about midnight. I guess little later than that.

00:20:58 Speaker 2

Next morning, when we made that attack.

00:21:02 Speaker 2

When the guys told me that new boy was killed, he lasted about 8 hours.

00:21:08 Speaker 2

And of course, my first platoon. Like I said, we were supposed to be in reserved for platoon was up in front of me. All the men that I trained with and bled.

00:21:20 Speaker 2

So naturally, I'm walking up down the line checking on them.

00:21:25 Speaker 2

I saw this one in there.

00:21:31 Speaker 2

Face down, you know.

00:21:34 Speaker 2

And I thought, you know, something just don't look.

00:21:36 Speaker 2

His face looked like it was in a hole in the ground.

00:21:40 Speaker 2

I went over and turned him over.

00:21:44 Speaker 2

And his whole face was gone.

00:21:46 Speaker 2

Just blew it off.

00:21:49 Speaker 2

You know, that kind of gets to you. But I couldn't love to get to meet you bad because I'm responsible for, you know, these guys.

00:22:03 Speaker 2

And I seen this other one that was wounded in his his leg and was bleeding real bad.

00:22:10 Speaker 2

So I went over and bandaged him up and got him back where some of the other guys that got in a platoon that I just took over. I didn't even know him.

00:22:19 Speaker 2

Only one I knew was his Sergeant.

00:22:22 Speaker 2

I had no, I said.

00:22:24 Speaker 2 Take him back. 00:22:25 Speaker 2 Get him some medical aid. 00:22:28 Speaker 2 He. 00:22:28 Speaker 2 How we gonna? 00:22:29 Speaker 2 We don't have a stretcher, I said. 00:22:31 Speaker 2 Take a. 00:22:32 Speaker 2 Half we got each one of us had 1/2 of a pup tent. They could put him on the shelter. 00:22:37 Speaker 2 When I be get on each corner I'm taking back. 00:22:42 Speaker 2 And then another one that had been in my platoon, he got hit too. 00:22:47 Speaker 2 Was just a little farther up, so I went. 00:22:49 Speaker 2 He could. 00:22:50 Speaker 2 I went and helped him get back. 00:22:53 Speaker 2 And. 00:22:55 Speaker 2 I heard later that the one the first one died. 00:22:59 Speaker 2

And the second one, he made it OK, but he never did ever come back to be out of it.

00:23:05 Speaker 2

That's how I got the Bronze star.

00:23:09 Speaker 2

Bullets flying all.

00:23:10 Speaker 2

I mean, I'm. I'm walking them down the line checking on the guys.

00:23:15 Speaker 2

Everybody else is down Hunter belly.

00:23:19 Speaker 2

I don't know if something wrong my head I guess.

00:23:23 Speaker 1

You also mentioned you were in the Battle of the Bulge.

00:23:26 Speaker 2

Yeah, I was only in it a couple of days after I got.

00:23:31 Speaker 2

I'll tell you about C rations.

00:23:34 Speaker 2

They came in two different cans, like you'd have corn beef hash.

00:23:40 Speaker 2

Beef Stew or something like that in one of them.

00:23:44 Speaker 2

And the other one had biscuits like hard biscuits and maybe a little piece of.

00:23:51 Speaker 2

Chocolate or something like that, or fruit bar or something and nescafe that.

00:23:59 Speaker 2

All we ever done with that was put little bit of cold water and drank it.

00:24:02 Speaker 2

Know he couldn't never chance to heat it up.

00:24:06 Speaker 2

If you ever make any pot roast, vegetable soup or anything like that, you got any left. You put in a refrigerator and all this grease settles on the top.

00:24:18 Speaker 2

5:00 in the morning, of course, everything is black out and during the war there's no lights anywhere.

00:24:25 Speaker 2

We stayed in a barn, hanging out of a barn.

00:24:29 Speaker 2

Was four guys to my left.

Every time somebody I was, I was up trying to get him to move 4 bullets, you know, try to get somebody to walk right into a machine gun.
