A four man tent in Camp Grant, Illinois, where I took medical basic. And then from there I went to outside, living in a pup tent, two man pup tent. 00:03:41 Speaker 2 In Tennessee on manoeuvres. 00:03:44 Speaker 2

Is from the layout from the.

We went to Camp Phillips, Kansas, in tarpaper shacks.

They had to go outside to go to the bathroom.

Take a shower and wash up and everything.

And then the kitchen was on the opposite end of the row of.

You had to go all up there and go outside and go eat and walk up there and then from there I went in Arizona and lived in four band tents and on the desert.

You know, personal item and then change it under clothes and stuff like.

When we lit in France, we got off the we walked in on a treadly and got one up and held up on top of the hill.

Was Apple orchard old apple orchard? There was nothing left of it.

Was all bombed and so they said. Empty your duffel bag.

Out here and then they took empty. Our full field pack gave us a blanket in the shoulder.

Hats out to half Eric Poncho, one of the two.

And then they took our pack and clothing, took our gas mask and we never saw them again.

Carried them all the way over there all that time. Never used, never saw them again.

What was your trip across the Pacific Ocean? Atlantic on the Queen Mary alike. Was it funny or was it? Was it interesting?

There was nothing on you because it was so fast. As a ship of fault at that time, Queen Mary was.

They went in a zigzag all the way across so that nothing could catch up with them.

But then we had escorts like 2 days out.

In Scotland actually, really. But then we got right off the boat and got on the trains and they pulled all the shades down and then we drove across England to whatever town I don't to this day, I don't know what the name of the town was.

We're supposed to be more or less hid. I guess you know, so the enemy wouldn't know where we were at at the time.

I made a mistake.

Omaha had beef.

00:09:31 Speaker 2

Then we went down here.

Yeah.

00:09:34 Speaker 1

Here to Jolanda on Omaha Beach on D-Day.

No, no, D + 3030 days after D-Day.

00:09:42 Speaker 2

And then there and all the way through France and up into Luxembourg, battle of the bulge and then back then we I was stationed.

Through all through Germany, in down in Austria and after the war was over, we I spent.

Oh, I don't know. Four or five months in Austria.

That was after the war was over.

If I only had one, then little cameras like they got now, it wouldn't matter.

What was your impression when you landed at Omaha Beach? And then we want to go on for hours and hours. But we, you know, want take take us along your journey here. 00:11:42 Speaker 2 OK. OK. This we were called MOP up. 00:11:42 Speaker 1 Take us along your journey. 00:11:48 Speaker 2 I say we it's more of the infantry. I was just in the. 00:11:51 Speaker 2 I was, you know, but the infant hopes the infantry were were the ones that did all the work. 00:11:58 Speaker 2 Know that we were just medics, but I said they would go into town. 00:12:04 Speaker 2 Say they it was a little town like Tomah, say just for instance. 00:12:08 Speaker 2 Well, they wouldn't. 00:12:11 Speaker 2 The US Army would bypass it more or less to go to the next town. 00:12:15 Speaker 2 Well then our unit would go in, they. 00:12:19 Speaker 2 What they called liberal liberated. 00:12:21 Speaker 2 And they'd go in and they'd run. All the Germans. Make sure there was no Germans in their snipers or anything else. 00:12:27 Speaker 2 Then when you got what they call liberated, they would go get the burglar in France. 00:12:33 Speaker 2

Wasn't the burglar my area was whatever the mayor.

00:12:36 Speaker 2

Is and they bring the church bell and everybody would assemble around the church.

00:12:42 Speaker 2

Oh, I'm I'm I'm wrong.

00:12:44 Speaker 2

That was in.

00:12:45 Speaker 2

In France, you didn't do that because you would be.

I mean, they kept their arms, you know, but when we got in Germany, they.

Burger.

00:12:56 Speaker 2

He came out, rang the bell and then they were supposed to turn their weapons in. Whatever kind of weapons they had. And you should have seen some of the nice weapons.

We didn't have.

It was all by foot and except when you go like this, when they walk through the line here and went across, then they went on 6 by sixes, they prayed for.

That's when Patton took off. You heard about.

00:13:47 Speaker 2

Patton took off and went on across.

00:13:49 Speaker 2

Right. And drove and then they ran out of supplies. Patent in the army.

Couldn't keep up supplies of.

00:13:57 Speaker 2

He was going so fast, but he was bypassing a lot of talents and seeing that's what we were doing behind him, mopping or what we call.

Liberated.

It wasn't really liberating France because they were our ally, but we called it liberate.

But when you got in Germany then you could do take, take whatever you wanted.

I mean, it's true.

I mean, you could just loot houses and everything because we were occupying them, and then France. You couldn't do that.

What about you got to the the battle of the bulge?

Tell us about the battle of the ball.

We vote.

00:14:35 Speaker 2 I was stationed at the time in Mets. 00:14:40 Speaker 2 And we're on Raspberry. 00:14:42 Speaker 2 A lot of time we need battle for a month and then you go back for 4-5 days and then go back and. 00:14:51 Speaker 2 Then we got to order in the middle of the night order to get on 6 by sixes that were moving out. 00:14:58 Speaker 2 Well, we had no idea where we were moving out. 00:15:01 Speaker 2 You know, they loaded us up in the back of 6 by sixes. 00:15:04 Speaker 2 No cover on it or nothing. 00:15:07 Speaker 2 And we drove all the way from Mets up to Luxembourg City all night long. 00:15:15 Speaker 1 And time here was in. 00:15:16 Speaker 2 That was in December. 00:15:19 Speaker 2 And I got up there. 00:15:23 Speaker 2 And as soon as I got out of the truck, I just shake, shake and shiver and shake and shake. 00:15:29 Speaker 2 I had chills all that. 00:15:32 Speaker 2 And I went and I had 103 or maybe even higher fever. 00:15:39 Speaker 2

And so they evacuated me.

00:15:42 Speaker 2

Back to a clearing company that is called and I stayed there 2 days.

00:15:49 Speaker 2

And then it subsided, and I went back, and I no sooner I got back in that night, it was right back up just as high as it was.

And so then they sent me.

00:16:01 Speaker 2

They knew I had pneumonia. See, I had.

I had contact with pneumonia, so then he shipped me all the way back down to Mets in a station hospital, which was really neat.

And I saved mine. And a lot of people have seen it. And they said, wow, that's going to be worth money because nobody ever saved that. So. 00:17:14 Speaker 1 So we're at the. 00:17:15 Speaker 1

Of the bones.

Now we're both.

They're gonna go through Korea.

See, I'm getting you guys off to them, OK?

I ended up down to met. 00:17:30 Speaker 1 And you had pneumonia? 00:17:31 Speaker 2 And they had pneumonia and I was. 00:17:33 Speaker 2 Probably they put me right on a cot and made me stay right in the cot. 00:17:38 Speaker 2 With. 00:17:42 Speaker 2 A spear on cup and I was coughing up all that phlegma. 00:17:47 Speaker 2 And then. 00:17:49 Speaker 2 When I got to stay there, probably 2, maybe 3 weeks ago. 00:17:56 Speaker 2 And then they. 00:17:56 Speaker 2 Sent me back to they called Ruffle Depot. 00:18:00 Speaker 2 They were replacement depots where after you went left the hospital after being. 00:18:06 Speaker 2 Moved out of your unit. They put you in a replacement \*\*\*\*\*\* and then from that replacement

\*\*\*\*\*\* they could send you anywhere they wanted to.

Well, I wanted to get back to my own unit.

00:18:19 Speaker 2

So I saw one of our trucks from my unit come there to get supplies and stuff.

And so I hit ask him if I could hit the right button back to my and I went back to my unit on my own so I could be with my one buddies.

But you just jumped on the truck and left.

Next town clearing them up. 00:19:08 Speaker 2 They gave up. 00:19:09 Speaker 2 More or less they. 00:19:11 Speaker 2 I mean, the Germans had more or less given up by then. 00:19:15 Speaker 2 See, that would have been in. 00:19:21 Speaker 2 Ring. 00:19:23 Speaker 2 Of 45. 00:19:25 Speaker 2 Yeah, it's right. In 45 they had more or less, you know there were no fight left in them and all of the men. 00:19:35 Speaker 2 You could pick up a woman pretty easy. 00:19:39 Yeah. 00:19:40 Speaker 2 Because all the members. 00:19:42 Speaker 2

Yeah.

00:19:43 Speaker 2 Want to give us some details? 00:19:46 Speaker 2 No, but all the men were drafted. 00:19:51 Speaker 2 German soldiers he took, they took everything. 00:19:56 Speaker 2 Yeah, they called it fraternization. Oh, yeah. 00:20:02 Speaker 1 It's only fraternization if you get caught. Right, Sir? 00:20:08 Speaker 1 Now I see up on the wall there. Obviously you said you had shrapnel when you picked up a Purple Heart, but you also have a Silver star and a bronze star. 00:20:16 Speaker 1 Bronze Star, of course, is, but it takes, you know, a Silver star is quite a jump up to. 00:20:21 Speaker 2 Yeah, that's in. 00:20:22 Speaker 2 It's a gallantry in action, I think. 00:20:23 Speaker 1 Was that in Korea or was that in? 00:20:25 Speaker 2 That was in Germany in. 00:20:27 Speaker 1 Tell us how you got how? 00:20:28 Speaker 1 Came how you went over there. The water there. 00:20:29 Speaker 2 OK, I.

00:20:30 Speaker 2

We were in this town, Paul and Moussan right here.

00:20:35 Speaker 2

And that's where Patton I was telling you how he rushed all the.

00:20:39 Speaker 2

Across here.

00:20:41 Speaker 2

And then he ran out of.

00:20:43 Speaker 2

So we dug or whatever we call it, digging it.

00:20:48 Speaker 2

We the dug hole with with a bulldozer, so we could for a place to sleep, you know, up in this hill mountain above this valley and then across the Valle in the middle of the valley was a river. And on the other side was another range of hill.

The in between there the Germans on the opposite side of that field in the hills mountains there were mountains there, hills.

They were dug in over there and we were dug in here.

Well, then they I will lose there for a week, maybe 10 days, something like that.

And then they decided to advance.

Well, they thought there was going to advance Americans.

And they they had it over on the German side. They had an outpost in the church people, which was supposedly not supposed to be done by the Geneva Convention, nor supposed to use churches as a, you know, and.

What they did, they had a.

00:21:51 Speaker 2

So any any movement in this field, they had their mortar drilled in on every spot was zeroed in on.

Movement in Bangor but we after a while we got to know from the Pope.

The martyrs made a plot.

No, it's like that where they shoot.

Could just hear that.

There's nothing major out there. 00:23:46 Speaker 2 Pass them up to get them back to the AIDS nation. 00:23:49 Speaker 2 Then the doctor booked them all.

And I thought with my medical background, I might get into medical supply and I kinda like that because in our units that I took care of the medical chest reordering, all the drugs that you had, they had to keep it up current.
