And went out to Indian town gap.

Where we formed the 702nd Tank Battalion.

On the 702nd Tank Battalion were over 30 of us from the Nazareth area.

I went back to our outfit, which was on camp. 00:03:08 Speaker 2 Camp, yeah. 00:03:14 Speaker 2 lt. 00:03:14 Speaker 2 It was in Kansas anyway. 00:03:17 Speaker 2 And join. 00:03:18 Speaker 2 Join the outfit. 00:03:20 Speaker 2 And then I think April, we went overseas. 00:03:26 Speaker 2 We left campsite, New York and then Mauritania, a British ship. 00:03:32 Speaker 2 We. 00:03:33 Speaker 2 We were not. 00:03:34 Speaker 2 We didn't have any guards with any ships with us. 00:03:38 Speaker 2 Because they have a lot more speed than their submarines and stuff. 00:03:43 Speaker 2 And. 00:03:45 Speaker 2 On this ship we got 2 meals a day. 00:03:50 Speaker 2 6000 of US on we slept on a hammock on a promenade.

When we landed in England, we landed Liverpool.

And every state of Liverpool a couple days on a golf course. Intense.

And from then on.



Yeah. 00:05:28 Speaker 3 A straight foot. And that's what happened to. 00:05:33 Speaker 3 Your friend. 00:05:34 Speaker 2 Yeah, I for those sort of skips. 00:05:37 Speaker 2 I was really lucky. 00:05:40 Speaker 2 When they called me in the office, I wanted to go to radio school.



No headlights, just little lights.

00:08:47 Speaker 3 That's all right. 00:08:48 Speaker 4 That's quite a trip, yeah. 00:08:52 Speaker 2 But sometime after the bullets, I think it was. 00:08:56 Speaker 2 We were driving along morning through Germany. 00:09:00 Speaker 2 One of our trucks came the other way. 00:09:03 Speaker 2 Horses off the road, we upset our half track. 00:09:08 Speaker 2 And. 00:09:10 Speaker 2 But we're lucky. Only land on the side. You imagine. I think after I living all the way over. 00:09:14 Alright. 00:09:18 Speaker 3 Now, when you were called up, when you're you, an outfit was called up with, but with Patton to come up to Luxembourg, that was before. That was after the Bulge had started on the 16th. 00:09:28 Speaker 3 Was around Christmas Eve. And where did you stay then Christmas Eve when you got up? 00:09:33 Speaker 3 To Luxembourg. 00:09:35 Speaker 2 Slept on a on a. 00:09:39 Speaker 4 Bowling alley.

00:09:40 Speaker 2 Falling out. 00:09:43 Speaker 2 And the one thing I saw I'll never forget Luxembourg. 00:09:48 Speaker 2 38 shooting on a meter Schmidt. 00:09:53 Speaker 4 In the air, yeah. 00:09:55 Speaker 2 The pilot for the message meant escape. He didn't escape. 00:09:59 Speaker 2 Got out, but they captured him. 00:10:02 Yeah. 00:10:02 Speaker 4 Did he shoot him down? 00:10:03 Speaker 2 Yeah. Oh. 00:10:04 Speaker 4 OK. 00:10:06 Speaker 3 And what then? When after the bowling alley we're we're bouncing Luxembourg. 00:10:11 Speaker 3 You remember parts of the Luxembourg it's version. 00:10:13 Speaker 2 No, I don't wanna bring it. 00:10:16 Speaker 2 But I mean, I was lucky all the way through because the fact that they call in the via radio operator and not.

Be a tank person in the tank, but they're dangerous.

Did you have any weapons on your half track?

Yeah. On our half track, we had a \$50 machine on 30 caliber machine gun. Each of the men we had a 30 Calvert carbine. We had some mines, we had grenades.

We had almost anything you want.

Open Half tracker clock or clock armored.

It was open, but yet though cameos you can put up.

00:11:19 Speaker 3 Where did you sleep then? 00:11:21 Speaker 3 Outside. 00:11:22 Speaker 2 Outside of the tent, or sometimes, oh, someone's on duty all night. 00:11:28 Speaker 2 Either or sometimes sleep in the after act all depending on the weather. 00:11:32 Speaker 1 What was the weather like? 00:11:34 Speaker 2 Well, it was normal. 00:11:36 Speaker 2 Was cold. 00:11:39 Speaker 1 Any frostbite? 00:11:40 Call. 00:11:41 No. 00:11:43 Speaker 1 To remember when the weather cleared. 00:11:48 Speaker 2 Not really. 00:11:50 Speaker 3 Now he got up there around Christmas time. So right at Christmas Eve. 00:11:56 Speaker 3 And. 00:11:59 Speaker 3

You remember and remember when we went back and went to Luxembourg and visited the different spots that you had been in and we went up to the one pass where the Germans actually came through.

Yeah, we we had one thing about our outfit too. Being with the Colonel, with our own cook.

Our communications officer came from Allentown.

Last name was Reese.

I can't remember his first name anyway, but he just died when we were up here.

We moved back.

Lived here in Allentown.

So we talked a lot.

And how many people are actually in the company?


Down around mites, the Rhine around mints.


