Uh. 00:10:06 Speaker 2 Uh. 00:10:10 Speaker 2 Attacks we had a hand set up on a on a hill and we had a house at the edge of town and we built, we built it in the House where we had to work on top of. 00:10:22 Speaker 2 The Hill for home duty. 00:10:28 Speaker 2 Read that, probably. 00:10:33 Speaker 2 Couple of 100 yards here to walk when we walk. Walk through archery. 00:10:39 Speaker 2 To the ground and back. We were in this particular spot for a couple of days. 00:10:47 Speaker 2 And. 00:10:50 Speaker 2 What is the? 00:10:55 Speaker 2 I think of the second squad. 00:11:00 Speaker 2

Machine gun.

That was was with us. And then on the way back.

He stepped down the line and here for two days we've been walking through there.

Told the company in to spread out along this field and we were catching our towing fire and when the Sergeant said to me, he says he caught up there.

That ditch along the road and stay there.

So what about maybe half an hour or 3/4 an hour? They pulled us back away from the authority and this went on for three nights.

They couldn't cross that over because there was so much artillery fire.

And there was the first first battalion went across the river 4th and the 2nd Battalion went across second. The first suffered suffered. Really was a lot of casualties, but they got across and he got a beach head over to cross the river and finally.

And the third of times master cross.

The commander of the rifle company called Back and tell us a ceasefire.

We weren't that close. We weren't that close to the city. We were probably.

How far can a machine gun fire?

You mentioned that machine guns are used in case of a counterattack. Did that ever happen?

Once I was in the battle of they were they were in area little area which was kind of an I-shaped.

Section of the of the woods and the German geranium other section. And after we had crossed the line right where the road went down through there.

Those they were beside me on the edge of the woods. 00:20:58 Speaker 2 I was on to to the left and I was on the left arm and the left had been right in my right. 00:21:07 Speaker 2 When we clean them out. 00:21:09 Speaker 2 And then, of course, we kept attacking, so we just kept moving, moving forward.

I saw Betty get killed while having his small arms. He was telling me he wounded when he got picked off and he was.

German soldier. 00:27:32 Speaker 1 How old was it when you joined them? 00:27:37 Speaker 2 You know the first week when I joined them, we were still in in Luxembourg and it was probably. 00:27:47 Speaker 2 High 20s when it's sort. 00:27:49 Speaker 2 Of snow on the ground. 00:27:54 Speaker 2 No. 00:27:56 Speaker 2 Two weeks later, when we got his sentry line, it was probably in his mid 30s. 00:28:03 Speaker 2 Ring.

Water. Of course. You know the river was flooded. That's why we had such a hard time crossing it.
