That's just where you ended up. 00:07:05 Speaker 1 I wouldn't tell you their advise you. 00:07:09 Speaker 2 I take it this was a troop train though. 00:07:12 Speaker 1 It does. It recruits the lightly in. 00:07:16 Speaker 1

And I mean roughly.

That was. 00:10:34 Speaker 1 And place for special forces. They just sent me out there for a couple of weeks. 00:10:40 Speaker 1 And then. 00:10:42 Speaker 1 So. 00:10:44 Speaker 1 It was nothing but just advanced basic training. 00:10:47 Speaker 2 Kind of things that they drill you on, Bob. 00:10:50 Speaker 1 All the just mainly the well marching of course, and not too much. 00:10:59 Speaker 1 Oh, you you fired to the to the rifle range in the 200 yard line. 00:11:06 Speaker 1 And that was we didn't get too much fire in here. 00:11:12 Speaker 1 And mainly. 00:11:13 Speaker 1

And the the obstacle courses, as they were known, they were played me. A lot of people couldn't get over it, you know.

And so they let him go. And we graduated a little over 100 and 102nd lieutenants. And they were doing that every day. Wow. Every day. Well, they're putting out infantry officers and just.

It was almost equal to a four year college. 00:16:05 Speaker 1 So they just. 00:16:06 Speaker 1 Crammed it down, you had to, you had to know everything and and and. 00:16:12 Speaker 2 What was your your first assignment after that training? 00:16:15 Speaker 1 Well, I had a short stay at Camp Wheeler, Georgia. That's outside of Macon for about a week and then they were just waiting to see what? 00:16:26 Speaker 1 Where they needed officers. So then I went to the 80th at Camp Forrest, Tennessee. 00:16:32 Speaker 1 That's out of Tullahoma. 00:16:35 Speaker 1 And the first day I was there, I was.

2nd and 10.

And we went over for breakfast at the officers mess hall.

And I thought, boy, this is the lie, and that's about the last I saw of any bold, so to speak.

What do you remember most about that trip?

And they had primeval tent set up.

And my biggest.

Job there was keeping the personnel that chased the Englishwoman. They were pretty lonely at that time, you know, because they're boys are all gone to war.

Some people like me and out to vote. 00:37:25 Speaker 1 I was lucky to get certainly work and so. 00:37:30 Speaker 1 And then most of my stay in the hospital when I found out it was going to live. 00:37:35 Speaker 1 Was in with three construction. 00:37:41 Speaker 1 Ohh. 00:37:42 Speaker 1 Tried everything I I developed what they call businesses and I couldn't open my mouth. 00:37:48 Speaker 1

They they crazy muscles.

I don't have any scarves shown here, but inside and it's like a rope and it comes down through there and it.
