Two, as a frontline Lifeline patents 3rd army with the 80th Infantry Division and I'd like to start off interview by asking You, Troy, where were you in Pearl Harbor?

I was living on a farm down in Muskogee County, near Porter, OK, and I didn't know that it happened till I went school that morning.

Of course, we had no lectures, but I found out in school and I was AI was a junior in high school.

Until how old were you?

00:00:55 Speaker 1

You guessed.

I was 16.

00:00:56 Speaker 1

And what were your feeling when you?

00:00:59 Speaker 1

Out who?

00:00:59 Speaker 2

Well, I didn't.

00:01:00 Speaker 2

Of course you have a.

00:01:01 Speaker 2

Let's do get him. You know, that's the first thing I found out.

It's a long process, so those guys in that business, but I found out everything I came home. I told my folks and they didn't actually know what Pearl Harbor was. Neither did I.

We did get an A in the Haitian.

And that's where I.

I was on the farm down there and I.

Ahead and went to high school that year. And then I I turned 17 that summer and next year I became a senior in high school.

And then in June, July, then I became 18.

Had to go register with the draft.

Mm.

So I had to.

I had no car in the.

But I walked from just east of Porter Old Wagoner. OK to register for the.

How far was that?

1242 Days walk is good days well.

00:01:59 Speaker 2

And I was going ahead and stayed on the phone then and till they call me.

Seem like in February of 44 to come take a physical.

00:02:10 Speaker 2

I came to Tulsa past physical and they they call me then in April.

00:02:17 Speaker 2

To report for the army.

00:02:20 Speaker 2

So we wound up over at Fort Sail and I was sworn in to army on April the 29th, 1944.

And we stayed there a couple 3 days and got some shots and some clothes and photos on the bus and they took a load of us to camp more Texas, which is out in free Mineral Wells and four, four hot place.

And with with discussion I didn't know, I'd never been out of Oklahoma except over Fort Smith AR, which is just across the line.

And more.

And some tanks were screwed in there. Something. But you're driving in the bus stop.

A big archway over there says.

Camp Water, Texas irtc infantry Replacement training center.

In English.

00:03:06 Speaker 2

So that's where my where I started with. The army was at Camp Waters, Texas.

And we had referred to have 16 weeks of basic training.

00:03:20 Speaker 2

And course you start out mostly with getting in physical shape.

00:03:25 Speaker 2

And then you start.

00:03:26 Speaker 2

They start teaching you about the rifle and about the grenade.

00:03:31 Speaker 2

So forth so.

00:03:31 Speaker 2

Different weapons you learn to use all these things and learn to shoot, yet become at least.

Qualify on the rifle, which was the whim when they had the M ones at that time, and then at the end of 16 weeks.

Why I was allowed to come by home, which I drew the train into Muskogee, OK?

00:03:55 Speaker 2

And I was going to catch a little.

00:03:58 Speaker 2

Plane a train next morning came out through Porter just to Milk Run you might.

00:04:01 Speaker 2

But that's that's long, about ten 11:00 at night. I had to wait. Next morning, I standing outside the depot over there and my school and his cab driver sitting there and got talking to him. He said.

Do you need to go?

00:04:14 Speaker 2

And I told him, he said, well, you know, that bridge is.

00:04:16 Speaker 2

I said, yeah, I understand, he said. We have to go all the way around to OK, we said.

You got any money? I.

I've got signed on and he's get in.

00:04:25 Speaker 2

So he took me all the way around to Oklahoma, back West, into a place called Tallahassee and South for about 9, he said. This not close enough.

Said you better not go any further because roads getting there and bad so.

I walked from there to home and I stayed at home 10 days.

00:04:42 Speaker 2

Had 10 days in route.

00:04:45 Speaker 2

And the thing they gave you is travel orders. You can ride any plane. I mean any train bus or however you need to travel. Just walk on.

No money.

00:04:56 Speaker 2

So I've come around there from my dad and the boys were picking cotton and off we went there for a few days and I had to catch that little plane and train one in back in Muskogee so I could leave and my dad said to me, said you.

Not any money, he said.

00:05:12 Speaker 2

I won't need any, I said.

Don't smoke.

Seemed like he had \$7.00 in his pocket.

I caught the try at small train into Muskogee, OK and I caught Katie into St. Books.

Louis I caught train.

I wound up in Baltimore, MD, on the.

And from there I took a electric train out to.

00:05:42 Speaker 2 And. 00:05:44 Speaker 2 Stayed there for four days nicely. 00:05:47 Speaker 2 Some. 00:05:48 Speaker 2 Don't change, you change your whole line of clothing and baggage 'cause you're going overseas, there's no doubt about. Then they we were there for a few days and. 00:05:58 Speaker 2 They moved to SEPTA Camp Shanks, New York. 00:06:02 Speaker 2 And while I was there, my brother was in the Air Force. 00:06:05 Speaker 2 Was stationed over New York City in the Air Force. 00:06:08 Speaker 2 I went over and visited him one couple nights and day and and they got I was not to leave 'cause. He was going to ship out. 00:06:16 Speaker 2 When one lead loaded up and got on the ferry went. 00:06:21 Speaker 2 New York. 00:06:23 Speaker 2 Wooded to Queen Mary. 00:06:25 Speaker 2 At least they sent me overseas first class. 00:06:29 Speaker 2 And.

00:06:30 Speaker 2

I went on right on the board what they call D deck, which is just level 4.

00:06:36 Speaker 2

I thought, well, I've been up all night practising.

00:06:40 Speaker 2

Think I'll just take a nap.

00:06:42 Speaker 2

When I woke up, there wasn't nothing inside the seagulls.

00:06:46 Speaker 2

They push that thing away in the dock and went out through the harbor.

00:06:50 Speaker 2

I was that.

00:06:52 Speaker 2

I went sleep and he really let the Queen run across and cook her five days and nights, which is fast for.

00:06:59 Speaker 2

Some of the Religionship took 30 days.

00:07:02 Speaker 2

We sailed in with at that time, the crane could land in New York City, Southampton and Liverpool. Southampton and Liverpool were full, so we sailed up the coast through iron, around iron and Scotland, through Anchorage, out in the river, up around the Glasgow, Scotland.

And we went over.

00:07:22 Speaker 2

We were on the small radio ships from the Queen into the docks.

00:07:28 Speaker 2

Went into docks and walked right into a big building right into a train.

00:07:34 Speaker 2

Which was dark by that time we took off on that train down through Scotland, into Amman.

00:07:41 Speaker 2

And we stopped and wound up.

00:07:42 Speaker 2

Get out and March into.

00:07:44 Speaker 2

Take over some British Army barracks which were quonset up like things.

00:07:50 Speaker 2

Next few days, then we start walking. Always.

00:07:54 Speaker 2

And a few days would ride.

00:07:58 Speaker 2

Roundup in Southampton.

00:08:01 Speaker 2

This is, well, the guy going back there when we sailed out of New York City was October the 12th, 1944.

00:08:11 Speaker 2

And then we landed over in France about.

00:08:19 Speaker 2

At the 17th of October, maybe around the 20th of October, and they moved us off the beach there into.

00:08:27 Speaker 2

It repaired some railroads and things and finally got us up to they called them ripple deposit equals.

And.

00:08:36 Speaker 2

Begin to move us up.

00:08:39 Speaker 2

Bound in some barracks of a German army barracks. And on November the 8th.

00:08:45 Speaker 2

I joined Company K, the 317th Infantry, which is one of the infantry regiments of the 80th Division.

It had three 17th, 18th and 19th infant.

00:08:55 Speaker 1

But these weren't men you trained with.

00:08:57 Speaker 1

You were plugged into this existing regiment, is that correct?

00:09:01 Speaker 1

And replacement.

00:09:02 Speaker 2

Straight to it because they they took us up there, we took a train bus act.

00:09:08 Speaker 2

I mean a truck after God, dark and wound up.

00:09:14 Speaker 2

Got off and walked away and took us into an old bombed out little town like a.

00:09:19 Speaker 2

And when there's some like a barn or something dark, you know, you couldn't see anything. There was no lights.

00:09:26 Speaker 2

Finally, someone heard some guy say that.

00:09:30 Speaker 2

My name's major bars and \*\*\*\*. You're in the 317th Infantry Regiment, the 80th Division.

00:09:36 Speaker 2

And pretty soon, he said, there'll be somebody to call your name after.

So pretty soon some guy called my name and he said come on, go with me.

00:09:44 Speaker 2

Took four of us out and put us in talks. Told us shoulders were to.

Time.

00:09:51 Speaker 1

So are you telling me that they? 00:09:53 Speaker 1 They put you. 00:09:54 Speaker 1 A replacement into this regiment and then right? 00:09:58 Speaker 2 Into a foxhole to a functional. 00:10:00 Speaker 1 OK. 00:10:01 Speaker 2 That's that's how I had primary training done. 00:10:04 Speaker 2 War, Texas. 00:10:05 Speaker 3 Sure. 00:10:05 Speaker 2 But I'm getting to my. 00:10:09 Speaker 2 Real training. 00:10:10 Speaker 1 OK, I'm with you. 00:10:11 Speaker 2 It happened right up on the frontline and I had some good introductions though. John soldiers were damn good instructors. 00:10:18 Speaker 2 That's where I got my advanced training, but right down the voxel. I knew how to work my. 00:10:24 Speaker 2

One I knew some round tactics you know about firing from the belly and firing from the knee and all

that stuff. But what you what we learned up there?

00:10:34 Speaker 2

You learned quick.

00:10:37 Speaker 2

And that's how I lasted when I did.

00:10:39 Speaker 2

We began to take.

00:10:42 Speaker 2

Scrapping for those.

00:10:43 Speaker 2

No, people won't shoot at you.

00:10:45 Speaker 2

Is all new to.

00:10:46 Speaker 2

I'm just a big old kid.

00:10:48 Speaker 2

And soon I'd like to say I'll learn quick.

00:10:51 Speaker 2

ln.

00:10:53 Speaker 2

We crossed the cross, the Mozel River up into northern corner N northern France, right up close to Germany.

00:11:01 Speaker 2

Do you imagine the lines where it were on Saint of old and the town of Metz? And that's where I really got.

00:11:09 Speaker 2

Featured and I nurse it to be kind of stopped because the patent third arm is running out a few running out of goods supplies.

00:11:19 Speaker 2

And we go on patrols and plug in at the old Maginot and in the seafood lines, just patrolling, see what they were. And so they.

00:11:31 Speaker 2

Told us you guys thought out there some trucks out front here in which you fall into some trucks. Well, that time I was just, I think.

00:11:37 Speaker 2

I made Corp.

00:11:40 Speaker 2

We got on these trucks and it came dark and we begin to travel.

00:11:46 Speaker 2

Stop. You know, we're so slow. Trucks you don't stop.

00:11:52 Speaker 2

There you go.

00:11:54 Speaker 2

Chaplain, come behind his Jeep. When the guy said, hey, Partners said, where are we going?

00:11:59 Speaker 2

Said son. I don't.

00:12:00 Speaker 2

I just follow the crowd and he was right, that's all.

00:12:04 Speaker 2

So that's where we got our first.

00:12:08 Speaker 2

Take of the Bulls. But before we got into bulls over round in northern France, there you got into those old bead fields and those old apple orchards. And that's where they had to hang out in the drawing school.

00:12:22 Speaker 2

Eat those apples and beets.

00:12:24 Speaker 2

And we kept taking those things and those little towns. That's where we learned what he's talking about.

00:12:29 Speaker 2

Warfare Sword field rockets.

00:12:32 Speaker 2

And.

00:12:34 Speaker 2

There was something to hear, especially if you were young and new and hadn't heard.

00:12:39 Speaker 2

And witchcraft reunion with him for a few days. And then you imagine the line there. They had. They'd use those old tank trap thing over big concrete bumper like thing.

00:12:49 Speaker 2

Get behind them and boy, they shouldn't stand over little.

00:12:53 Speaker 2

Where you throw head on that. That was one of the best weapons we had hand grenades.

00:12:58 Speaker 2

And we'd take them out of those.

00:13:00 Speaker 2

We scrapped them around Earth for a while around around St. of old, and Mets was a town that was never captured in World War One, but the 3rd Army captured World War 2.

00:13:10 Speaker 2

We didn't see a 4th Army Division, which we were.

00:13:14 Speaker 2

In ground support then.

00:13:15 Speaker 2

And then I'd say then we moved into the.

00:13:20 Speaker 2

Southern tip of Poles and begin to slug north.

00:13:25 Speaker 2

And that's when our summer uniforms got very inadequate.

00:13:30 Speaker 2

Because it turned cold up there, gentleman, it turned cold.

00:13:34 Speaker 2

And finally, they got us up some overshoes.

00:13:39 Speaker 2

Actually, I'm not the guy who's had trench foot, frozen foot and the thing about the infantry is.

00:13:47 Speaker 2

Your homes out there.

00:13:49 Speaker 2

Where you dig the hole and that that's really.

00:13:52 Speaker 2

And they said, well, how did you ever get?

00:13:55 Speaker 2

I said no, but I kept from freezing to death. That's about all we can do.

00:14:01 Speaker 2

And we scrapped him around there on that southern flank till we, of course, you lose an awful lot of men.

00:14:07 Speaker 2

In fact, there's more people lost in the battle for bullets, and there's been lost wins war right now in that one battle. And we slowed it out there with them.

00:14:17 Speaker 2

I don't.

00:14:17 Speaker 2

I just a big old, healthy country boy. I've been raised in down country and I could take that cold weather and I could take that physical.

00:14:25 Speaker 2

Streets that it took day after day.

00:14:29 Speaker 2

Walking through the snow.

00:14:31 Speaker 2

Carrying you everything you own was on your back.

00:14:36 Speaker 2

And you had to take your food along with you, carry your equipment.

00:14:44 Speaker 2

And it took a toll on some of the younger guys and.

00:14:49 Speaker 2

It can't be so that.

00:14:51 Speaker 2

That come and go and come and go and.

00:14:53 Speaker 2

I'm just lucky I didn't get hit except.

00:14:57 Speaker 2

For this Purple Heart.

00:14:58 Speaker 2

I took a tree burst up.

00:15:00 Speaker 2

Those tall trees? I guess they were fur.

00:15:05 Speaker 2

And artillery or mortar fire hit one in the cannon. Really. Flying a piece that taught me right across the eye up here and told me they loose and they sent me back. The aid station stitched it up and then that's where I got to burn hard.

Could you go ahead and show them in the shout box please?

00:15:22 Speaker 1

It says tree verse probably 88mm fire.

00:15:25 Speaker 2

People didn't know was even mortified.

00:15:27 Speaker 1

Got it.

00:15:29

Hello.

00:15:32 Speaker 2

Oh, it's that little getting some wind. 00:15:36 Speaker 1 There you go. 00:15:36 Yeah. 00:15:41 Speaker 1 And so this is basically caught the brow bridge right here and splits you open. 00:15:47 Speaker 2 And they thought he. 00:15:49 Speaker 2 I went back to a little age station like thing and some doctor there and medicine put the stitch in it. 00:15:54 Speaker 2 Take a picture of that. 00:15:57 Speaker 2 They give me a shot of penicillin, I guess. 00:15:59 Speaker 2 They didn't have penicillin pumps, but. 00:16:02 Speaker 3 Now this strap, although it wasn't the one that hit you. 00:16:04 Speaker 2 You know that just wanted it hidden, but you know that stuff. 00:16:07 Speaker 2 When Hip grew up like this mushroom. 00:16:10 Speaker 2 That was coming back and hit me right around here. Of course I had one. 00:16:14 Speaker 2 Tell you all about them clothes. 00:16:16 OK.

00:16:20 Speaker 2 That's that. 00:16:20 Speaker 2 One of the worst things about the down the Bulls over. 00:16:25 Speaker 2 And like I say, as an infantryman, that's your home. 00:16:28 Speaker 1 What you do to to dig a foxhole with the frozen ground? 00:16:31 Speaker 1 You guys do. 00:16:33 Really. So you're. 00:16:35 Speaker 2 We had entrenching tools and you get down under that snow while it go pretty good. 00:16:40 Speaker 2 Went through the crust. 00:16:41 Speaker 2 Yeah, you. 00:16:42 Speaker 2 You had a little show and you could use a shoulder or you. 00:16:44 Speaker 2 Bend it use like. 00:16:47 Speaker 2 And here you dig in. 00:16:50 Speaker 2 That's where we stayed. 00:16:51 Speaker 1 What did you do to stay warm? 00:16:53 Speaker 2

Well, I'm from tell you about that I had on, you know what? GI underwear or they're, they're all wool top drawers and top.

00:17:01 Speaker 2

All long sleeve, but and then I had on Roger OD pants and shirts which are the old olive.

00:17:07 Speaker 2

Their wool.

00:17:08 Speaker 2

Hat on my fatigues.

00:17:10 Speaker 2

In my head of, I had a sweater on and I had to.

00:17:15 Speaker 3

See your jacket.

00:17:17 Speaker 2

Our overcoat and your ankle, that's what it took.

00:17:21 Speaker 2

Now I was going to say you don't get real.

00:17:23 Speaker 2

You keep from freezing to death, and that's what I do. And socks your feet get.

00:17:29 Speaker 2

Had no way to keep your feet dry.

00:17:32 Speaker 2

But I had enough known that the Jeep had come up in Washington law with some cow.

00:17:36 Speaker 2

That if.

00:17:37 Speaker 2

Could get up there. I'd get me so they'd have dry socks on that Jeep.

00:17:40 Speaker 2

Get me to a free pair of them, but in my.

00:17:43 Speaker 2

Knapsack and I kept my feet from getting frostbitten or taking trench foot. Some of the guys didn't. 00:17:50 Hmm. 00:17:50 Speaker 2 They. 00:17:51 Speaker 2 They get them. Get them. 00:17:52 Speaker 2 Or take French food. 00:17:54 Speaker 2 But I managed to weather that in. 00:17:57 Speaker 2 I had made. 00:17:59 Speaker 2 I had made the Buck Sergeant in. 00:18:03 Speaker 2 Now see. In other words, I had a squad out of IT company caving. 00:18:08 Speaker 2 One night theft was dug in up there on the hillside and then cold and rock. 00:18:12 Speaker 2 On the platoon Sergeant was loaded like man, by the way, if some Oklahoma at that time his name was forgotten. His name, Darko, he said. Man, get out of that hole. 00:18:22 Speaker 2 Down. 00:18:23 Speaker 2 Get the company command won't talk. 00:18:24 Speaker 2 You, I thought. 00:18:25 Speaker 2

What have I done now?
00:18:26 Speaker 1
Yeah.

00:18:27 Speaker 2

But he said well.

00:18:31 Speaker 2

Sergeant soldiers that he's going.

00:18:32 Speaker 2

He was older, like guys and he's going home.

00:18:35 Speaker 2

You're going to have to take over the first platoon, I said.

00:18:38 Speaker 2

Goodness, captain, I said.

00:18:41 Speaker 2

You know you're talking too I.

00:18:42 Speaker 2

I'm a 19 year old farmer boy from Oklahoma.

00:18:46 Speaker 2

And I only been up here about 18 about 8 weeks on the front lines, he said.

00:18:50 Speaker 2

Let me tell you mine, he said.

00:18:52 Speaker 2

You're 19, said you're a year older than.

00:18:54 Speaker 2

Them and said you've been up here about 6.

00:18:57 Speaker 2

Weeks longer than most of them.

00:18:59 Speaker 2

And he said.

00:19:00 Speaker 2

This is the case where we have no choice.

00:19:02 Speaker 2

There is nobody.

00:19:05 Speaker 2

And I thought I told him, I said, he said.

00:19:06 Speaker 2

Now you take over the first baton and he says not full strength and everyone of.

00:19:10 Speaker 2

You never full strength.

00:19:13 Speaker 2

So he said, you take it over.

00:19:15 Speaker 2

And he said. Now let me tell you that I can't help you much because he said I've got three other two.

But he said I can give a little bit of advice, said don't let those guys dig in and sleep too long.

Freeze to death, said aroused man there and make them walk.

And that's what I had to.

I had to see that they had K rations. Had to see that they wasn't sick.

I had to rush them out of that hole and all they \*\*\*\* about it.

Hmm. Hmm. Hmm.

They threatened, but they realized then that what it was all about keep from freeing course you ever got down and got warm and comfortable. You free to death.

00:19:43 Speaker 1 Yeah. 00:19:52 Speaker 2 You didn't realize you were freezing, but that was the story of the Battle of bulls was. 00:19:58 Speaker 2 It was the weather and but you know those guys in my platoon here, they were. 00:20:05 Speaker 2 Were all draftees. 00:20:07 Speaker 2 Might. 00:20:07 Speaker 2 I think we had one volunteer younger. 00:20:11 Speaker 2 We're all draftees and. 00:20:13 Speaker 2 They want, but fighting men they want. 00:20:16 Speaker 2 That's what they were, and we need they. 00:20:19 Speaker 2 They were good. 00:20:20 Speaker 2 I have to give it to them. 00:20:22 Speaker 2 Were the platoon. 00:20:23 Speaker 2 Just. 00:20:24 Speaker 2 I just laid them up there to the valley. 00:20:25 Speaker 2

Knew how to do it and would. 00:20:27 Speaker 2 With it. 00:20:28 Speaker 2 Some of I had. I had boys from California, from Texas, from Pennsylvania, from New York. 00:20:34 Speaker 2 Hadn't got a small this united. 00:20:36 Speaker 2 They were all drafted and some of these guys, even when I was a 19 year old. 00:20:42 Speaker 2 Married men they had gotten. 00:20:45 Speaker 2 Deferred for one and drafted. 00:20:47 Mm. 00:20:48 Speaker 2 Sent him up there on the front lines and I did the best I could with that. Captain, visor told me. 00:20:53 Speaker 2 Well, you just have to figure this thing out to. 00:20:56 Speaker 2 Said you've been up here long enough and I thought lots of times. 00:21:00 Speaker 2 Old. 00:21:01 Speaker 2 Lots of times I. 00:21:02 Speaker 2 Did I do the best I could? 00:21:07 Speaker 2 Did I keep these men as warm as I could?
