What?

00:02:29 Speaker 2 Well, it was different. 00:02:33 Speaker 2 It we the first month that we were there. 00:02:40 Speaker 2 We. 00:02:41 Speaker 2 Burned an awful lot. 00:02:44 Speaker 2 About things to go in the army. 00:02:48 Speaker 1 Did you feel like you were low man on the totem pole? 00:02:53 Speaker 2 No, but they tried to make us feel that way. 00:02:56 Speaker 1 You didn't give in. 00:02:57 Speaker 2 No. 00:03:00 Speaker 1 Did you find the studies easy hard. 00:03:05 Speaker 2 Studies were no hard. 00:03:07 Speaker 2 Hard at all. 00:03:10 They. 00:03:10 Speaker 2 Seem to get along very well. 00:03:14 Speaker 2

We graduated 44.

And left for Germany.

So the war had already started before you graduated.

Let me back up a little bit and do you remember where you were at when you heard about Pearl Harbor being bombed?

And tell me, what was your first assignment? 00:05:31 Speaker 2 My first. 00:05:32 Speaker 2 My first assignment was. 00:05:34 Speaker 2 In. 00:05:37 Speaker 2 Well, I ended up in the company attached to the 80th Infantry Division in Germany. 00:05:47 Speaker 2 That gave me quite a bit. 00:05:52 Speaker 1 What was your training? 00:05:53 Speaker 1 Were.

Responsibilities.

Our training was.

The ship was going up and down in your.

Southampton. We got into Southampton and they put us in a room by ourselves. Next morning we found that the all the floors under us are about 5.

Filled with German wrens, which were royal enlisted Navy personnel.

We'll need to say they got us out of that room in a hurry.

Ship.

Did you find that embarrassing?

No, no text later.

Or comical maybe, huh?

I wonder, well, I'm married in Milwaukee, but not.

She passed away sometime back. 00:11:23 Speaker 2 And. 00:11:27 Speaker 1 She was a good military wife, huh? 00:11:29 Speaker 2 Yep. 00:11:30 Speaker 3 How long were you married? 00:11:32 Speaker 2 68 years. 00:11:33 Speaker 1 Oh my goodness. 00:11:36 Speaker 1 It's a long time. That's wonderful. 00:11:38 Speaker 1 Wonderful. 00:11:40 Speaker 1 So you were anxious to get married before you. 00:11:43 Speaker 1 Out was that.

00:11:43 Speaker 1 And what was the reasoning? 00:11:45 Speaker 1 Some guys waited till it came back or they didn't. 00:11:49 Speaker 2 We just got married in Milwaukee. 00:11:53 Speaker 1 So anyway, you were married when you got to Southampton, OK? 00:11:56 Speaker 1 Wanted to clarify that, all right and. 00:11:57 Speaker 2 Mm. 00:12:01 Speaker 1 Where were you sent? 00:12:03 Speaker 1 Were you assigned to? What unit were you assigned to them? 00:12:09 Speaker 2 Replacement officers and they. 00:12:13 Speaker 2 We bring people into the Fourth Harmony Division, which was fighting in the Battle of the Bulge at the time and I was convoy commander.

We had. AI was lucky. I never got shot at.

Did you ever have to fire your rifle or gun?

Mostly we had a pistol.

What kind of pistol?

And I mean he 45 automatic.

So you were in a convoy. You're managing a convoy that would take troops to the front and then bring back. What troops that were being relieved or?

Nobody have an empty convoy coming back and we take troops up to the 4th harm.

We had enough. 00:15:52 Speaker 2 Range liquors to keep us dry, but that's all we have. 00:15:57 OK. 00:16:00 Speaker 2 The. 00:16:02 Speaker 1 Were. 00:16:02 Speaker 1 Were they keeping you well supplied at that time? 00:16:05 Speaker 2 Oh yeah, we were well supplied. 00:16:10 Speaker 2 I wouldn't come out. 00:16:13 Speaker 2 Bunch of replacements up to the 4th Armored and deliver them and then. 00:16:21 Speaker 2 Sign off on saying go back home. 00:16:26 Speaker 2 I was a convoy commander. 00:16:29 Speaker 1 So did you have a chow hall that you could eat out when you got back? 00:16:34 Speaker 1 Or was it attempt messed up?

00:16:36 Speaker 2 It was a camp. 00:16:40 Speaker 1 I imagine. 00:16:41 Speaker 1 It was raining all the time. It must have been pretty dirty and muddy and. 00:16:52 Speaker 1 Did you did your unit repair besides artillery? 00:16:56 Speaker 1 They repair vehicles. 00:16:58 Speaker 2 Oh yeah. 00:16:59 Speaker 1 Was just everything needed to. 00:17:00 Yeah. 00:17:01 Speaker 2 Medium maintenance, which meant you repaired. 00:17:07 Speaker 2 The arms and the vehicles. 00:17:13 Set up how many? 00:17:14 Speaker 1 Guys, did you have under your command? 00:17:18 Speaker 2 Why did Tana? 00:17:20 Speaker 2 Small section. I'm trying to think. 00:17:28 Speaker 2
