Do you remember 43? 00:02:03 Speaker 2 43. 00:02:06 Speaker 1 And how? How long? When were you finally discharged? 00:02:10 Speaker 2 I would discharge those in three years. 00:02:14 Speaker 2 30-4 months I was in. 00:02:17 Speaker 2 MHM. OK, 17 one. It's a lot. 00:02:41 Speaker 1 Easier than. 00:02:41 Speaker 2 Good. 00:02:43 Speaker 1 Then trying to get your. 00:02:44 Speaker 2 We went into Fort Custer first. 00:02:47 Speaker 1 Ohh yeah. 00:02:48 Speaker 2 Michigan. 00:02:50 Speaker 2 And from there we went to Little Rock, AR, Kent Robinson. Yeah, you bolts from up, getting zeroed in. 00:05:37 Speaker 1 And when you when you got over to England, how how long were you there before you? 00:05:43 Speaker 2 About two or three weeks. 00:05:45 Speaker 2 We went in the Scott class, scout landed. 00:05:51 Speaker 2 Then we went to Black, Black Pool England and stayed about 3 weeks. 00:05:58 Speaker 2 And then they took the lacrosse into Southampton, where we took the South boats into France. 00:06:08 Speaker 1 When did you get into France? Where did and where did you go in France? 00:06:14 Speaker 2 Omaha Beach and. 00:06:15 Speaker 1 Were you in Omaha? 00:06:17 Speaker 2 It was after the beach had, really, but we went after we went in. 00:06:23 Speaker 2 They were fighting and staying low when we got in. 00:06:25 Speaker 1 There. So what was that? 00:06:27 Speaker 2

They were fighting in Saint Low when we when we got them.

Ohh yeah.

You say you were in in Europe for 17 months. What did what happened when you were? I mean, what?

Were you wounded at all?

When they closed the flats gap, they trapped in a German bunch of Germans.

The place again. Where was that? Where is that? That was in France. No.

Not too far from Saint Low. I don't think it's going toward Europe.

Good Lord, just with me because I hate border shall coming in I knew was going to be close.

And they dumped and little ***** that had jumped in there.

And it just blasted everything on my back, back, back and everything and just threw.

They took me down the England hospital for four months. Four months.

About four guys I only knew in the whole outfit that Christian had been wounded or killed.

When they closed, when they crossed the Moselle river, I guess they lost them all again.

It was after a gun wanted them.

00:08:39 Speaker 2

And I was in through my four months or three or four months in England hospital and and need to be I didn't have to go back. But I said well, I'll go back to my job.

That we have a job to finish.

I went back the 80th.

00:08:56 Speaker 2

I only knew about four guys in there that I knew before.

And the first thing we went and the bastone and we leave those people from better stone after that.

Did were you there when? When were you there? Were you there when the Germans pushed into Bastone or?

You know when they were pushing in, we went in and relieved them guys.

Yeah, they're the Germans.

So you were there at the Battle of the bulges, were you?

Not really. The Battle of Bouch.

Outlook before like.

Was that?

00:09:41 Speaker 1

Before you say.

00:09:42 Speaker 2

When was the battle of bunks?

Christmas time, you know, December, January 19.

Four. Yeah, I was there in the battle of Bolt.

Relieved those people in bastones because they were trapped.

And then we get pulled back and we went up and going to go across to Siegfried Line. They had a zeroed in.

And sick freed the line for two days. We couldn't move with that fog. Fox holes and we stayed in there. Two men. Fox holes.

For two days till the airplanes come in unbounded.

Ohh geez.

And they bombed the.

00:10:32 Speaker 2

And then he got through and then he went on all the way through the mines, crossed the Rhine and mines on the salt boats.

And when the in cross.

Into Germany.

Went through gene with Leona.

Concentration camp in Gina, we relieved.

Those people were just nothing but skin and bone.

They're both shape. Is that right? They were so happy to see us.

And we went all the way through Germany into Czechoslovakia, right near the border.

And then they cut down South from there, went into neuenburg.

00:11:15 Speaker 2

We spend a week in Neuenburg resting up.

00:11:19 Speaker 2

And playing ball in their big Colosseum. They had big swastik on won him and a big Coliseum there. So we played ball there every day while arresting.

Ohh yeah.

Mm-hmm.

And then we took off from there and went across.

Into limbs crossed their Danube near limbs.

And then he went S from there to the mountains and the mountain pass.

Into I can't remember the little town we went into when the war ended.

You were relieved that the war was ended, were you? Everybody was.

And we've taken prisoners in there for several days. They were coming in from the Russian side. They didn't want to give up to the Russians, so they gave.

So we run out of box cars to put them in and we told them to.

Go home.

Perfect.

In the war in the.

How long after that was well? Was there any plans to?

Deploy you into the Pacific where you.

Well, they were talking about. I wouldn't have to gone. I had enough points that they were talking about putting us in the Pacific. There were division.

But I came home.

00:12:37 Speaker 2

Have to have, well, not too long. We there about four or five months before I got home then.

Then they had the the bomb and that ended everything.

And Japanese give up and then have to go out there.

That went to Lahore and came back from there. The states that.

With the plant McCoy, Wisconsin, where I got discharged.

Where was that camp? McCoy, Wisconsin. Oh, yeah. Well, I get discharged from.

That was married and had a boy in the service.

Oh, is that right? Yeah.

00:13:32 Speaker 1

Are they still drafted you, huh?

00:13:34 Speaker 2

Yeah, little bit draft. And the wife wanted the boy or going on the baby before I left.

When did you get married?

November 20, 1942.

So that was just about the time when you went into service?

And when?

Three months later.

3 three, yeah.

00:14:14 Speaker 2

That they asked me to be the Sergeant three times. But I said no. I'd rather be a like private than a dead Sergeant. Too many. I've seen too many sergeants getting it.

Is that right? Yeah.

00:14:28 Speaker 1

How did they buy from our own soldiers or from Germans or what?

00:14:33 Speaker 2 You know from the Germans. 00:14:34 Hmm. 00:14:35 Speaker 2 You know, we had several battles going on through. 00:14:39 Speaker 2 From the six feet line into lines. 00:14:44 Speaker 2 And after the idea we had some battles that took an air base. 00:14:48 Speaker 2 In Germany. 00:14:50 Speaker 2 They thought we had a whole division going across that field. They only had a platoon. 00:14:55 Speaker 2 They were so scattered. 00:14:58 Speaker 2 He would throw and machine gun bullets at us. There was there was kicking up dirt around us, but we kept going anyway. Nobody got hurt. But one fella got little bit. 00:15:10 Speaker 2 You have poor shots. 00:15:17 Speaker 1 Well, of course at that time there were a lot of. 00:15:20 Speaker 1 People who were a lot younger than you and they probably thought they were indestructible. 00:15:27 Speaker 2 Yeah. 00:15:35 Speaker 2 That then I came back and went back to work for Fords. For 38 years I was there.

00:15:41 Speaker 1 Ohh yeah, what? 00:15:43 Speaker 1 What? What did you do at? 00:15:44 Speaker 2 Ford, I worked in the central lab. 00:15:47 Speaker 2 Physical testing. 00:15:49 Uh-huh. 00:15:51 Speaker 2 Control. 00:15:52 Speaker 1 What kind? 00:15:53 Speaker 2 Quality country. 00:15:54 Speaker 1 Quality control. 00:15:58 Speaker 1 Had you had you had? Were you working at Ford before you went into the service? 00:16:03 Speaker 2 Yes.

They went through their trade school that through night trade school but.

And I got through the trade school. They asked me if I want to work in the lab, in the Armor plate lab. They were making armor plates for tanks. So I went there, and then they that's when they drafted me from there.

So you really didn't, you didn't work as a tool and die maker at all then, huh?

I'll have to go to school.

Uh-huh.

Or if we had to run later for tests taken test samples that to use another shape or and the grinder and the lathe and all that, you have to use them in the left.

Oh, yeah. 00:18:24 Speaker 2 And vascular degeneration in both eyes. 00:18:30 Speaker 1 Didn't help any, didn't help with it. 00:18:38 Speaker 2 Yeah. You see, I'm legally blind. 00:18:44 Speaker 2 So the veterans gave me a partial pension mount. 00:18:49 Speaker 1 Oh, they did. 00:18:53 Speaker 2 And go down to an Arbor Day. That's hospital. 00:18:56 Speaker 1 You go down to the. 00:18:58 Speaker 2 Get some B12 shots and stuff. 00:19:08 Speaker 1 So you go there for shots for B12 shots. 00:19:13 Speaker 1 Does that help any? 00:19:15 Speaker 2 Well, they say my blood's getting better. It was my blood was pretty bad. Come on. 00:19:20 Speaker 2

Getting better.

So it's not that it's only, but the. The only time you were wounded was when you had the shrapnel in your shoulder.
