When we're moving up in trucks. 00:07:14 Speaker 2 We had a. 00:07:15 Speaker 2 Gun open up on us. 00:07:18 Speaker 2 Out there and a guy sitting next to me. 00:07:22 Speaker 2 Hit in. 00:07:23 Speaker 2 Leg. 00:07:23 Speaker 2 And machine gun had to go all the way down that truck and didn't get anybody else but him. 00:07:28 Speaker 2 I sat next to him and he lost his leg later on.

It's the name of the river.

No, we didn't.

Soldiers are civilians soldiers.

And I went across. 00:21:26 Speaker 2 This sounds they sound kind of crazy, but I had. 00:21:29 Speaker 2 Long John's on. 00:21:33 Speaker 2 Odessa, top of that. 00:21:36 Speaker 2 Sweater and sweater and then fatigues. On top of that and a field jacket and an overcoat. 00:21:42 Speaker 2 How cold it was? 00:21:44 Speaker 2
