

Well, we didn't have a lot of money to the family. 00:05:11 Speaker 2 My dad had a job. 00:05:14 And. 00:05:17 Speaker 2 All the. 00:05:19 Speaker 2 He was never unemployed, but the job. 00:05:22 Speaker 2 No job paid very much. 00:05:26 Speaker 2 And people don't believe now when I tell him that. 00:05:31 Speaker 2 I can remember when I was a kid having to take the rent down, rent money down to the landlord. 00:05:40 Speaker 2 The rent money was \$10 a month. 00:05:44 Speaker 2 And if he wanted to raise it a dollar a month, my dad was looking for a place to move. 00:05:53 Speaker 1 How did you hear about the attack on Pearl Harbor? 00:05:58 Speaker 2 I remember hearing it over the radio. 00:06:01 Speaker 2 That Sunday morning. 00:06:06 Speaker 2 You know as well as 16, I guess. 00:06:10 Speaker 1

What was that like to hear?

Well, I I probably as a 16 year old didn't think a lot of it although.

Talk to.

00:08:37 Speaker 1 About your first time taking on enemy fire. 00:08:47 Speaker 2 The first time. 00:08:49 Speaker 2 We were in a little town of. 00:08:54 Speaker 2 Overlooking the our river, which is the boundary between Germany and Luxembourg. 00:09:01 Speaker 2 And we. 00:09:06 Speaker 2 And artillery barrage came in there. 00:09:13 Speaker 2 Both artillery and screaming Mimis. 00:09:20 Speaker 2 And. 00:09:23 Speaker 2 That was the first. 00:09:27 Speaker 2 Well, I wasn't here, but the guy that was right close to me, we were outside a building and. 00:09:38 Speaker 2 You had a little. 00:09:40 Speaker 2 He's the first guy that I knew. 00:09:42 Speaker 2 They got hit. 00:09:45 Speaker 2 And it was minimal.

00:09:49 Speaker 2

A little piece of shrapnel in his neck, which?

He left that day to the aid station and he came back to our platoon the day I left.

Talk to me about some of your experiences engaging with the Germans and the firefights that you're platoon to get into.

You know.

00:10:16 Speaker 2

We didn't really get into any because I think our platform or our company was in reserve.

A lot of the time that I.

00:10:26 Speaker 2

Over there.

00:10:27 Speaker 1

That right?

Yeah.

00:10:31 Speaker 2

So my experience.

I always felt I was very, very lucky.

I did everything I was told to do when I was told to do it.

And the way I was supposed to do it, at least I thought I did.

Weapon the BAR.

You carry that your entire time.

Yes.

Were there any times that you guys had to set up the bar?

Not really.

Like I know from my understanding of the BAR, it's used both as a defensive and an offensive weapon.

So the BAR man's going with The Rifleman.

And if they needed any covering fire, the BAR can do.

Like a machine gun.

Right.

Did you?

00:11:35 Speaker 2

Well, you know, it's not like a machine gun.

Because you could really only fight.

Well, the clip held 20 rounds.

That you could fire those out of there before you get to your finger off the trigger.

But you're only supposed to fire that thing 3 or 4 rounds at a time. 00:12:02 Speaker 2 You fired first. 00:12:03 Speaker 2 You do. The barrel would be gone. 00:12:06 Speaker 2 All the rifling would be out of the barrel. 00:12:10 Speaker 2 Hacker say no. 00:12:13 Speaker 1 Talk to me about. 00:12:15 Speaker 1 Were there many times you you? 00:12:16 Speaker 1 On German artillery. 00:12:20 Speaker 2 No. 00:12:28 Speaker 2 No. 00:12:31 Speaker 2 Like I said, most of the time I'm sure that we were on reserve. 00:12:37 Speaker 2 The time. 00:12:38 Speaker 1 Did you have to go on any patrols? 00:12:40 Speaker 2 I did. 00:12:42 Speaker 1

What do?

00:12:42 Speaker 1

Remember about the patrols that you went on.

00:12:45 Speaker 2

Well, I always thought about it this way.

00:12:49 Speaker 2

It was a night patrol.

00:12:52 Speaker 2

And I understood that most guys.

00:12:56 Speaker 2

Really didn't like.

00:12:57 Speaker 2

It's about as dangerous a thing as we could do.

00:13:02 Speaker 2

We were told that we were not supposed to take any prisoners.

00:13:09 Speaker 2

I don't know how far we had walked.

00:13:13 Speaker 2

When we left, well, first of all.

00:13:18 Speaker 2

I was scared.

00:13:21 Speaker 2

But I wasn't.

00:13:24 Speaker 2

As scared as.

00:13:26 Speaker 2

Because they what they did is.

00:13:31 Speaker 2

Platoon Sergeant came around and said Call My Name with two other guys.

00:13:37 Speaker 2

You're going to night patrol, so I didn't have time to think about it.

00:13:43 Speaker 2

We got out there.

00:13:45 Speaker 2

I have no idea how long or how far we had walked.

00:13:49 Speaker 2

And the first thing I knew we heard.

00:13:54 Speaker 2

Guys talking.

00:13:57 Speaker 2

They were coming right to have us.

00:14:02 Speaker 2

And like I say, we were told we're not gonna take on any prisoners.

00:14:08 Speaker 2

Oh, what does that leave you?

00:14:15 Speaker 2

But you have to kill him.

00:14:19 Speaker 2

And you know, they walked right up onto onto us.

00:14:24 Speaker 2

That we waited until they got right at us.

00:14:30 Speaker 2

And we scared the bud Jabbers out of them.

00:14:33 Speaker 2

We had them on the ground.

00:14:36 Speaker 2

And disarmed, I think before their hearts started beating again.

00:14:42 Speaker 2

Now.

00:14:44 Speaker 2

I don't remember too much about what happened.

00:14:49 Speaker 2

I think there was maybe one of them could speak English.

00:14:55 Speaker 2

We took them back with us and what happened to them? I have no idea.

But I think the reason that we were supposed to not take any prison, we had no way to watch them. No way to keep them.

So what happened to them?

00:15:14 Speaker 2

I have no idea.

00:15:16 Speaker 1

Do you think they were killed?

00:15:17 Speaker 2

I doubt.

00:15:19 Speaker 2

It I didn't hear any shots fired really close by the rest of the night.

00:15:26 Speaker 1

You mentioned you saw the man close to you get hit in the neck with a piece of shrapnel.

00:15:32 Speaker 1

Were there other times that you saw men around you getting hit from small arms or shrapnel?

00:15:37 Speaker 2

The day I got hit, we had lost.

00:15:41 Speaker 2

I don't really remember how many but but.

00:15:45 Speaker 2

I think probably four or five, maybe more, that I I really don't know. 'cause, we're pretty well scattered out.

00:15:54 Speaker 2

And.

00:15:58 Speaker 2

I do know that when we had no first aid, Kai with us.

00:16:06 Speaker 2

And when?

00:16:08 Speaker 2

Came up and got us a an ambulance.

00:16:13 Speaker 2

Uh.

00:16:14 Speaker 2

It filled the.

00:16:17 Speaker 2

Damn.

00:16:20 Speaker 2

I laid across the top of the hood.

00:16:24 Speaker 2

I think there were four or five and could be more.

00:16:30 Speaker 2

Uh.

00:16:34 Speaker 2

Of the ambulance, the vehicle they brought up, there was a weapons carrier.

00:16:40 Speaker 2

Which is his next biggie hero and a Jeep.

00:16:45 Speaker 2

And they loaded everybody in.

00:16:53 Speaker 2

The.

00:16:55 Speaker 2

I had to lay across the I had no idea who they were, but I had to lay across the top of the hood to hang on to whatever I could to ride that. And I don't know how far was Rd. that thing back to the aid station.

But I do remember this that on the way back.

00:17:16 Speaker 2

The 4th Armored Division had tanks lined up bumper to bumper, getting ready to take off.

00:17:24 Speaker 2

For as far as I could go, this was just in the edge of Germany a little ways.

00:17:33 Speaker 1

And.

00:17:35 Speaker 1

Before we get into that incident.

00:17:38 Speaker 1

Describe to me what's it like to have German artillery going off around you.

00:17:44 Speaker 2

Well.

00:17:47 Speaker 2

I always said that.

00:17:51 Speaker 2

The.

00:17:54 Speaker 2

Rifle fire or the small arms.

00:17:59 Speaker 2

As long as you could hear him, they weren't gonna hurt you.

00:18:05 Speaker 2

But the artillery it was like to whom it may concern, because you could, if you were close by, you were gonna get hit.

00:18:16 Speaker 2

And.

00:18:25 Speaker 1

What was the difference between the German artillery and the German mortars?

00:18:33 Speaker 2

Well, I don't really know.

00:18:36 Speaker 1

In the time that you were with the 80th, they breached the Siegfried Line, right?

00:18:42 Speaker 2

No.

00:18:45 Speaker 2

We did that.

00:18:46 Speaker 2

It had been breached, yes, but not where we were.

00:18:51 Speaker 1

So just explain to me you know, but when you join the division on the 22nd of January and until the time that you were wounded on February 22nd, what was the area that you guys covered?

00:19:04 Speaker 1

Were the major battles.

00:19:06 Speaker 2

Little just a very end of the battle of the bulge and then.

00:19:13 Speaker 2

They took us back there for about two or three days.

00:19:20 Speaker 2

At.

00:19:21 Speaker 2

First couple days of February, then they moved us up to close to the German border.

00:19:30 Speaker 2

In preparation to cross and over into.

00:19:35 Speaker 2

Germany across the our river.

00:19:38 Speaker 1

What do you remember about the river crossing?

00:19:41 Speaker 2

Or do I ever?

00:19:44 Speaker 2

I don't think anybody.

00:19:49 Speaker 2

I don't know of anybody in our platoon who had ever made a river crossing like that.

00:20:00 Speaker 2

Couple days before we did that.

00:20:04 Speaker 2

We made a practice crossing of the Sour River.

00:20:11 Speaker 2

And we had absolutely no problems.

00:20:15 Speaker 2

The instructions were that.

00:20:19 Speaker 2

When we got to the cross, the river do not grab hold of any trees or any anything to keep moving that boat right up on the shore, right up on the Bank of the river.

00:20:34 Speaker 2

Well, we tried three days to cross that river.

00:20:41 Speaker 2

Now this is February the 9th.

00:20:44 Speaker 2

Was the last time and I really knew he was going to cross that river regardless of what. But the river was flooded.

00:20:57 Speaker 2

The current was very swift. 00:20:59 Speaker 2 The engineers could not build a bridge across there. 00:21:05 Speaker 2 Due to most Cran of the river and the artillery. 00:21:11 Speaker 2 Umm. 00:21:14 Speaker 2 So we. 00:21:15 Speaker 2 We rode into his assault boats. 00:21:19 Speaker 2 We got over within. 00:21:21 Speaker 2 I know it was within at least the length of the boat. 00:21:26 Speaker 2 We go by some overhanging trees. 00:21:31 Speaker 2 Guy in the upper left hand corner, left front corner of that boat. 00:21:38 Speaker 2 Grabbed ahold of a tree limb. 00:21:42 Speaker 2 The vote goes. 00:21:44 Speaker 2 Dumped us all in the water. 00:21:53 Speaker 2

00:21:56 Speaker 2

I knew that there was at least.

One guy that was in that boat that I knew who could not swim.

00:22:03 Speaker 2 I had when I was in an aircraft artillery. 00:22:11 Speaker 2 I had been an instructor. 00:22:15 Speaker 2 In. 00:22:20 Speaker 2 Or fair Aquatics? 00:22:24 Speaker 2 Survivor swimming. 00:22:28 Speaker 2 And the first thing I knew somebody and I have no idea who was on my back. 00:22:36 Speaker 2 We went down under. 00:22:39 Speaker 2 I got him off of. 00:22:41 Speaker 2 Came back up. 00:22:43 Speaker 2 Know whether or not was the same guy. 00:22:45 Speaker 2 I do not know, but somebody got ahold of me again. 00:22:49 Speaker 2 Went down again. 00:22:51 Speaker 2 I got him off. 00:22:54 Speaker 2 Could not get back up. 00:22:57 Speaker 2

And I apparently was fighting it too much. 00:23:01 Speaker 2 But I. 00:23:02 Speaker 2 I have no idea how far I went down that river underneath the water. 00:23:07 Speaker 2 But I knew I could not hold my breath anymore. 00:23:11 Speaker 2 I finally said to hell with. 00:23:13 Speaker 2 I'm going to drown. 00:23:17 Speaker 2 When I did that, I relaxed and I popped up out of that water like a cork. 00:23:25 Speaker 2 Swam over to the bank. 00:23:28 Speaker 2 Cut out. I sat there for. 00:23:33 Speaker 2 I have no idea how long. 00:23:36 Speaker 2 Till I could get my breath and move out ahead. 00:23:41 Speaker 2 Trouble finding my platoon 'cause. I really didn't know where was that. 00:23:47 Speaker 2 It's still dark. 00:23:51 Speaker 2 But. 00:23:54 Speaker 2 Now there I lost my glasses.

00:23:57 Speaker 2 I lost my helmet. 00:24:02 Speaker 2 Of course, I was pretty well. Water soaked. 00:24:06 Speaker 2 And. 00:24:12 Speaker 2 I told. 00:24:14 Speaker 2 Some girl last winter at that cardiac rehab, \*\*\*\*\* was complaining about being cold, I said. 00:24:22 Speaker 2 Don't know what cold is. 00:24:27 Speaker 1 What happened to the other men? 00:24:30 Speaker 2 Well, there were. 00:24:33 Speaker 2 I do not know whether they were all out of the same boat I was in. 00:24:37 Speaker 2 But that night you were. 00:24:41 Speaker 2 In. 00:24:43 Speaker 2 Ground. They were first recorded as. 00:24:48 Speaker 2 Mia. 00:24:50 Speaker 2 And later on I think. 00:24:53 Speaker 2

Most of that I know of, I think, was found scattered along the river there someplace. 00:25:00 Speaker 1 And which river was this? 00:25:02 Speaker 2 The our river. 00:25:03 Speaker 1 Did you? 00:25:04 Speaker 1 Did you take part in the Sour river crossing? 00:25:07 Speaker 2 I did. 00:25:07 Speaker 2 We used that as a practice cross. 00:25:10 Speaker 1 So during the hour river crossing. 00:25:14 Speaker 1 Did you take on any fire when you were crossing? 00:25:18 Speaker 2 While we were so busy, I don't really know. 00:25:21 Speaker 2 I think I. 00:25:23 Speaker 2 Don't know they had the smoke screen up or not with when we did that, but. 00:25:29 Speaker 1 So you go back. 00:25:30 Speaker 1 You're on the enemy side of the bank right after you. 00:25:35 Speaker 2 Yes.

00:25:36 Speaker 1

So and you're sitting there after that, what do you do?

00:25:41 Speaker 2

Well.

00:25:42 Speaker 2

Like I said.

00:25:45 Speaker 2

We were still in reserve.

00:25:48 Speaker 2

Because most of the fire that was there had to come from artillery.

00:25:52 Speaker 2

It was dark when we were crossing now.

00:25:59 Speaker 2

That whole area, I'm sure that the Germans.

00:26:05 Speaker 2

Artillery had every bit of that river registered.

00:26:11 Speaker 2

Because they had they built.

00:26:14 Speaker 2

That Siegfried line in the late 30s or early 40s.

00:26:19 Speaker 1

Well, I just wanted to know though, like that, that night after your incident in the water and you go and you lost your stuff and you're sitting there soaked. What happens to you and the rest of the men?

00:26:35 Speaker 1

Like, do you go?

00:26:36 Speaker 1

To the American side of the river.

00:26:39 Speaker 2

We. 00:26:45 Speaker 2 Hi. 00:26:48 Speaker 2 Well after daylight I think where I remember now we were. 00:27:04 Speaker 2 We walked up to the next town up the road there, which was amanding and and. 00:27:12 Speaker 2 We. 00:27:14 Speaker 2 Stayed into. 00:27:18 Speaker 2 A bunker? That was. 00:27:21 Speaker 2 A part of the siege free line. 00:27:25 Speaker 2 And we stayed there, I think. 00:27:31 Speaker 2 The morning. 00:27:31 Speaker 2 We must have been there for two or three days. 00:27:35 Speaker 2 But. 00:27:41 Speaker 2 I know I served guard duty. 00:27:45 Speaker 2 A good big share that time. 00:27:47 Speaker 1 Did you have any experiences against German tanks?

No. 00:27:52 Speaker 1 Do you have any experiences with German land mines? 00:28:00 Speaker 2 No, I didn't. 00:28:01 Speaker 2 I know they were around there and I know. 00:28:04 Speaker 2 I but that was a big. 00:28:06 Speaker 2 I was concerned about when I got out of that water. 00:28:11 Speaker 2 And wandering around there in the dark, trying to find it the rest of my platoon. 00:28:19 Speaker 2 Because I. 00:28:21 Speaker 2 There was a lot of them there. 00:28:25 Speaker 1 You eventually found your platoon. 00:28:27 Speaker 2 I did. 00:28:29 Speaker 1 They were all soaked as well. 00:28:33 Speaker 2 No, the the rest, the guys that I found didn't have a problem with the boats. 00:28:40 Speaker 1 How many men were in a boat? 00:28:42 Speaker 2

00:27:51 Speaker 2

I think there were 12. I think there are 10 infantry and two engineers.

00:28:47 Speaker 1

And did you have any experiences with the German Luftwaffe?

00:28:52 Speaker 1

Do they strafe your area?

00:28:54 Speaker 2

Never saw a German airplane.

00:28:55 Speaker 1

And tell me the story about how you were wounded.

00:28:59 Speaker 1

Me through the beginning. What happened?

00:29:04 Speaker 2

Well, we had.

00:29:07 Speaker 2

Uh.

00:29:11 Speaker 2

Moved up to.

00:29:16 Speaker 2

Little town of uh.

00:29:21 Speaker 2

I'm not gonna remember that name.

Anyhow, there.

00:29:27 Speaker 2


A anti tank gun who had knocked out.
