What? 00:11:06 Speaker 1 What did you say para para? 00:11:08 Speaker 2 Paris, France. 00:11:10 Speaker 1 What did you do while you were there? 00:11:14 Speaker 2 Just slipped around. 00:11:15 Speaker 1 For the night. 00:11:20 Speaker 2 Took in the sights. 00:11:25 Speaker 1 Do you recall any particularly humorous or unusual events? 00:11:32 Speaker 2

In Paris.

And we passed the roadside crossroads and there's amp standing there directing traffic.

Outfit my brother Earl was in was up that road, so I hollered. Nasty MP. How far up the road was that outfit? And he said about a half a mile. So when we got to where we was going that night.

I as acting company commander for pass to go back next day and see my brother.

And uh, he gave me an OK, but he gave me a Jeep driver too. He said he was waiting on order. So.

No, we've been in about, I guess, six months when this was taken. I'd made corporal already a company clerk for.

Year and a half, I guess before I got kicked out.

Well, I went on awl with leave, with permission.

I had an appointment to meet my brother Albert at.

In San Diego, CA.

And we moved out on the desert and they.

Set a record didn't wasn't up to par when they had an inspection, so.

I'd already there was no way of me getting a hold of him again. So.

I went to the company commander and got permission to go on pass and I took it back to personnel officer.

Yet OK, I'm all.

And I put my name about halfway down and he just signed the paper and I took off.

I went to Yuma, AZ and then hitchhiked to San Diego.

Come back the next day. Anyway, I checked in and nobody said anything. But about midnight that night they woke me up and told me I had no, no longer clerk. I back with the mortar. So.

So I had owl with live with permission really.

What did you think of officers or fellow soldiers?

Most officers we had were decent people.

We had one that I didn't get along with too well, but that was more.

He tried to give me the load some.

And we had a battle that first went over there and then we took in a bunch of ammunition and their vehicles and.

He wanted to take some of them with him, so he wanted me to help him load her motorcycle onto the truck. He's going.

To take both of them.

And I told him I was busy loading up.

I finally went over and helped him load it though.

And he took me to the company commander and he said, well, I'll let you know what I decide.

So he sent after me and I went over. I thought, well, I'm going to catch it again. But he, he said he's going to forget about what had happened on the loading.

Refuted an officer again.

So about a week after that, then I made staff Sergeant from Corporal.

Did you keep a personal diary?

Yeah.

Your call the day your service ended and where were you?

Where was I was have two. One week out on the ocean, bringing some prisoners over here.

And the war with Germany was over. Why?

00:17:51 Speaker 2

Next morning we headed back towards France, taking those prisoners back. So that was two weeks out on the ocean that.

We we count a week back.

So took us from.

Last of March till middle of June, they get home on a 30 day furlough.

What day did your service end?

00:18:24 Speaker 2 24th. 00:18:27 Speaker 2 24th of October 19, 4445. 00:18:33 Speaker 1 What did you do in the days and weeks after your service ended? 00:18:38 Speaker 2 We all went back to work at Armco. 00:18:41 Speaker 2 AK. 00:18:44 Speaker 1 What kind of job was that? 00:18:47 Speaker 2 It was a rewind they had to run all the coil to get. 00:18:52 Speaker 2 Off gauge and bed. 00:18:55 Speaker 2 Material out of them and. 00:18:59 Speaker 2 That's the job I left from. I went back to it. 00:19:06 Speaker 1 Was your educate I mean? 00:19:08 Speaker 1 Did your work or did you go to work or go back to? 00:19:11 Speaker 1 School. 00:19:13 Speaker 2

I went back to work, but we had little classes. Later to I went to but.

Well, we were given rations to carry with us, but.

So we didn't have to get anything from the kitchen. Why? Usually we had a ration to eat.

I remember one time there was before daylight.

00:23:49 Speaker 2

I went up to.

00:23:50 Speaker 2

Started up, they brought a kitchen, brought food up to us.

00:23:55 Speaker 2

And.

00:23:58 Speaker 2

I'll start up the canteen to get or up to the kitchen, rather to get some coffee and something to eat before I got there. She'll come in and exploded.

You cut.

00:24:10 Speaker 2

That.

00:24:11 Speaker 2

Canteen cup out of my hand.

00:24:14 Speaker 2

But it never bothered me and he just took the canteen.

What kind of stuff did you have?

To carry around with you.

Real rations and and clothes of socks. They try to get socks up to us every day. They didn't really always make it, but.

They've done a pretty good job.

And do what we're told.

You have to carry any certain.

00:24:40 Speaker 1

Type of weapons with you.

We had mortars but.

What are?

Pardon, it's.

00:24:45 Speaker 1

What are more?

00:24:49 Speaker 2

Tube. That's a shell that you drop down in a tube and it sets it off and it goes to the enemy territory.

It's better really than our two. You, Arthur. We had more of a.

Slant. Work the. 00:25:06 Speaker 2 Mortar kind of comes straight down. 00:25:10 Speaker 3 Can you tell them how you slept while on the front? 00:25:16 Speaker 2 Well. 00:25:19 Speaker 2 We supposed to dig foxholes and slit trenches, but you never, never always had time to do that. 00:25:28 Speaker 2 So you've just done what you had to. 00:25:30 Speaker 2 Do. 00:25:31 Speaker 2 Slip out on top. 00:25:33 Speaker 2 That or. 00:25:35 Speaker 3 Can you tell them how you? 00:25:38 Speaker 3 Tried to warm yourselves. 00:25:41 Speaker 2 Well, stomp around or move around it. 00:25:45 Speaker 2 If it wasn't too, uh hard we had dig a foxhole, but. 00:25:50 Speaker 2 And then you get out and around it. If it wasn't shelling. 00:25:56 Speaker 2 But.

00:25:59 Speaker 1

What was like your basic uniform you wore every day.

Well, we got it run every once in a while to put on. They got pretty dirty before.

We got usually got a chance to change.

00:26:15 Speaker 1

What did you have to wear?

But in the winter time we had where all we could, all we could find the word and keep us warm, especially around the bulb. The bulge because there wasn't any place to get out of it there and you couldn't dig foxholes so cold.

As a as a bad part about the bulge is so miserable cold.

People going back with frozen feet.

Uh.

What's the one memory lover that you have from World War 2?
