

After they crossed the pontoon boats and all there was was German over there. OK and I and another guy laid in the quick bit so they wouldn't see us. Now we could see the German walking up low. And that morning they Tiger Tank came down on us. And that's the biggest.

Looks like a three story house.

And it fell on you. No, no, no. And he killed 120 men that morning of our company. 252 men. But this tanker tank when he come up, he come up to go on the road.

Now this is a German tank.

Yeah, OK. And then we had an anti tank quicker 7mm gun and it bounced off like peace.

So then we shot, we're able to, when he got hung up and shot the buggy wheels. And that's what stopped him. And and he couldn't go to war. And then So what they did after that, and they said, well, we don't need an anti tank company anymore.

Yeah, even the Canon company couldn't even penetrate the Tiger tank. The biggest one they made, and there was only a few of them. But there was no way they could stop if he wouldn't have got hung up, he would have cleaned.

Well, they tell Madam to all the officers and people who got captured that morning.

Yeah, OK. 00:22:16 Speaker 1 Injured them. Then this man that was in Lake Station now. 00:22:23 Speaker 1 He was crossed when we did to the Moselle river and he got killed. He got killed, killed with shrapnel, I mean. 00:22:32 In front of me. 00:22:34 You know. 00:22:35 Speaker 2 So there was a tremendous lot of damage done. 00:22:39 Not much over. 00:22:40 Speaker 2 To all of these. 00:22:41 Speaker 1 Yeah, because of the fact that they had us because we couldn't get help.

And they kept blowing that bridge out in pontoon boat and they put it up three times. So you were stuck on the wrong side of the.

Bridge and there's no way to get back.

Get back. We got guys that tried to swim them. Where we down. We weren't grounded.

Really dressed with. No, no, I couldn't swim anywhere.

Dad, tell him how you got off of.

That carrier, when they dropped this in across the English Channel and.

When they dropped the Pope list.

Why I hung on to a real tall guy and I went under the water and if I wouldn't been hanging on the guy, I would have drowned. But hundreds of them drowned anyway, and some of they dropped it in 20-30 foot of water. They want to get out of there.

Those those bolts didn't go up to the shore. They dropped them. They went as close as they thought they could go and drop them.

So they just dropped him deep waters. Yeah, yeah.
