

We were there. 00:07:12 Speaker 3 Months, quite a month and they put us on the Queen Mary. One day was in July. 00:07:18 Speaker 3 A purse in July of this first week of July. 00:07:22 Speaker 3 And four days and 20 hours later, we were in. 00:07:27 Speaker 3 Work Scotland. 00:07:30 Speaker 3

And a few word there. Big old ship sitting in there all by itself.

Habit of real. 00:09:57 Speaker 3 Real mess. But we we done well. 00:10:01 Speaker 3 And we closed the gap. 00:10:02 Speaker 3 And they captured 35,000 Germans. 00:10:07 Speaker 1 3/8. 00:10:09 Speaker 3 Well. 00:10:10 5. 00:10:11 Speaker 3

The 3rd Army, the 80th, was just part of the Soviet 35th Division, the Third Division and the 8th Division. Then in the Canadians came down.

Had all the operating to operating.

So up I went. 00:14:57 Speaker 3 And I got up there. 00:14:59 Speaker 3 I was there. 00:15:01 Speaker 3 During the night, they always take replacement up during the night come Daybreak. 00:15:08 Speaker 3 This Lieutenant says. Where's your weapon? 00:15:12 Speaker 3 He says I'm a medic.

What is your quit license? 00:15:15 Speaker 3 Don't know I. 00:15:16 Speaker 3 I've been just brought up here and dumped here. So he went off and said they took the Medicaid, got injured. 00:15:26 Speaker 3 He. 00:15:27 Speaker 3 Leave his stuff there and I was supposed to pick it up and use it. 00:15:29 Speaker 3 Someone threw it into the ambulance when they hold him away, they threw I am. 00:15:35 Speaker 3 Have a shovel. 00:15:38 Speaker 3 A canteen. 00:15:39 Speaker 3 In a. 00:15:40 Speaker 3 That's all I had. 00:15:42 Speaker 1 No medical equipment, nothing. 00:15:43 Speaker 3 Nothing. 00:15:45 Speaker 3 So my first episode as a combat medic didn't last long. 00:15:52 Speaker 3

When I was there a couple hours and 1, Lieutenant says. What are we going to do with you? I said.

I'm a truck driver. 00:16:02 Speaker 3 He. 00:16:03 Speaker 3 We're going to send you back. 00:16:04 Speaker 3 So they sent me back. 00:16:06 Speaker 3 About a week later. 00:16:10 Speaker 3 We got another tap on the shoulder and I went down and they said you're going back up. 00:16:18 Speaker 3 And with Art Peters, Hollis Hill and I, Hollis Hill with a full blooded Sioux Indian from North Dakota and Hart Piers was a clubhouse custodian for the Saint. 00:16:29 Speaker 3 Cardinals baseball team. 00:16:32 Speaker 3 And none of us actually know of has had any training whatsoever. 00:16:38 Speaker 3 All, all three of us were Dumber than dumb as far as treating anybody. 00:16:46 Speaker 3 Well, I got signed to the heavy weapons company. 00:16:52 Speaker 3

That was mortars and machine guns, and we were more or less a little bit behind the infantry, the

rival companies. And So what Peters did, they sent him off.

Anyway, it was a neck wound now.

Make wounds that are head.

Do I do morphine or don't do morphine and I said how much paining in there, young fella?

He would mumbling her a little bit and he was spitting some blood and.

Well, apparently he's not in too much pain, so we didn't do any more pain because I didn't know how to give him a shot anyhow.

But you were a great ambulance driver and I I want to tell the folks out there a little story and then you're going to fill in the blanks early in the in the war, before the bulge, about 300 American soldiers crossed the Moselle river.

And when they got across, they were attacked by the Germans. And I don't know how many died, but 22 were wounded and Bob got a call. You got to get your ambulance over there and pick up these men.

I was in old Section 8 that night looking for a place to sleep is all I was doing but.

And well then for 8 or 10 seconds I can see.

Too bad I think I got over there and maybe 1520 minutes.

The other side was these 2216 group litter cases and chicks were walking on it and I knew the guy. The medic will shine. He was a Pittsburgh boy also and it was the only medic over there and he was trying to take care of these poor.

I learned what board litter cases and I put a walking wound up problem with me and we went.

Unfortunately, when I was dead but we didn't know that at a time, but I got 22 guys back from.

Request a mosel.

But the second and third trip you failed to tell them that you were under heavy fire.

Yeah, there was.

00:24:34 Speaker 3

They were dropping some, I guess not. Being an infantryman, I wasn't sure what they were.

The Germans had a gun called an 88, which was a super super gun.

The best gun in the world.

00:24:50 Speaker 3

And they knew how to use it, and they could shoot the.

Tree burst. In other words, shell that would go up in the air and come down on you and they were firing a couple of those, but they weren't sure. Every time they put a player up it would, it would go out and they didn't.

Didn't know exactly what we were doing.

But they had dropped some shells around us and.
