Once you got overseas into Europe where all were you at? 00:03:30 Speaker 1 I don't know if you need all this stuff, but see when when we went over. 00:03:35 Speaker 1 Uh. 00:03:37 Speaker 1 There, there was. The torpedoes were quite a. 00:03:42 Speaker 1 Problem crossing the Atlantic so they. 00:03:46 Speaker 1 II loaded on the ship at. 00:03:50 Speaker 1 At Pier 13 in Staten Island. 00:03:55 Speaker 1

And we we sell to. 00:03:58 Speaker 1 Glasgow, Scotland. 00:04:01 Speaker 1 And then then I got to. 00:04:04 Speaker 1 Get on a train at Glasgow and went to. 00:04:09 Speaker 1 Across Scotland and England. 00:04:12 Speaker 1 And to Southampton, England. 00:04:16 Speaker 1 And that's. 00:04:19 Speaker 1 And we we laid around there until it got real foggy at night and then we crossed. 00:04:25 Speaker 1 The English Channel into France. 00:04:30 Speaker 1 And then I was. 00:04:33 Speaker 1 Went to a replacement depot there for a few days to leave. 00:04:37 Speaker 1 Get ISOD in what's carrying on, and then then they they sent me to Luxembourg, Germany. And that's where the battle of the bulge was. But. But it was the the main fighting was over with. When I got there. 00:04:56 Speaker 1 So I was. 00:04:58 Speaker 1

I was in Luxembourg.

And then from after that was over away, we moved back.


The Yeah, the Prince of the.

What was it like guarding like the salt mines?

Sit there and they had these big doors. See the salt mines? The atmosphere is is perfect for storing paintings and stuff. And that's the that's the reason.

That's what I was in. 00:23:31 Speaker 1 And. 00:23:35 Speaker 1 See us over here in. 00:23:41 Speaker 1 If I had let some burger on here. 00:23:46 Speaker 1 Right. 00:23:48 Speaker 1 But anyway. 00:23:51 Speaker 1 It's right in this. 00:23:53 Speaker 1 When they're Luxembourg. 00:23:55 Speaker 1 And that's where I was. 00:23:58 Speaker 1 And then we we came out of there and these there was here for my 319. 00:24:06 Speaker 1 And we we came out of there. 00:24:09 Speaker 1 To catch in London and we were there for a little bit and then we went over here to Worms Germany.

And this is the Ryan River.

And so we come out of there and then we crossed it, Armstead and went. 00:24:44 Speaker 1 Then we went on up through here. 00:24:47 Speaker 1 And it's castle Levinson. 00:24:49 Speaker 1 That's where they said that bad. 00:24:53 Speaker 1 They bought the bloodiest battle they had and then we lasted 3 days. So then anyway, we came out of there. 00:25:02 Speaker 1 And started down this way. 00:25:05 Speaker 1 And we got over here to. 00:25:09 Speaker 1 Limbaugh. 00:25:11 Speaker 1

And and that was, that's where I said.

Now it was. 00:26:51 Speaker 1 And. 00:26:53 Speaker 1 So I stayed, stayed with the First Division. 00:26:58 Speaker 1 Until I came home and I came home, I think it's July 2nd. When I came home. 00:27:04 Speaker 3 OK. 00:27:07 Speaker 3 So what was it like at the Nuremberg Trials? Did you guard prisoners, or did you? 00:27:13 Speaker 1 Ohh yeah. 00:27:15 Speaker 1 Yeah, they. 00:27:20 Speaker 1 I wish that. 00:27:22 Speaker 1 Picture was that was more thorough I had marked on there who I've guarded and what day I did. Yeah, we guarded.

And then then we had to pull guard at all the.

The judges from the different countries there was but England and France and all them had they had their judges and we had to pull guard for for all of them.

Now this this is the one that wrote trumpet Theresa Newman.

See they they were a little short of men. I think we might have had that printed in here, but see if we were guarding.

Day and night. And then if it got, if they got real short of men, we had go 2 hours on two hours off and you would hardly get back to your bed before you had to go back.

That's three. 19th Infantry went home and I joined the 1st Division with friends and squad, Czechoslovakia and.

Guard at the.

00:30:08 Speaker 1

Nuremberg trials in Nuremberg. They're not much else going on in Nurnberg because she was old. Nurnberg was a walled city, and it had all been all bone pieces. I had a lot of pictures of where that was.

Then here tell us what the.

They had Nurnberg, and here's a guy that I guarded in the in the courtroom with, yes.

At all Hitler's. 00:30:55 Speaker 1 Deputy. 00:31:01 Speaker 1 And see this this guy. 00:31:04 Speaker 1 Yes. 00:31:06 Speaker 1 It looks like he kind of got a bad deal, he. 00:31:10 Speaker 1 He flew over to Scotland in an attempt to negotiate peace with the United Kingdom. 00:31:18 Speaker 1 But instead when. 00:31:22 Speaker 1 When they German. 00:31:25 Speaker 1 Flew into there where they took him prisoner and. 00:31:28 Speaker 1 And he was put in that. 00:31:31 Speaker 1 He died there in 1987. 00:31:35 Speaker 3 OK. 00:31:37 Speaker 1 And then there was. 00:31:39 Speaker 1 There's also guarded the judges quarters. The judges for British, American and Russian. 00:31:47 Speaker 1

And when it went on duty, you get a pass and go sit in the audience. And had these earphones as down your back.

So when he came in, why his commanding officer said, if you if you boys were neighbor boys at home, I'm going to give him three day pass.

They doubled the value of the mark.

After our payroll was sent in, so we actually got paid twice. We paid double the one month.
