We run an obstacle course and and I was passing them all up and I looked up to go over that wall, stepped on a big rock and sprained my ankle, and that was into me. I run my head in that thing. I was doing pretty good. I didn't. I don't take off so fast, but.

Well after basic training they moved us. They can't Phillips Kansas. I didn't know it till after the war was over. We were supposed to went to Africa. I think it was a fight in the Pacific someplace.

What did you do in at in Kansas?

Well, we had that desert maneuvers in the desert.

I'm not sure, not too long. They need this in Europe, so they changed the rules and sent.

And when we went to Europe, we, the Germans, weren't supposed to know, we was there. Say we went as a ghost division. That's why they never mentioned it or seen much right up in the paper about us.

Losing men we had close to 18,000 casualties and.

The 9th is one M and and the Fourth Armored Division said they'd rather be with us because we can move faster than any of the rest and.

You were with the 80th, you said 80th Infantry Division. Tell me about your trip from the states over to Europe. What do you remember about that?

Landed at Scotland and the yacht ready to go across. But when we went went from New Jersey over we went on the Green Queen Mary. The second biggest ship. We didn't have much to eat. I think 1 prune and some bad coffee to see the the British furnished the food.

How I come to be turned in for the Bronze Star and whenever they get it, we change company commanders. One got killed in in two or three of them and they changed the fast and and I never didn't know their names in combat. You very seldom ever see the company commander unless he calls you and that wanted.

Wanted something done. He always called me and he said you're the only one I ever see a work. And when they come around and said you're always busy doing something.

Less than 1/2 a second. I've been dead. If it went off when they intended it to and it killed everybody around there, they said. But that steep Haller fell in save me. They said the angels or something must have been looking out for.

And while I was up there, I probably saved that pilot and the other pilots life that the Germans was in that he said to look up all the time. And I look looked down and up. I heard that noise up there above my head is coming.

They combat in the front line and the. 00:13:06 Speaker 3 It wasn't too bad when the then but. 00:13:10 Speaker 3 A lot of them didn't like to eat K rations and stuff all time. 00:13:14 Yeah, yeah. 00:13:16 Speaker 1 Did you have enough like boots and clothes? Was that sufficient? 00:13:24 Speaker 3

Yeah, I think so. Why wouldn't you be?

Yeah, yeah. 00:13:28 Speaker 3 Our masks are. 00:13:31 Speaker 3 Not based on the supplies on hit. Get that stuff. No one else could get it. He probably stole it some. 00:13:40 Speaker 3 Ohh, he was the character. 00:13:43 Speaker 1 And you said there were a lot of casualties. 00:13:45 Speaker 3 Ohh yeah. 00:13:47 Speaker 1 Did you lose friends? 00:13:48 Speaker 3 Ohh yeah. 00:13:49 Speaker 1 Yeah. 00:13:50 Speaker 3 It's Christmas Day and the bowls that was in the in the bowls. 00:13:56 Speaker 3 Three of my buddies got killed. An airplane came down and killed them guys and bombed us. I could have tucked and and got him with my rifle, but I know what I thought. Then I wouldn't think about it being the German plane. So he come back to circle and I knew he dropped his bomb, so I took him one and this. 00:14:16 Speaker 3 Tempted to that he he took off and I never did see him anymore. 00:14:21 Speaker 3 In.

Some of the towns that we took, the bigger ones was Nurnberg and Castle and Hereford and through there and and close to I think it was close to Nuremberg.

Which there was a short sell this shell sound different, outgoing and ingoing. I can hear the German shells coming this way over my head. And the Americans are going that way.

And I wrote him a letter and he took his computer and he got my phone number. Talked to me for about two hours and I wondered what happened to him.

They're about 40 to 50 deers in a big circle. That's the way they lay down and they're just thick over. I don't see other farmers could raise anything. So II shot in there and big Buck. I probably hit some of them. No doubt. They're hard to kill. 00:21:18 Speaker 3 So. 00:21:19 Speaker 3 We wanted some fresh meat. You. 00:21:21 Speaker 3 Know. 00:21:22 Speaker 3 And.

We had a real good butcher in the outfit, he butcher, and he done that before he went into service. That was one of my best buddies and I don't know what ever happened to him. I wrote him for years and he disappeared. The guys in his hometown, so they don't know whatever happened.

He might have went back to this lobby. That's where his folks.

The next time two young deers boy this the King's good to eat and you know it's this. Had a buck had two little horns so I took good aim and put it right through that deer's heart. It went clear through and out. It's hard and you couldn't tell that thing had been hit.

That dough and that buck, both of them, they stand under head, just like guys that tack on two boxers. All of them are kicking at my head and I couldn't shoot them or only had 6 shells.

I think and I was just the duck, and I wore out too, a ducking the whole time and I couldn't hit very good. But I tore that.

Shooting point blank, they call out it toward the dose hippo just floored it slide. And you know that though, despite me on one leg, like nothing happened so.

They that buck finally got weak after a while and I'd run out of shells, I was going to have to take my rifle and hit him. So I happen to think I had a little Russian pistol in my pocket and I fixed it so it would shoot made the hammer Tucker fall and fixed it and had one little 22.

Short and boy, I took good aim, took him 20 and down and went and they left me alone. Boy, I thought I'd have it.
