Melvin, could you state for the recording your birthplace and the date you were born?

Which branch of the service and in what war did you serve?

I served in the army as an armored inventory officer in World War 2.

And were you drafted or did you enlist? How did you get into the service?

I was at the University of Wisconsin and became a participant in the Reserve Officers Training Car program. Our OTC, and this was in the fall of 19.

Served all through the until we were until the ROTC unit was called up for active duty. We were remade it with the University of Wisconsin, then went to Camp Walters, Texas.

And went through basic infantry training there and then sent back to the University of Wisconsin, where we remained because the infantry school Fort Benning was.

Called to active duty at Fort Benning, we were active duty all along. Act. That's correct that.

2nd and there's a class of. I don't know how many there was other officer cannabis from not only the University of Wisconsin, but from the University of Illinois.

And was kept on or ordered to stay on at Fort Benning as a tactical officer.

00:02:52 Speaker 2 However, before that. 00:02:56 Speaker 2 After being commissioned, we were all given leave and I. 00:03:01 Speaker 2 Went back to Charlottesville, VA, where I married my wife, Mary Schuyler. 00:03:08 Speaker 2 Who was living in in Charlottesville with her family at that time? 00:03:13 Speaker 2 Then. 00:03:14 Speaker 2 Went to Fort Benning with Mary and as a tactical officer there remained. 00:03:20 Speaker 2 And as a tactical officer. 00:03:24 Speaker 2 Until after by Stone. 00:03:27 Speaker 2 When suddenly because of the casualties that passed on. 00:03:32 Speaker 2 All of us who were fresh second lieutenants were called. 00:03:36 Speaker 2 2. 00:03:39 Speaker 2 Ordered 2 or to Europe and I entered up with the. 00:03:45 Speaker 2 With the 4th Armored Division, 53rd Armored Infantry. 00:03:52 Speaker 2 Commanded at that time, if I'm not mistaken. 00:03:55 Speaker 2

By.

Colonel. Well, I see.

00:04:03 Speaker 2

The 53rd Armored Infantry was commanded by a Colonel, Jakes.

00:04:07 Speaker 2

However, we usually fought in Europe as a part of a combat team made-up of.

Harbored tanks and infantry together with artillery and our commander on occasion was then Colonel Abrams, who later became a four-star general and the commander of our troops in Vietnam, as if I'm not mistaken.

My first real combat experience in Germany.

00:04:46 Speaker 2

After being assigned to the third tomb company C.

00:04:53 Speaker 2

53rd armored imagery.

00:04:56 Speaker 2

We were on basically confronting the Germans in Belgium.

00:05:02 Speaker 2

With the Germans on one side of the Sour River, and we Americans on the other side and.

00:05:09 Speaker 2

We it was stationary. This was midwinter, and it was stationary combat. You'd have Germans sending patrols across the sour river trying to determine.

What our forces were and what strength we had and so forth, and we would do the same.

00:05:28 Speaker 2

However, suddenly one day our office was ordered out of there from that that stationary position.

To attack.

00:05:40 Speaker 2

We later learned I went, was ordered back to join my company commander and Battalion commander, and later learned that we were going to attack a town called Boxford in Belgium.

And I was told I was going to. My platoon was going to lead the.

Track.

And.

We took off with, well, I can remember telling my my platoon sergeants, squad leaders. I told them, for instance, there was a Sergeant Pico, I said, Pico, you'll be on one side of the.

This high the road as we go in and when we were at when we're fired upon, I want everybody to spread out into the open fields that we're told that that there should be open fields there and spread out.

Don't remain together because we want to minimize our casualties.

Any event?

00:06:43 Speaker 2

As we moved along the highway before we started, I told the the Sergeant Pico I said Pico. You'll be on one side and and I don't remember who the other squad leader was. You'll be on the other side and I saw all these.

Troops of mine. Now this is the first time I'd ever lived these men into real combat. I mean, we're face to face, hand to hand combat. Like I saw all of these enlisted men. Look at me. And these are all sergeants just to say this guy's yellow. And I said no pico.

Pico and I will be on one side of the road and here I will be in the lead and on the other side will be so and so.

And we moved along that fashion as we moved along, we moved through. I think it was the 80th infantry straight infantry outfit. And these GI's on each side of the road kept telling us, my man and I, as we passed along, all you you're going to run into trouble there. We've been trying for three days and three nights.

To take the town of Boxford.

And.

Naturally, there was a rather frightening experience for everybody, but you will either succeed in overcoming your fears and go on and and most of the men, I'm glad to say, did.

We continued on until suddenly we heard.

Those of us who were right up front heard voices off to the right in the field. Now they were.

Talking among themselves very loudly in German, so we knew it was the enemy.

They didn't know we were there, fortunately, but.

00:08:35 Speaker 2

I told.

00:08:36 Speaker 2

Pico to go back. He and I had moved forward and.

00:08:44 Speaker 2

I told him to go back and.

00:08:47 Speaker 2

Wait for me to return and I would tell him talk when we decided when? After I've scouted out this situation.

What we should do? Well, any event now people will move back. And I was there by myself and.

All of a sudden.

A machine gun opened up.

00:09:09 Speaker 2

They still were guessing what was going on, but they'd decided that they'd heard something, apparently. Maybe one of our.

Jeeps or half tracks, and this was armored imagery and.

00:09:23 Speaker 2

We.

00:09:24 Speaker 2

Usually traveled in either Jeep or half track or frequently would get on top of the tanks and ride the tanks into combat and then attack.

Wondering about that? And you said you moved.

00:09:37 Speaker 2

Up I was wondering.

00:09:38

Whether you were marching up or, but you didn't.

00:09:40 Speaker 2

Well, our, our, our half tracks were all way behind us.

00:09:46 Speaker 2

But there there's someone must have cranked up.

00:09:51 Speaker 2

But any event I went back and gave orders to my men that were.

00:09:57 Speaker 2

This is the.

00:09:58 Speaker 2

Situation we don't know, but the town of Boxford obviously is not very far up.

00:10:04 Speaker 2

And I said, I want all of you to spread out with your told my squad. You spread your squads out on the right and left side and we will move forward all spread out. I said I don't want anybody concentrated. We're going to get caught in our Tillery fire.

Any event?

00:10:24 Speaker 2

We before we took off, I talked with the artillery forward observer.

00:10:31 Speaker 2

And told them what we were going to do and I told him. You hear my Tommy gun. Open up. I want you to.

00:10:38 Speaker 2

To drop our till reef on the town of Boxford.

00:10:43 Speaker 2

I said keeping my men are out there in that field and so they don't have rounds come in too short.

00:10:51 Speaker 2

Well.

00:10:53 Speaker 2

I might fire my fire when I we got near the town of Boxford and these Germans.

00:11:00 Speaker 2

And that machine gun nest out there. If I fired on them and we, the artillery started coming in and I thought I just had fears that my men were all going to be killed because the artillery came in so close to.

Any event, we then all move forward and our men were not. None of my men were hit by that artillery. We were, everything was still intact, and we moved in on that town. There was very little resistance that there were two tiger tanks, Big Tiger tanks in the town.

Still, and our artillery knocked them out.

00:11:41 Speaker 2

And we took the town without any serious problem at all. Well, any event.

It was rather interesting of a very experienced combat officer in combat with us.

Who had seen a lot of combat before, or a man named Lieutenant Grundy as I remember him very clearly.

Grundy later was killed. He was killed when? Well, that's another story. But in any event.

He had been very much involved with me in this thing and he put me in for a bronze star. That's the first first time I'd really loved my troops in combat. And lo and behold, I was given the brown star for valor and.

Well, I I must have missed some some other parts of this, but any event we captured the town and.

00:12:43 Speaker 2

The 80th Infantry then moved up and took care to occupy the town.

00:12:51 Speaker 2

From there, we.

00:12:54 Speaker 2

Eventually raced to the Rhine.

00:12:58 Speaker 2

This is armored entry with the tanks and half tracks.

00:13:04 Speaker 2

And we were 80 miles in depth.

00:13:07 Speaker 2

With Germans on either side of US.

00:13:11 Speaker 2

When we hit the Rhine.

00:13:13 Speaker 2 And. 00:13:18 Speaker 2 I think you stop your machine a moment. 00:13:23 Speaker 2 We then raced to the Rhine and we were our objective was to take a bridge across the Rhine River. 00:13:34 Speaker 2 And this. 00:13:36 Speaker 2 This bridge was blown up in front of us. 00:13:41 Speaker 2 We then moved along the Rhine River South as I remember. 00:13:47 Speaker 2 And another bridge was blowing up. 00:13:51 Speaker 2 Before we could capture it. 00:13:54 Speaker 2 We finally crossed the Rhine River on pontoon boats. 00:14:00 Speaker 2 The engineers have built these pontoon boats and we crossed the Rhine on those boats. 00:14:11 It's good. 00:14:12 Speaker 1 How many men would have been on these boats army? 00:14:14 Speaker 2 What was our I don't. 00:14:16 Yeah. When army is in, that's incredible. 00:14:24 Speaker 2

Then.

00:14:27 Speaker 2

Hold it a bit.

00:14:27

OK.

00:14:30 Speaker 2

The next action we saw, we were running in an open field.

00:14:38 Speaker 2

We'd crossed the Rhine and suddenly a light tank pulled up.

00:14:45 Speaker 2

Beside me and this tank was was occupied by Colonel Abrams.

00:14:56 Speaker 2

And he said, Lieutenant, I was then a Lieutenant. You see that bridge up there? I hadn't seen that bridge, but he serves there. It's up there. I want you to take it.

And this was a a bridge at.

00:15:13 Speaker 2

On one side of the water, and I don't remember what the water was that that we were that the bridge was over over.

00:15:25 Speaker 2

On one side of it was a town called Gross Sahim, and the other side of the town was Klein Anaheim.

00:15:33 Speaker 2

And.

00:15:35 Speaker 2

We raced to the town.

00:15:39 Speaker 2

And.

00:15:42 Speaker 2

I I went forward leaving my platoon.

00:15:51 Speaker 2

Back until they had a chance to scout out what was ahead of us, we.

00:15:59 Speaker 2

A man named Pegla, Sergeant Peglow and I went forward.

00:16:05 Speaker 2

By that time, Pegla would become my platoon Sergeant. My original platoon Sergeant man named Carnes.

00:16:13 Speaker 2

Had been wounded.

00:16:15 Speaker 2

And replaced by Peggle.

00:16:18 Speaker 2

The two of us went forward and suddenly we heard.

00:16:25 Speaker 2

Voices again.

00:16:27 Speaker 2

And.

00:16:31 Speaker 2

Next thing we heard, a railroad.

00:16:34 Speaker 2

Train came chugging up.

00:16:37 Speaker 2

Alongside.

00:16:43 Speaker 2

I'm getting ahead of myself here. I got my platoon up there to this town of Gross Ahim. And after we crossed the the this.

00:16:59 Speaker 2

Bridge.

00:17:00 Speaker 2

And.

00:17:02 Speaker 2

We were in these houses.

00:17:06 Speaker 2

We've taken this this little town. Go. Solheim or Klein Ohio. I don't remember which was which, but any event we crossed the water. We're occupying these houses. When?

00:17:20 Speaker 2

Suddenly a railroad train came pulling up beside us.

00:17:26 Speaker 2

And.

00:17:28 Speaker 2

Next thing you know here is what turned out to be a battalion of officer candidates German officer candidates.

00:17:38 Speaker 2

We were just a platoon and this German commanding officer lined up his troops. He had no idea that we were were there.

00:17:52 Speaker 2

And he marched these troops right down the street toward us.

00:17:59

Oh.

00:18:00 Speaker 2

By that time I I figured out what was happening. I had Pegler put half of my petun on one side of the street.

00:18:07 Speaker 2

And.

00:18:07 Speaker 2

The other half was on the other side.

00:18:09 Speaker 2

Of the street.

00:18:10 Speaker 2

With me and I told Pedro, if you hear my Tommy gun go off.

00:18:15 Speaker 2

Shoot them up because it was obvious these these Germans were being marched to the street as a as a whole whole officer candidates and they were coming right toward us.

00:18:31 Speaker 2

And any event.

00:18:34 Speaker 2

Peggle took his half of the platoon on his side of the street, and I took kept the other half on my side and the Germans came right at us and I opened up with my Tommy gun and they spread out and.

They were far outnumbered us.

00:18:51 Speaker 2

And they surrounded us, and before they surrounded us some, some of us got back, and most of us got back to the where the company was. And the battalion was a part of it. The battalion was now across the bridge too.

And.

00:19:14 Speaker 2

When I got back, I told the the company commander and battalion, but by that time, battalion had caught up with our our outfit and I told him what was going on.

And.

Go.

00:19:32 Speaker 2

My returning or interrupting for a moment and saying that my runner by that time when I joined the this 53rd or company C 53rd Armored Dimitry I was a platoon leader and I my runner. I inherited this platoon.

That's in a sense.

00:19:50 Speaker 2

In fact, all of the officers in that company, with the exception of one, had been killed.

00:19:56 Speaker 2

Are wounded and.

00:19:59 Speaker 2

I, along with the all of the other officers, with the exception of this one officer.

00:20:07 Speaker 2

Whose name escapes me as of the month. As of the moment.

00:20:12 Speaker 2

We're all replacements. This whole whole platoon is a rather company. It was made-up of replacements like myself. My runner, however, was this experienced?

Nice.

00:20:27 Speaker 2

Man from Lepanto, AR.

00:20:31 Speaker 2

His name was Hendrix, Red Hendrix.

00:20:35 Speaker 2

I didn't know it at the time, but Hendricks had been in Bastone and for his action at Bastone, and this is all written up in in books.

00:20:46 Speaker 2

His action had bestowed resulted in Hendrix being awarded the Congressional Medal of Honor.

00:20:54 Speaker 2

And it was eventually awarded to him at the time when I, when I joined the Outfit and met Hendrix, I had no idea. He had no idea that he'd been put in for the Congressional Medal of Honor.

00:21:08 Speaker 2 But any event?

Hendrix was from Lepanto, AR.

00:21:13 Speaker 2

Saying he's one of the most intelligent people I'd ever known, he had only a 3rd or 4th grade education and extremely smart.

And eventually I made him the head of my mortar squad, though he'd he'd only had three years of formal education. He could do so much, and so did this thing so well.

Any event returning to where we where we crossed this bridge at gross all time incline all time we're in this.

00:21:47 Speaker 2

Uh.

00:21:52 Speaker 2

Had my platoon guarding outposts in the town.

00:21:58 Speaker 2

And when this railroad train had come up.

00:22:02 Speaker 2

And next thing I we knew.

00:22:05 Speaker 2

His battalion of officer candidates had attacked or March to us toward us, and we had dispersed them with our Tommy guns and rifles, and we were surrounded by it by Germans, and we managed to.

00:22:23 Speaker 2

Some of us, most of us, managed to work our way back through lumber yards and places wherever we could go without, and most of us got through without being captured.

00:22:36 Speaker 2

Well, I finally got back to where the company's headquarters was.

00:22:42 Speaker 2

Is this on?

00:22:45 Speaker 2

And told them what the situation told my company commander and by that time, I think the battalion had somebody for for one of the officers. Maybe it was a matter.

Named.

00:22:57 Speaker 2

Major Crosby, Major Crosby was the second command of the 53rd Armored Dimitry Battalion.

00:23:06 Speaker 2

A man named Jakes, Colonel Jakes. JA Qu ES was the commander of the 53rd Armored Infantry.

00:23:16 Speaker 2

Battalion.

00:23:19 Speaker 2

And my company commander was man named.

00:23:24 Speaker 2

Captain Williams, I don't know whether he was with us still still at that time or not.

00:23:31 Speaker 2

But any event I got back to to where the battalion had set up its headquarters and the company, the battalion.

00:23:42 Speaker 2

Commander, who must have been Jakes at that time, told him what was happening and I was then told ordered after we'd.

00:23:52 Speaker 2

This is ordered to outpost the town. That's how my men happen to be in these houses, which, when the officer candidates came marching along and surrounded us, having them worked to disperse the the Germans and they dispersed us and having gotten back to the battalion headquarters.

I told him what I thought the situation was, and I and by that time I knew that the Germans had were in these houses all along the road.

00:24:23 Speaker 2

Toward the river again, and I told the.

00:24:28 Speaker 2

Battalion commander, give me a light tank.

00:24:32 Speaker 2

And let me take that correct. The fire of that light tank and we'll clean out those hoses. Well, we begin with this light tank began to move along the streets to clear out these Germans and these houses when suddenly.

00:24:53 Speaker 2

I saw or heard a voice holler.

00:24:57 Speaker 2

Americans don't shoot, have an American, and he helped. There's a man waving a white handkerchief. Well, it turned out to be my Sergeant Pigloo. He had been captured.

00:25:11 Speaker 2

Any event pegla wig rescued Pegula and and then continued on with the light tank and firing into these houses and and managed to take the town and and move on.

00:25:26 Speaker 2

Well.

00:25:34 Speaker 2

After taking gross and flying all high, which was very near Frankfurt, Germany, we bypassed Frankfurt, Germany and were.

00:25:44 Speaker 2

Ordered our outfit was ordered toward Berlin.

00:25:48 Speaker 2

And we had.

00:25:53 Speaker 2

Gotten to the outskirts of Berlin.

00:26:00 Speaker 2

When we ran into.

00:26:04 Speaker 2

Into German fire.

00:26:09 Speaker 2

Well, we raced toward Berlin and got to a a city called Glocal.

00:26:15 Speaker 2

And.

00:26:18 Speaker 2

At glaucoma, we had.

00:26:23 Speaker 2

We were, we gotten to Glaucon, which is between the city of of Dresden and Chemnitz.

00:26:32 Speaker 2

And.

00:26:34 Speaker 2

We.

00:26:40 Speaker 2

Ran into real resistance there.

00:26:44 Speaker 2

And this was about 10:00 in the morning when we ran into this resistance. We were riding our.

00:26:50 Speaker 2

Our.

00:26:53 Speaker 2

Half tracks and all got onto tanks. As soon as there was reason to think that.

00:27:01 Speaker 2

We could capture this town and we were on these tanks when suddenly we were all fired upon and.

00:27:08 Speaker 2

We're we jumped off the tanks and ran behind the tanks as best we could.

00:27:18 Speaker 2

And eventually went into the town at 10:00 in the morning. We arrived in the outskirts of the town and then fought in the town city street fighting.

00:27:32 Speaker 2

All through the day until 4:00 in the afternoon.

00:27:37 Speaker 2

When we came out the other end of the town.

00:27:41 Speaker 2

And we're in the suburbs. When Germans were racing trying to escape from us.

00:27:49 Speaker 2

Behind us, straight infantry had come come behind us and we're cleaning up the houses in that town. When we were in the outskirts of the town.

And.

00:27:59

Umm.

00:28:01 Speaker 2

I can remember firing my tongues. I I traded in a a little carbine that had been given to me as a standard issue.

00:28:10 Speaker 2

I traded it in. Fortunately, even by even, even before I saw any real combat. It's an interesting.

00:28:20 Speaker 2

In itself, because I've got something more to say about this.

00:28:23 Speaker 2

I saw strapped to the side of this.

00:28:28 Speaker 2

American truck hauling gasoline up to the front line is that Thompson submachine gun.

00:28:35 Speaker 2

Now I had a carbine mission to me that had an unjustifiable wind site.

00:28:43 Speaker 2

I didn't hadn't seen anybody else who had one of these. How I got this, I don't know.

00:28:49 Speaker 2

But it had an adjustable wind sight and it was something of a treasure. Is having a unique carving like this and I showed it to the driver of this. I guess it was called a red ball express.

Yes. And he looked at this thing and I said now, would you like to have that? He said. Yeah, that's interesting. I've never seen one like that. I said you've got something I'd like to have. And I said, I'll give you my carbine for that Thompson submachine gun. I had no idea that I would be doing as much street fighting as.

As as was with my.

00:29:23 Speaker 2

Yes.

00:29:26 Speaker 2

Any event with returning? I guess where we were at this point, we've gone through the town, fought in the town from 4 from 10:00 in the morning till 4:00 and we were in the.

Suburbs.

00:29:40 Speaker 2

When we spotted these Germans in in a wooded area.

00:29:44 Speaker 2

Quite a large number of them.

00:29:46 Speaker 2

And I ordered my men to fire on them, and I fired my Tommy gun. When?

00:29:53 Speaker 2

Suddenly.

00:29:55 Speaker 2

A bullet came along.

00:29:58 Speaker 2

And just missed me.

00:30:01 Speaker 2

And it went into my Tommy gun and and.

00:30:05

Oh.

00:30:07 Speaker 2

I it the impact of the German bullet?

00:30:10 Speaker 2

Shattered the casing of my Tommy gun.

00:30:14 Speaker 2

The bullet itself must have splattered and parts of it went into my mouth and my face was just peppered with shrapnel.

A a a cigarette case that I'd carried in my this pocket of my uniform.

00:30:33 Speaker 2

Just had a big dent in.

00:30:34 Speaker 2

lt.

00:30:35 Speaker 2

Very near to where my heart would have been, I guess, but not any event. I threw the Tommy gun up.

00:30:37

Ohh.

00:30:43 Speaker 2

And rent hollering, medic, thinking I was mortally wounded because my face was just peppered. And as I say, I had this strap will come into my mouth.

00:30:52 Speaker 2

And Howard, medic, medic and ran back, looking for a medic.

00:30:58 Speaker 2
