I was doing and since.

00:21:30 Speaker 1 Since my parents, my dad had died and my mother was very ill, I asked not to be evacuated. 00:21:41 Speaker 1 And I would. 00:21:42 Speaker 1 I would heal and without incident. 00:21:48 Speaker 2 So the reason you didn't want to be evacuated was so that they wouldn't send a telegram. 00:21:53 Speaker 1 What they do, they send a telegram room immediately. If you wounded him so. 00:22:00 Speaker 2 Could you tell us where were? 00:22:01 Speaker 2 Hit with the shrapnel, Sir. 00:22:04 Speaker 1 My arms. 00:22:06 Speaker 1 Hands. 00:22:09 Speaker 3 How? 00:22:12 Speaker 1 I'll explain what happened. 00:22:16 Speaker 1 Yes, I.

When you came home from the war, you know, decades later, did any of the shrapnel find its way?

Who? You know, they would get tropical wounds and it would be embedded. And they'll be sitting down, you know, 50 years after the war, pick up their skin.

We weren't. 00:24:06 Speaker 1 One side they went out the other side. 00:24:10 Speaker 1 But then just. 00:24:12 Speaker 1 At the end of the war, I ended up. 00:24:16 Speaker 1 Having to leave, I think. 00:24:17 Speaker 1 I think that was enough. 00:24:18 Speaker 1 I'm not sure it was. 00:24:23 Speaker 1 We went in there, there was, there were no Jews, just these poor people that were laid in cots and. 00:24:35 Speaker 1 Some were alive, some were trying to save the ones that were very, very thin and sectarian. 00:24:45 Speaker 1 Genetics were feeding them my shoes and things like that, but. 00:24:51 Speaker 1 They didn't have. 00:24:52 Speaker 1 It was not very good. 00:24:54 Speaker 1 They were right through. 00:24:58 Speaker 1

One one thing I did see that.

Is that you can see that they would that the prisoners that were.


