So back, all right. 00:10:37 Speaker 1 All right. 00:10:40 Speaker 2 You served in World War 2, right? 00:10:41 Speaker 2 Correct. And where exactly did you go? 00:10:42 Speaker 1 Yes. 00:10:45 Speaker 2 Area like overseas. 00:10:47 Speaker 2 Where what area was that? 00:10:48 Speaker 1

OK, I went to Germany.

And I went overseas.

I went over as a replacement. I had taken my basic training at Fort Bragg and then I went to officers training school at Fort Sill, Oklahoma became a second Lieutenant.

The average span of an infantryman was in combat was about 60 days.

Either killed wounded in action, trench foot, whatever.

Terrible living conditions in World War 2? We did not have trench warfare. Oh, none. 00:15:15 Speaker 2 Oh no.

Practically.

What we had were foxholes.

00:15:21 Speaker 1

One and two men. Foxholes.

00:15:24 Speaker 1

And we moved a lot.

00:15:27 Speaker 1

You either in the 3rd Army.

00:15:31 Speaker 1

General Patton.

00:15:33 Speaker 1

Believed in attack, attack, attack, attack. As a result, he saved thousands of lives by that military philosophy.

Because he would attack with these armored divisions, his tanks and we infantry would ride on the tanks till we hit resistance.

Off the tank then would go off and leave us.

00:16:02 Speaker 1

They would get behind the enemy.

And then the infantry would have to mop up the pockets.

That was left.

And by doing that, General Patton saved a lot of lives rather than this slugging out.

Attack a little bit and then retreat and attack.

He didn't believe in.

He believed in taking off with his armor.

Are there many casualties in your unit?

Yes, a on the state side, a company.

I will speak now and with the infantry that I experience, even though I wasn't field artillery.

In the stateside a company.

Comprised of about 200 men.

00:16:58 Speaker 1

And.

During combat.

It wasn't very long until we D be down to 180 men and a lot of times a company would be maybe 121 thirty men.

Because they were always experiencing casualties.

In the Baker company that I was assigned to.

Out of the 200 men that went through their training.

00:17:36 Speaker 1

Here in the United States.

Only five of them ever went the whole distance with the Baker company to the end of the war only 5.

And were you one of those five?

No.

00:17:53 Speaker 1

I'm Speaking of of the original 200.

That shipped overseas became engaged in combat.

All that original 200 only 5 ended up and that was typical in infantry divisions.

The very few.

Infantrymen not speaking at headquarters.

Or ordnance or.

I'm Speaking of the combat infantryman.

Uh. He just couldn't expect to survive the full length of the engagement.

Very our casualty rate in the infantry regiments was 180% from the time we entered combat in Normandy until we ended up.

Uh.

Battle fatigue.

Being killed or wounded by friendly fire? That happens.

Yes, and, but generally speaking, we'd go out and move out and attack the inventory would around 4:00 to 50 clock in the morning when it was dark, we jump off.





Only five of the original 200 that shipped overseas became engaged in combat.
